## Sunday - September 25, 1966

9:15 - 9:45 Touro Synagogue. Rabbi Lewis to speak.

Those staying at the Viking, should walk down Touro Street to the Synagogue, approximately 2 blocks. Those staying elsewhere, via private automobiles to Touro Synagogue Parking Lot on School Street, just off Touro Street. Touro Synagogue located 3 blocks west of Viking Hotel.

THOSE GOING TO TOURO SYNAGOGUE MUST BE PROMPT. Rabbi Lewis is making a special exception to open the Synagogue at this time, and as they have Sunday School at 10:00 a.m., everyone must be PROMPT. (This is a great treat you should not miss.)

10:00 - 11:15 "Green Animals", residence of Miss Alice Brayton, Cory's Lane, Portsmouth, Rhode Island.

Via private automobile from Touro Synagogue or Viking Hotel, take Route 138 out Broadway to Two Mile Corner, approximately 2 miles. (Third stop light.) At third stop light, on left you will see The Savings Bank of Newport sign which flashes time of day and temperature. Proceed north on Route 114, approximately 3 miles, past Raytheon Plant. As you come to Corý's Lane, you will see cow barns on left, and on right, a sign to Portsmouth Priory School. Turn left onto Cory's Lane and continue to almost the end at bottom of hill. Miss Brayton's place last on left.

This is a magnificent Topiary Garden which you should not miss.
