Mr. FOGARTY introduced the following bill; which was referred to the Committee on Education and Labor

---

## A BILL

To encourage expansion of teaching and research in the education of mentally retarded children through grants to institutions of higher learning and to State educational agencies.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       That the Commissioner of Education is authorized to make  
4       grants to public or other nonprofit institutions of higher  
5       learning to assist them in providing training of professional  
6       personnel to conduct research in, or conduct training of  
7       teachers in, fields related to education of mentally retarded  
8       children. Such grants may be used by such institutions  
9       to assist in covering the cost of courses of training or study  
10      for such personnel and for establishing and maintaining

1 fellowships, with such stipends as may be determined by the  
2 Commissioner of Education.

3       SEC. 2. The Commissioner of Education is also author-  
4 ized to make grants to State educational agencies to assist  
5 them in establishing and maintaining, directly or through  
6 grants to public or other nonprofit institutions of higher  
7 learning, fellowships or traineeships for training personnel  
8 engaged or preparing to engage in employment as teachers  
9 of mentally retarded children or as supervisors of such  
10 teachers.

11       SEC. 3. Payments of grants pursuant to this Act may  
12 be made by the Commissioner of Education from time to  
13 time, in advance or by way of reimbursement, on such con-  
14 ditions as the Commissioner may determine.

15       SEC. 4. For purposes of this Act—

16       (a) The term “nonprofit institution” means an institu-  
17 tion owned and operated by one or more corporations or  
18 associations no part of the net earnings of which inures, or  
19 may lawfully inure, to the benefit of any private shareholder  
20 or individual.

21       (b) The term “State educational agency” means the  
22 State board of education or other agency or officer primarily  
23 responsible for State supervision of public elementary and  
24 secondary schools in the State.

1 (c) The term "State" includes the District of Columbia  
2 and any Territory, Commonwealth, or possession of the  
3 United States.

4 SEC. 5. The Commissioner of Education is authorized to  
5 delegate any of his functions under this Act, except the  
6 making of regulations, to any officer or employee of the  
7 Office of Education.
