Mr. Fogarry introduced the following joint resolution; which was referred to the Committee on Interstate and Foreign Commerce

JOINT RESOLUTION

To establish in the Department of Health, Education, and Welfare the National Advisory Council for International Medical Research, and to establish in the Public Health Service the National Institute for International Medical Research, in order to help mobilize the efforts of medical scientists, research workers, technologists, teachers, and members of the health professions generally, in the United States and abroad, for assault upon disease, disability, and the impairments of man and for the improvement of the health of man through international cooperation in research, research training, and research planning.

Whereas it is recognized that disease and disability are the common enemies of all nations and peoples, and that the means, methods, and techniques for combating and abating the ravages of disease and disability and for improving the health and health standards of man should be sought and shared, without regard to national boundaries and divisions; and

Whereas advances in combating and abating disease and in the positive promotion of human health can be stimulated by supporting and encouraging cooperation among scientists, research workers, and teachers on an international basis, with consequent benefit to the health of our people and of all peoples; and

Whereas there already exist tested means for international cooperation in matters relating to health, including the World Health Organization, the Pan American Sanitary Bureau, and the United Nations International Children's Fund (UNICEF), with which the United States is identified and associated, and it is highly desirable that the United States establish domestic machinery for the maximum mobilization of its health research resources, the more efficiently to cooperate with and support the research, research training, and research planning endeavors of such international organizations: Therefore be it

- SEC. 2. The purpose of this joint resolution is:
- 2 (1) To encourage and support on an international basis
- 3 studies, investigations, experiments, and research, including

- 3 SEC. 5. (a) There is hereby established, in the Depart-
- 4 ment of Health, Education, and Welfare, the National

- 8 Secretary or the Surgeon General or the Director of the

- 23 (c) The Council shall consist of the Surgeon General of
- 24 the Public Health Service, who shall be Chairman, a duly
- 25 designated representative of the Secretary of State, and six-

teen members appointed by the Secretary without regard to civil service laws. The Director of Vocational Rehabilitation 2 shall be a member ex officio. The Secretary may appoint 3 additional ex officio members on either a permanent or tem-4 porary basis, as desirable, but the number of such additional 5 ex-officio members shall not be greater than two at any one time. The sixteen appointed members shall be leaders in the fields of medical research, teaching and training, medical or biological science, rehabilitation, education, or public and 9 international affairs. Eight of the sixteen shall be selected 10 from among leading experts and authorities in the fields 11 with which this joint resolution is concerned, with special 12 emphasis on associations with research and research training. 13 (d) Each appointed member of the Council shall hold 14 office for a term of four years, except that (1) any member appointed to fill a vacancy occurring prior to the expiration 16 of the term for which his predecessor was appointed, shall be 17 appointed either for the balance of that term, or for a full four-year term at the discretion of the Chairman, and (2) the terms of the members first taking office after September 20 30, 1958, shall expire as follows: four shall expire four years after such date; four shall expire three years after such date; four shall expire two years after such date; and four shall 24 expire one year after such date, as designated by the Secre-25 tary at the time of appointment. None of the sixteen ap-

- 1 pointed members shall be eligible for reappointment until a
- 2 year elapses since the end of his preceding term.
- 3 (e) Members of the Council, other than ex officio mem-
- 4 bers and members who are officers or full-time employees
- 5 of the Government, while attending conferences or meetings
- 6 of their respective Council or committees thereof, or while
- 7 otherwise engaged in the work of the Council or the com-
- 8 mittees thereof, upon the specific authorization of the Chair-
- 9 man of the Council or the Secretary, shall be entitled to
- 10 receive compensation at a rate to be fixed by the Secretary,
- 11 but not exceeding \$50 per diem, and shall also be entitled
- 12 to receive an allowance for actual and necessary traveling
- 13 and subsistence expenses while so serving away from their
- 14 places of residence. This authorization for compensation
- 15 and expenses shall also extend to consultants and members
- 16 of special field or other committees engaged or established
- 17 pursuant to section 6 of this joint resolution.
- 18 (f) The Council shall meet at the call of the Chairman
- 19 or on the request of a third of its membership, but in no
- 20 event less than three times during the year.
- 21 (g) Provision shall be made by the Secretary, through
- 22 the Surgeon General, for coordination of the work of and
- 23 consultation between the Council and the National Advisory
- 24 Health Council, and the national advisory councils of the
- 25 National Institutes of Health, and through the Director of

Vocational Rehabilitation, the National Advisory Council on Vocational Rehabilitation, with respect to matters bearing 2

on the purposes and administration of this joint resolution. 3

Sec. 6. The Secretary is authorized to secure, from time to time, and for such periods as he deems advisable, the assistance and advice of consultants who are technicians, experts, scholars, or otherwise especially qualified in fields related to research, research training, or research planning, from the United States or abroad. These experts, individually or in groups, shall advise the Secretary or the Surgeon General or the Director of Vocational Rehabilitation, or the Council, on such matters as are appropriate. 12

Sec. 7. The Secretary is hereby authorized to engage in the following activities:

(1) Encourage and support research, investigations, and 15 experiments by individuals, universities, hospitals, labora-16 tories, or other public or private agencies or institutions, in 17 countries other than the United States, relating to the cause, 18 prevention, and methods of diagnosis and treatment of physi-19 cal and mental diseases and impairments of man, referred to 20 in paragraph (1) of section 2, by means of: the direct con-21 duct of research in countries other than the United States, 22 fianncial grants, contracts, grants or loans of equipment, and 23 grants or loans of medical, biological, physical, or chemical 24 substances or standards where required for research or re-25

- 1 search training, and furnishing expert personnel from the
- 2 United States (including the payment of travel and subsist-
- 3 ence for such experts when away from their places of resi-
- 4 dence).
- 5 (2) Encourage and support research, investigations, and
- 6 experiments conducted in countries other than the United
- 7 States, related to the rehabilitation of the physically handi-
- 8 capped, by the means referred to in paragraph 2 hereof.
- 9 (3) Encourage and support the coordination of experi-
- 10 ments and programs of research conducted in the United
- 11 States with related programs conducted abroad, by facili-
- 12 tating the interchange of research scientists and experts be-
- 13 tween the United States and foreign countries who are en-
- 14 gaged in such experiments and programs of research,
- 15 including the payment of per diem compensation, subsistence
- 16 and travel for such scientists and experts when away from
- 17 their places of residence, as provided for consultants in section
- 18 5 (e) hereof.
- 19 (4) Make grants for the improvement or alteration of
- 20 facilities needed for medical research and research-training,
- 21 including the provision of equipment for research and train-
- 22 ing purposes.
- 23 (5) Establish and maintain research fellowships within
- 24 the National Institutes of Health and elsewhere with such al-
- 25 lowances (including travel and subsistence expenses) as may

- 1 be deemed necessary to train United States research workers,
- 2 research teachers, technicians and experts in the laboratories
- 3 of other countries, and to procure the assistance of talented
- 4 research fellows from abroad, and, in addition, to provide for
- 5 such fellowships and other research training through grants,
- 6 upon recommendation of the Council, to public and other
- 7 nonprofit institutions. This program of fellowships and
- 8 grants shall not duplicate or replace the programs authorized
- 9 under section 32 of the Surplus Property Act of 1944, as
- 10 amended, and the United States Information and Educational
- 11 Exchange Act of 1948, as amended.
- 12 (6) Encourage and support broad surveys of the inci-
- 13 dence of the major diseases endemic in various parts of the
- 14 world, and initiate comprehensive plans for their eradication
- 15 or mitigation through cooperative programs of research and
- 16 research training in regard to these diseases, including re-
- 17 search in pertinent phases of the science of public health.
- 18 (7) Support and encourage international communication
- 19 in the medical and biological sciences, international scientific
- 20 meetings, conferences, translation services and publications,
- 21 including provision for travel funds to permit participation
- 22 in such conferences.
- SEC. 8. The Secretary shall keep the Secretary of State
- 24 fully informed concerning the projects and programs under-
- 25 taken pursuant to this joint resolution, and shall solicit and

- 1 secure from him policy guidance with regard to such proj-
- 2 ects, programs, or other activities proposed to be undertaken
- 3 under this joint resolution. No project, program, or activ-
- 4 ity shall be undertaken which is contrary to or inconsistent
- 5 with such policy guidance.
- 6 SEC. 9. Programs authorized by this joint resolution
- 7 shall not unnecessarily duplicate those undertaken by other
- 8 departments and agencies of the Government pursuant to
- 9 law, and the Secretary shall take proper precaution to this
- 10 end. Nothing contained in this joint resolution shall be ap-
- 11 plied or construed to diminish the authority or responsibility

- 20 paroled into the United States by the Attorney General pur-
- 21 suant to the authority contained in section 212 (d) (5) of
- 22 such Act.
- SEC. 14. There is hereby authorized to be appropriated
- 24 the sum of \$50,000,000 annually, to carry out the provisions

- 1 of this joint resolution. Such amount is to be apportioned
- 2 as the Congress may direct to the Office of the Secretary, the
