A BILL

To extend the application of the Classification Act of 1949 to certain positions in, and employees of, the executive branch of the Government.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That section 201 (b) of the Classification Act of 1949
- 4 (5 U.S.C., sec. 1081 (b)) is amended to read as follows:
- 5 "(b) Subject to the exemptions specified in section 202,
- 6 and except as provided in sections 204 and 205, this Act
- 7 shall apply to all civilian positions, officers, and employees
- 8 in or under the departments, including positions in local
- 9 boards and appeal boards within the Selective Service Sys-
- tem and employees occuping such positions."

- 1 SEC. 2. So much of section 10 (b) (4) of the Universal
- 2 Military Training and Service Act. (50 App. U. S. C., sec.
- 3 460 (b) (4)) as precedes the words "That any officer" is
- 4 amended to read as follows: "(4) to appoint, and to fix, in
- 5 accordance with the Classification Act of 1949, the compen-
- 6 sation of such officers, agents, and employees (including
- 7 employees of local boards and appeal boards) as he may
- 8 deem necessary to carry out the provisions of this title:
- 9 Provided,".
- SEC. 3. The rate of basic compensation of each employee
- 11 appointed to a position in a local board or in an appeal board
- 12 within the Selective Service System prior to the effective
- 13 date of this Act shall be adjusted, as of such date, as follows:
- 14 (1) If the rate of basic compensation of such employee
- 15 is equal to any scheduled rate for the grade to which the
- 16 position of such employee is allocated, such rate of basic
- 17 compensation shall be the new rate of basic compensation
- 18 for such employee;
- 19 (2) If the rate of basic compensation of such employee
- 20 is less than the minimum scheduled rate for the grade
- 21 to which the position of such employee is allocated, such
- 22 minimum rate shall be the new rate of basic compensation

- 24 (3) If the rate of basic compensation of such employee
- 25 falls between any two scheduled rates for the grade to which

- 4 (4) If the rate of basic compensation of such employee
- 5 is greater than the maximum scheduled rate for the grade
- 6 to which the position of such employee is allocated, such
- 7 rate of basic compensation shall be the new rate of basic
- 8 compensation for such employee.
- 9 SEC. 4. This Act shall take effect at the beginning of
- 10 the first pay period which begins more than ninety days after
- 11 the date of enactment of this Act.
