AN ACT

Making appropriations for the Departments of Labor, and Health, Education, and Welfare, and related agencies, for the fiscal year ending June 30, 1964, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any money
4 in the Treasury not otherwise appropriated, for the Depart-
5 ments of Labor, and Health, Education and Welfare, and
6 related agencies, for the fiscal year ending June 30, 1964,
7 namely:

1 TITLE I—DEPARTMENT OF LABOR

2 BUREAU OF LABOR STATISTICS

3 SALARIES AND EXPENSES

4 For expenses, not otherwise provided for, necessary
5 for the work of the Bureau of Labor Statistics, including
6 advances or reimbursement to State, Federal, and local
7 agencies and their employees for services rendered,
8 ~~(1)\$16,485,000~~ \$16,205,000.

9 REVISION OF THE CONSUMER PRICE INDEX

10 For expenses necessary to enable the Bureau of Labor
11 Statistics to revise the Consumer Price Index, including not
12 to exceed \$250,000 for temporary employees at rates to be
13 fixed by the Secretary of Labor (but not to exceed a rate
14 equivalent to that for general schedule grade 9) without
15 regard to the civil service laws and Classification Act of
16 1949, as amended, \$1,320,000.

17 BUREAU OF INTERNATIONAL LABOR AFFAIRS

18 SALARIES AND EXPENSES

19 For expenses necessary for the conduct of international
20 labor affairs, ~~(2)\$882,000~~ \$842,000.

1 OFFICE OF MANPOWER, AUTOMATION AND TRAINING

2 MANPOWER DEVELOPMENT AND TRAINING

3 ACTIVITIES

4 For expenses necessary to carry into effect the Man-
5 power Development and Training Act of 1962 (Public Law
6 87-415), and for the performance of the functions of the
7 Secretary in the fields of automation and manpower,
8 ~~(3)\$140,000,000~~ \$110,000,000.

9 AREA REDEVELOPMENT ACTIVITIES

10 For expenses necessary to carry into effect sections 16
11 and 17 of the Area Redevelopment Act (Public Law 87-
12 27), including grants or reimbursements to States,
13 ~~(4)\$9,000,000~~ \$8,000,000.

14 BUREAU OF APPRENTICESHIP AND TRAINING

15 SALARIES AND EXPENSES

16 For expenses necessary to enable the Secretary to con-
17 duct a program of encouraging apprentice training, as
18 authorized by the Acts of March 4, 1913 (5 U.S.C. 611),
19 and August 16, 1937 (29 U.S.C. 50), \$5,460,000.

1 BUREAU OF EMPLOYMENT SECURITY

2 LIMITATION ON SALARIES AND EXPENSES

3 For expenses necessary for the general administration
4 of the employment service and unemployment compensa-
5 tion programs, including temporary employment of persons,
6 without regard to the civil-service laws, for the farm place-
7 ment migratory labor program; not more than ~~(5)~~\$12,640,
8 ~~000~~ \$12,400,000 may be expended from the employment
9 security administration account in the Unemployment trust
10 fund, of which \$1,565,000 shall be for carrying into effect
11 the provisions of title IV (except section 602) of the Serv-
12 icemen's Readjustment Act of 1944.

13 LIMITATION ON GRANTS TO STATES FOR UNEMPLOYMENT

14 COMPENSATION AND EMPLOYMENT SERVICE ADMIN-

15 ISTRATION

16 For grants in accordance with the provisions of the Act
17 of June 6, 1933, as amended (29 U.S.C. 49-49n), for
18 carrying into effect section 602 of the Servicemen's Read-
19 justment Act of 1944, for grants to the States as authorized
20 in title III of the Social Security Act, as amended (42
21 U.S.C. 501-503), including, upon the request of any State,
22 the purchase of equipment, and the payment of rental for
23 space made available to such State in lieu of grants for such
24 purpose, for necessary expenses including purchasing and
25 installing of air-conditioning equipment in connection with

1 the operation of employment office facilities and services in
2 the District of Columbia, and for the acquisition of a building
3 through such arrangements as may be required to provide
4 quarters for such offices and facilities in the District of
5 Columbia and for the District of Columbia Unemployment
6 Compensation Board, subject to the same conditions with re-
7 spect to the use of these funds for such purposes as are ap-
8 plicable to the procurement of buildings for other State em-
9 ployment security agencies, and for expenses not otherwise
10 provided for, necessary for carrying out title XV of the Social
11 Security Act, as amended (68 Stat. 1130), ~~(6) \$350,000,000~~
12 *\$425,000,000* may be expended from the employment
13 security administration account in the Unemployment trust
14 fund~~(7)~~, *and of which \$15,000,000 shall be available only to*
15 *the extent necessary to meet increased costs of administration*
16 *resulting from changes in a State law or increases in the*
17 *number of claims filed and claims paid or increased salary*
18 *costs resulting from changes in State salary compensation*
19 *plans embracing employees of the State generally over those*
20 *upon which the State's basic grant (or the allocation for*
21 *the District of Columbia) was based, which increased costs*
22 *of administration cannot be provided for by normal budgetary*
23 *adjustments: Provided, That notwithstanding any provision*
24 *to the contrary in section 302 (a) of the Social Security*
25 *Act, as amended, the Secretary of Labor shall from time*

1 to time certify to the Secretary of the Treasury for payment
2 to each State found to be in compliance with the require-
3 ments of the Act of June 6, 1933, and, except in the case
4 of Guam and the Virgin Islands, with the provisions of
5 section 303 of the Social Security Act, as amended, such
6 amounts as he determines to be necessary for the proper
7 and efficient administration of its unemployment compensa-
8 tion law and of its public employment offices (8) *during fiscal*
9 *year 1964 and that any portion thereof not obligated by*
10 *the State in that year shall be returned to the Treasury and*
11 *credited to the account from which derived: Provided further,*
12 That such amounts as may be agreed upon by the Depart-
13 ment of Labor and the Post Office Department shall be used
14 for the payment, in such manner as said parties may jointly
15 determine, of postage for the transmission of official mail
16 matter in connection with the administration of unemploy-
17 ment compensation systems and employment services by
18 States receiving grants herefrom.

19 In carrying out the provisions of said Act of June 6,
20 1933, the provisions of section 303 (a) (1) of the Social
21 Security Act, as amended, relating to the establishment and
22 maintenance of personnel standards on the merit basis, shall
23 apply.

24 None of the funds appropriated by this title to the

1 Bureau of Employment Security for grants-in-aid of State
2 agencies to cover, in whole or in part, the cost of operation
3 of said agencies, including the salaries and expenses of
4 officers and employees of said agencies, shall be withheld
5 from the said agencies of any States which have established
6 by legislative enactment and have in operation a merit sys-
7 tem and classification and compensation plan covering the
8 selection, tenure in office, and compensation of their em-
9 ployees, because of any disapproval of their personnel or the
10 manner of their selection by the agencies of the said States,
11 or the rates of pay of said officers or employees.

12 Grants to States, next succeeding fiscal year: For mak-
13 ing, after May 31 of the current fiscal year, payments to
14 States under title III of the Social Security Act, as amended,
15 and under the Act of June 6, 1933, as amended, for the
16 first quarter of the next succeeding fiscal year, such sums
17 as may be necessary, the obligations incurred and the ex-
18 penditures made thereunder for payments under such title
19 and under such Act of June 6, 1933, to be charged to the
20 appropriation therefor for that fiscal year: *Provided*, That
21 the payments made pursuant to this paragraph shall not
22 exceed the amount paid to the States for the first quarter of
23 the current fiscal year.

1 UNEMPLOYMENT COMPENSATION FOR FEDERAL
2 EMPLOYEES AND EX-SERVICEMEN

3 For payments to unemployed Federal employees and
4 ex-servicemen, either directly or through payments to
5 States, as authorized by title XV of the Social Security Act,
6 as amended, \$110,000,000.

7 Unemployment compensation for Federal employees
8 and ex-servicemen, next succeeding fiscal year: For making,
9 after May 31 of the current fiscal year, payments to States,
10 as authorized by title XV of the Social Security Act, as
11 amended, such amounts as may be required for payment to
12 unemployed Federal employees and ex-servicemen for the
13 first quarter of the next succeeding fiscal year, and the obli-
14 gations and expenditures thereunder shall be charged to the
15 appropriation therefor for that fiscal year: *Provided*, That
16 the payments made pursuant to this paragraph shall not
17 exceed the amount paid to the States for the first quarter
18 of the current fiscal year.

19 COMPLIANCE ACTIVITIES, MEXICAN FARM LABOR PROGRAM

20 For expenses necessary to enable the Department to
21 determine compliance with the provisions of contracts entered

1 into pursuant to the Act of July 12, 1951, as amended.

2 ~~(9)~~\$870,000 \$1,387,250.

3 SALARIES AND EXPENSES, MEXICAN FARM LABOR

4 PROGRAM

5 For expenses, not otherwise provided for, necessary
6 to carry out the functions of the Department of Labor under
7 the Act of July 12, 1951, as amended (7 U.S.C. 1461-
8 1468), including temporary employment of persons without
9 regard to the civil-service laws, ~~(10)~~\$1,135,000 \$2,048,500,
10 which shall be derived by transfer from the Farm labor
11 supply revolving fund.

12 BUREAU OF VETERANS' REEMPLOYMENT RIGHTS

13 SALARIES AND EXPENSES

14 For expenses necessary to render assistance in connec-
15 tion with the exercise of reemployment rights under section
16 8 of the Selective Training and Service Act of 1940, as
17 amended (50 U.S.C. App. 308), the Service Extension Act
18 of 1941, as amended (50 U.S.C. App. 351), the Army
19 Reserve and Retired Personnel Service Law of 1940, as
20 amended (50 U.S.C. App. 401), and section 9 of the Uni-

1 versal Military Training and Service Act (50 U.S.C. App.
 2 459), and the Reserve Forces Act of 1955 (69 Stat. 598),
 3 ~~(11)\$790,000~~ \$784,000.

4 BUREAU OF LABOR STANDARDS

5 SALARIES AND EXPENSES

6 For expenses necessary for the promotion of industrial
 7 safety, employment stabilization, and amicable industrial re-
 8 lations for labor and industry; performance of safety func-
 9 tions of the Secretary under the Federal Employees' Com-
 10 pensation Act, as amended (5 U.S.C. 784 (c)) and the
 11 Longshoremen's and Harbor Workers' Compensation Act,
 12 as amended (72 Stat. 835); and not less than \$303,000 for
 13 the work of the President's Committee on Employment of
 14 the Handicapped, as authorized by the Act of July 11, 1949
 15 (63 Stat. 409); \$3,470,000: *Provided*, That no part of
 16 the appropriation for the President's Committee shall
 17 be subject to reduction or transfer to any other depart-
 18 ment or agency under the provisions of any existing law;
 19 including purchase of reports and of material for informa-
 20 tional exhibits.

21 (12) OFFICE OF WELFARE AND PENSION PLANS

22 SALARIES AND EXPENSES

23 For expenses necessary for performing the functions
 24 vested in the Secretary by the Welfare and Pension Plans

1 Disclosure Act, as amended (72 Stat. 997; 76 Stat. 35),
2 \$1,565,000.

3 BUREAU OF LABOR-MANAGEMENT REPORTS

4 SALARIES AND EXPENSES

5 For expenses necessary for the Bureau of Labor Manage-
6 ment Reports, \$5,900,000.

7 OFFICE OF LABOR-MANAGEMENT RELATIONS SERVICES

8 SALARIES AND EXPENSES

9 For necessary expenses to carry out the provisions of
10 the Welfare and Pension Plans Disclosure Act, as amended
11 (72 Stat. 997), the Labor-Management Reporting and Dis-
12 closure Act of 1959 (73 Stat. 519), expenses of commissions
13 and boards to resolve labor-management disputes and other
14 expenses for improving the climate of labor-management
15 relations, \$7,500,000.

16 BUREAU OF EMPLOYEES' COMPENSATION

17 SALARIES AND EXPENSES

18 For necessary administrative expenses and not to ex-
19 ceed \$111,000 for the Employees' Compensation Appeals
20 Board, (13)\$4,285,000 \$4,275,000, together with not to
21 exceed \$60,000 to be derived from the fund created by sec-
22 tion 44 of the Longshoremen's and Harbor Workers' Com-
23 pensation Act, as amended (33 U.S.C. 944).

1 EMPLOYEES' COMPENSATION CLAIMS AND EXPENSES

2 For the payment of compensation and other benefits
3 and expenses (except administrative expenses) authorized
4 by law and accruing during the current or any prior fiscal
5 year, including payments to other Federal agencies for medi-
6 cal and hospital services pursuant to agreement approved
7 by the Bureau of Employees' Compensation; continuation
8 of payment of benefits as provided for under the head
9 "Civilian War Benefits" in the Federal Security Agency
10 Appropriation Act, 1947; the advancement of costs for en-
11 forcement of recoveries in third-party cases; the furnishing
12 of medical and hospital services and supplies, treatment, and
13 funeral and burial expenses, including transportation and
14 other expenses incidental to such services, treatment, and
15 burial, for such enrollees of the Civilian Conservation Corps
16 as were certified by the Director of such Corps as receiving
17 hospital services and treatment at Government expense on
18 June 30, 1943, and who are not otherwise entitled thereto as
19 civilian employees of the United States, and the limitations
20 and authority of the Act of September 7, 1916, as amended
21 (5 U.S.C. 796), shall apply in providing such services.
22 treatment, and expenses in such cases and for payments pur-
23 suant to sections 4 (c) and 5 (f) of the War Claims Act of
24 1948 (50 U.S.C. App. 2012) ; \$53,838,000(14), together
25 with such amount as may be necessary to be advanced from the

1 *subsequent year appropriation for the payment of compen-*
2 *sation and other benefits for any period subsequent to March*
3 *31 of the year: Provided, That, in the adjudication of claims*
4 *under section 42 of the said Act of 1916, for benefits pay-*
5 *able from this appropriation, authority under section 32 of*
6 *the Act to make rules and regulations shall be construed to*
7 *include the nature and extent of the proofs and evidence*
8 *required to establish the right to such benefits without regard*
9 *to the date of the injury or death for which claim is made.*

10 **WOMEN'S BUREAU**

11 **SALARIES AND EXPENSES**

12 For expenses necessary for the work of the Women's
13 Bureau, as authorized by the Act of June 5, 1920 (29
14 U.S.C. 11-16), including purchase of reports and material
15 for informational exhibits, \$785,000.

16 **WAGE AND HOUR DIVISION**

17 **SALARIES AND EXPENSES**

18 For expenses necessary for performing the duties im-
19 posed by the Fair Labor Standards Act of 1938, as amended,
20 and the Act to provide conditions for the purchase of sup-
21 plies and the making of contracts by the United States,
22 approved June 30, 1936, as amended (41 U.S.C. 35-45),
23 including reimbursements to State, Federal, and local agen-
24 cies and their employees for inspection services rendered.
25 \$19,300,000.

1 OFFICE OF THE SOLICITOR

2 SALARIES AND EXPENSES

3 For expenses necessary for the Office of the Solicitor
 4 ~~(15)\$4,570,000~~ \$4,420,000 together with not to exceed
 5 \$127,000 to be derived from the Employment Security Ad-
 6 ministration account, Unemployment Trust Fund.

7 OFFICE OF THE SECRETARY

8 SALARIES AND EXPENSES

9 For expenses necessary for the Office of the Secretary of
 10 Labor, ~~(16)including~~ expenses of commissions or boards to
 11 ~~resolve labor-management disputes,~~ \$2,364,000 \$2,269,000,
 12 together with not to exceed \$138,000 to be derived from the
 13 Employment Security Administration account, Unemploy-
 14 ment Trust Fund.

15 TRADE ADJUSTMENT ACTIVITIES

16 For necessary expenses to carry out the functions of the
 17 Secretary of Labor under the Trade Expansion Act of 1962,
 18 ~~(17)\$4,000,000~~ \$150,000.

1 This title may be cited as the "Department of Labor
2 Appropriation Act, 1964".

3 TITLE II—DEPARTMENT OF HEALTH, EDUCA-
4 TION, AND WELFARE

5 FOOD AND DRUG ADMINISTRATION

6 SALARIES AND EXPENSES

7 For necessary expenses not otherwise provided for, of
8 the Food and Drug Administration, including reporting and
9 illustrating the results of investigations; purchase of
10 chemicals, apparatus, and scientific equipment; payment in
11 advance for special tests and analyses and adverse reaction
12 reporting by contract; payment of fees, travel, and per diem
13 in connection with studies of new developments pertinent
14 to food and drug enforcement operations; compensation of
15 informers; payment for publication of technical and in-
16 formational materials in professional and trade journals;
17 and rental of special purpose space in the District of Colum-
18 bia or elsewhere; \$35,805,000.

1 BUILDINGS AND FACILITIES

2 For construction, alteration, and equipment, of facilities,
3 including acquisition of sites, and planning, architectural,
4 and engineering services, (18) ~~\$4,347,000~~ \$4,670,000, to
5 remain available until expended.

6 REVOLVING FUND FOR CERTIFICATION AND OTHER
7 SERVICES

8 For the establishment of a revolving fund for certifica-
9 tion and other services, there is hereby appropriated the
10 aggregate of fees (including advance deposits to cover such
11 fees) paid during the fiscal year 1964, and each succeeding
12 fiscal year, for services in connection with the listing, certifi-
13 cation, or inspection of certain products and the establish-
14 ment of tolerances for pesticides, in accordance with sections
15 406, 408, 506, 507, 702A, and 706 of the Federal Food,
16 Drug, and Cosmetic Act, as amended (21 U.S.C. 346a,
17 356, 357, 372a, and 376), and the unexpended balance of
18 such fees (or advance deposits) heretofore appropriated shall
19 be credited to such revolving fund. This fund shall be avail-
20 able without fiscal year limitation for salaries and expenses
21 necessary to carry out the Secretary's responsibilities in
22 connection with such listings, certifications, inspections, or
23 establishment of tolerances, including the conduct of scien-
24 tific research, development of methods of analysis, purchase

1 of chemicals, fixtures, furniture, and scientific equipment and
2 apparatus; expenses of advisory committees; refund of ad-
3 vance deposits for which no services have been rendered:
4 *Provided*, That any supplies, furniture, fixtures, and equip-
5 ment on hand or on order on June 30, 1963, and purchased
6 or ordered under appropriations for "Salaries and Ex-
7 penses, Certification, Inspection, and Other Services," shall
8 be used to capitalize the revolving fund.

9 OFFICE OF EDUCATION

10 PROMOTION AND FURTHER DEVELOPMENT OF VOCATIONAL 11 EDUCATION

12 For carrying out the provisions of titles I and II of the
13 Vocational Education Act of 1946, as amended (20 U.S.C.
14 15i-15m, 15o-15q, 15aa-15jj), section 1 of the Act of
15 March 3, 1931 (20 U.S.C. 30), the Act of March 18, 1950
16 (20 U.S.C. 31-33), section 9 of the Act of August 1, 1956
17 (20 U.S.C. 34), and section 2 of the Act of September 25,
18 1962 (76 Stat. 586), \$34,756,000, of which \$5,000,000
19 shall be for practical nurse training under such title II of the
20 Vocational Education Act of 1946, as amended, and \$180,-
21 000 for vocational education in the fishery trades and indus-
22 try including distributive occupations therein: *Provided*, That
23 the amount of allotment which States and Territories are not

1 prepared to use may be reapportioned among other States
2 and Territories applying therefor for use in the programs for
3 which the funds were originally apportioned.

4 FURTHER ENDOWMENT OF COLLEGES OF AGRICULTURE AND
5 THE MECHANIC ARTS

6 For carrying out the provisions of section 22 of the Act
7 of June 29, 1935, as amended (7 U.S.C. 329),
8 \$11,950,000.

9 GRANTS FOR LIBRARY SERVICES

10 For grants to the States, pursuant to the Act of June
11 19, 1956, as amended (20 U.S.C. 351-358), \$7,500,000.

12 PAYMENTS TO SCHOOL DISTRICTS

13 For payments to local educational agencies for the
14 maintenance and operation of schools as authorized by the
15 Act of September 30, 1950, as amended (20 U.S.C., ch.
16 13), \$104,466,000: *Provided*, That this appropriation shall
17 also be available for carrying out the provisions of section 6
18 of such Act.

19 ASSISTANCE FOR SCHOOL CONSTRUCTION

20 For an additional amount for providing school facilities
21 and for grants to local educational agencies in federally
22 affected areas, as authorized by the Act of September 23,
23 1950, as amended (20 U.S.C., ch. 19), including not to
24 exceed \$800,000 for necessary expenses during the current
25 fiscal year of technical services rendered by other agencies,

1 \$23,740,000, to remain available until expended: *Provided*,
 2 That no part of this appropriation shall be available for
 3 salaries or other direct expenses of the Department of
 4 Health, Education, and Welfare.

5 DEFENSE EDUCATIONAL ACTIVITIES

6 For grants, loans, and payments under the National
 7 Defense Education Act of 1958 (72 Stat. 1580-1605),
 8 ~~(19)\$229,620,000~~ \$219,620,000, of which \$90,900,000
 9 shall be for capital contributions to student loan funds and
 10 loans for non-Federal capital contributions to student loan
 11 funds, of which not to exceed \$900,000 shall be for such
 12 loans for non-Federal capital contributions; ~~(20)\$54,000,~~
 13 ~~000~~ shall be for grants to States and loans to nonprofit pri-
 14 vate schools for science, mathematics, or modern foreign
 15 language equipment and minor remodeling of facilities;
 16 \$3,750,000 shall be for grants to States for supervisory and
 17 other services \$47,750,000 shall be for grants to States and
 18 loans to nonprofit private schools for science, mathematics, or
 19 modern language equipment and minor remodeling of facili-
 20 ties and for grants to States for supervisory and other serv-
 21 ices: *Provided*, That allotments under sections 302(a) and
 22 305 for acquisition of equipment and minor remodeling shall
 23 be made on the basis of \$47,520,000 for grants to States and
 24 shall be made on the basis of \$6,480,000 for loans to private,
 25 nonprofit schools, and allotments under section 302(b) for

1 *supervisory and other services shall be made on the basis of*
2 *\$3,750,000; \$15,000,000 shall be for grants to States for*
3 *area vocational education programs; and \$15,000,000 shall*
4 *be for grants to States for testing, guidance, and counseling:*
5 *Provided, That no part of this appropriation shall be avail-*
6 *able for the purchase of science, mathematics, and modern*
7 *language teaching equipment, or equipment suitable for use*
8 *for teaching in such fields of education, which can be identi-*
9 *fied as originating in or having been exported from a Com-*
10 *munist country, unless such equipment is unavailable from*
11 *any other source: Provided further, That no part of this*
12 *appropriation shall be available for graduate fellowships*
13 *awarded initially under the provisions of the Act after the*
14 *date of enactment of the Department of Health, Education,*
15 *and Welfare Appropriation Act, 1962, which are not found*
16 *by the Commissioner of Education to be consistent with the*
17 *purpose of the Act as stated in section 101 thereof.*

18 Loans and payments under the National Defense Educa-
19 tion Act, next succeeding fiscal year: For making, after
20 March 31 of the current fiscal year, loans and payments
21 under title II of the National Defense Education Act, for the
22 first quarter of the next succeeding fiscal year such sums as
23 may be necessary, the obligations incurred and the expendi-
24 tures made thereunder to be charged to the appropriation
25 for the same purpose for that fiscal year: *Provided, That*

1 the payments made pursuant to this paragraph shall not
 2 exceed the amount paid for the same purposes for the first
 3 quarter of the current fiscal year.

4 EXPANSION OF TEACHING IN EDUCATION OF THE
 5 MENTALLY RETARDED

6 For grants to public or other nonprofit institutions of
 7 higher learning and to State educational agencies, pursuant
 8 to the Act of September 6, 1958, as amended (20 U.S.C.
 9 611-617), \$1,000,000.

10 (21) EXPANSION OF TEACHING IN EDUCATION OF THE
 11 DEAF

12 *For grants to public or other nonprofit institutions of*
 13 *higher education for courses of study and scholarships for*
 14 *training teachers of the deaf, \$1,500,000.*

15 COOPERATIVE RESEARCH

16 For cooperative research, surveys, and demonstrations
 17 in education as authorized by the Act of July 26, 1954
 18 (20 U.S.C. 331-332), \$11,500,000.

19 EDUCATIONAL RESEARCH (SPECIAL FOREIGN CURRENCY
 20 PROGRAM)

21 For purchase of foreign currencies which the Treas-
