DEFINITIONS

- 7 SEC. 6. For the purposes of this Act—
- 8 (1) The term "Commissioner" means the United States
- 9 Commissioner of Education.
- 10 (2) The term "local education agency" means a board
- 11 of education or other legally constituted local school authority
- 12 having administrative control and direction of elementary
- 13 or secondary schools in a city, county, township, school
- 14 district, or other political subdivision.
- 15 (3) The term "State" includes the District of Columbia,
- 16 Puerto Rico, Guam, American Samoa, and the Virgin
- 17 Islands.
- 18 (4) The term "private school" means an elementary or
- 19 secondary school legally constituted under the laws of the
- 20 State, which includes within its curriculum all of the neces-
- 21 sary subjects which must be taught under the education
- 22 laws of the State, even though such schools also teach addi-
