AN ACT

Making appropriations for the Departments of Labor, and Health, Education, and Welfare, and related agencies, for the fiscal year ending June 30, 1965, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any money
- 4 in the Treasury not otherwise appropriated, for the Depart-
- 5 ments of Labor, and Health, Education, and Welfare, and
- 6 related agencies, for the fiscal year ending June 30, 1965,
- 7 and for other purposes, namely:

2	BUREAU OF LABOR STATISTICS
3	SALARIES AND EXPENSES
4	For expenses, not otherwise provided for, necessary for
5	the work of the Bureau of Labor Statistics, including ad-
6	vances or reimbursement to State, Federal, and local agencies
7	and their employees for services rendered, \$18,125,000.
8	BUREAU OF INTERNATIONAL LABOR AFFAIRS
9	SALARIES AND EXPENSES
10	For expenses necessary for the conduct of international
11	labor affairs, \$856,000.
12	MANPOWER ADMINISTRATION
13	MANPOWER DEVELOPMENT AND TRAINING ACTIVITIES
14	For expenses necessary to carry into effect the Man-
15	power Development and Training Act of 1962, as amended
16	(42 U.S.C. 2571-2620), and for the performance of the
L 7	functions of the Secretary in the fields of automation and
18	manpower, \$327,906,000, to be immediately available.
19	AREA REDEVELOPMENT ACTIVITIES
20	For expenses necessary to carry into effect sections 16

2	For necessary expenses to carry out the functions of the
3	Secretary of Labor under the Trade Expansion Act of 1962,

6	For expenses necessary to enable the Secretary to con-
7	duct a program of encouraging apprentice training, as author-
8	ized by the Acts of March 4, 1913 (5 U.S.C. 611), and
9	August 16, 1937 (29 U.S.C. 50), \$5,541,000.
10	LIMITATION ON SALARIES AND EXPENSES, BUREAU OF
11	EMPLOYMENT SECURITY
12	For expenses necessary for the general administration of
13	the employment service and unemployment compensation
14	programs, not more than \$13,325,000 may be expended from
15	the employment security administration account in the Un-
16	employment trust fund, of which \$1,605,000 shall be for
17	carrying into effect the provisions of title IV (except section
18	602) of the Servicemen's Readjustment Act of 1944.

1 LIMITATION ON GRANTS TO STATES FOR UNEMPLOYMENT 2 COMPENSATION AND EMPLOYMENT SERVICE ADMIN-3 ISTRATION 4 For grants in accordance with the provisions of the Act 5 of June 6, 1933, as amended (29 U.S.C. 49-49n), for carrying into effect section 602 of the Servicemen's Readjustment Act of 1944, for grants to the States as authorized in title III of the Social Security Act, as amended 9 (42 U.S.C. 501-503), including, upon the request of any State, the purchase of equipment, and the payment of rental 11 for space made available to such State in lieu of grants for such purpose, and for expenses not otherwise provided for, 13 necessary for carrying out title XV of the Social Security Act, as amended (68 Stat. 1130), \$455,076,000 may be expended from the employment security administration account 15 in the Unemployment trust fund, and of which \$30,000,000 16 shall be available only to the extent necessary to meet increased costs of administration resulting from changes in a 18 19 State law or increases in the number of claims filed and claims 20 paid or increased salary costs resulting from changes in 21 State salary compensation plans embracing employees of 22 the State generally over those upon which the State's basic 23 grant (or the allocation for the District of Columbia) was 24 based, which increased costs of administration cannot be

- 1 provided for by normal budgetary adjustments: Provided,
- 2 That any portion of the funds granted to a State in the current
- 3 fiscal year and not obligated by the State in that year shall
- 4 be returned to the Treasury and credited to the account from
- 5 which derived: Provided further, That such amounts as may
- 6 be agreed upon by the Department of Labor and the Post
- 7 Office Department shall be used for the payment, in such
- 8 manner as said parties may jointly determine, of postage for
- 9 the transmission of official mail matter in connection with the
- 10 administration of unemployment compensation systems and
- ¹¹ employment services by States receiving grants herefrom.
- Grants to States, next succeeding fiscal year: For mak-
- 13 ing, after May 31 of the current fiscal year, payments to
- 14 States under title III of the Social Security Act, as
- amended, and under the Act of June 6, 1933, as amended,
- 16 for the first quarter of the next succeeding fiscal year, such
- 17 sums as may be necessary, the obligations incurred and the
- 18 expenditures made thereunder for payments under such title
- 19 and under such Act of June 6, 1933, to be charged to the
- 20 appropriation therefor for that fiscal year: Provided, That
- 21 the payments made pursuant to this paragraph shall not
- 22 exceed the amount paid to the States for the first quarter
- 23 of the current fiscal year.

1	UNEMPLOYMENT COMPENSATION FOR FEDERAL
2	EMPLOYEES AND EX-SERVICEMEN
3	For payments to unemployed Federal employees and
4	ex-servicemen, as authorized by title XV of the Social
5	Security Act, as amended, \$126,000,000.
6	Unemployment compensation for Federal employees and
7	ex-servicemen, next succeeding fiscal year: For making, after
8	May 31 of the current fiscal year, payments to States, as

- 7 including payments to other Federal agencies for medical and
- 8 hospital services pursuant to agreement approved by the
- 9 Bureau of Employees' Compensation; continuation of pay-

20	For expenses necessary for the Office of the Secretary
21	of Labor, \$3,198,000, together with not to exceed \$139,000
