Mr. Fogarry introduced the following bill; which was referred to the Committee on Interstate and Foreign Commerce

A BILL

To authorize assistance in meeting the initial cost of professional and technical personnel for comprehensive community mental health centers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That this Act may be cited as the "Community Mental
- 4 Health Centers Act Amendments of 1965".
- 5 TECHNICAL AMENDMENTS
- 6 Sec. 2. (a) (1) The Mental Retardation Facilities and
- 7 Community Mental Health Centers Construction Act is
- 8 amended by changing the heading of title II thereof to read
- 9 "TITLE II—COMMUNITY MENTAL HEALTH CEN-
- 10 TERS", by inserting immediately below such heading the

- 1 subheading "Part A-Grants for Construction of
- 2 Centers", and by changing the words "this title" wherever
- 3 they appear in such title to read "this part"; and (2) all
- 4 references to such title II in titles I and IV of such Act and
- 5 elsewhere are changed to read "part A of title II".
- 6 (b) Such title II is further amended by adding at the
- 7 end thereof the following:
- 8 "PART B-GRANTS FOR INITIAL COST OF PROFESSIONAL
- 9 AND TECHNICAL PERSONNEL OF CENTERS
- 10 "AUTHORIZATION, DURATION, AND AMOUNT OF GRANTS
- "Sec. 220. (a) For the purpose of assisting in the es-
- 12 tablishment and initial operation of community mental health
- 13 centers providing all or part of a comprehensive community
- 14 mental health program, the Secretary may, in accordance
- 15 with the provisions of this part, make grants to meet, for
- 16 the temporary periods specified in this section, a portion of
- 17 the costs (determined pursuant to regulations under section
- 18 223) of compensation of professional and technical person-
- 19 nel for the initial operation of new community mental health
- 20 centers or of new services in community mental health cen-
- 21 ters.
- 22 "(b) Grants for such costs for any center under this
- 23 part may be made only for the period beginning with the
- 24 first month for which such a grant is made and ending with
- 25 the close of four years and three months after such first

- 1 month; and such grants with respect to any center may not
- 2 exceed 75 per centum of such costs for the period ending
- 3 with the close of the fifteenth month following such first
- 4 month, 60 per centum of such costs for the first year there-
- 5 after, 45 per centum of such costs for the second year there-
- 6 after, and 30 per centum of such costs for the third year
- 7 thereafter.
- 8 "APPLICATIONS AND CONDITIONS FOR APPROVAL
- 9 "Sec. 221. (a) Grants under this part with respect to
- 10 any community mental health center may be made only
- 11 upon application, and only if—
- "(1) the applicant is a public or nonprofit private
- agency or organization which owns or operates the
- center;
- "(2) the services to be provided by the center,
- alone or in conjunction with other facilities owned or
- operated by the applicant or affiliated or associated with
- the applicant, will be part of a program providing, prin-
- cipally for persons residing in a particular community
- or communities in or near which such center is situated,
- 21 at least those essential elements of comprehensive mental
- health services which are prescribed by the Secretary;
- 23 "(3) a grant was made under part A of this title
- 24 to assist in financing the construction of the center or

- the type of service to be provided as part of such pro-
- 2 gram by such center with the aid of a grant under this
- 3 part was not previously being provided.
- 4 "(b) No grant may be made under this part after
- 5 June 30, 1970, with respect to any community mental health
- 6 center or with respect to any type of service provided by
- 7 such a center unless a grant with respect thereto was made
- 8 under this part prior to July 1, 1970.
- 9 "PAYMENTS
- 10 "Sec. 222. Payment of grants under this part may be
- 11 made (after necessary adjustment on account of previously
- 12 made overpayments or underpayments) in advance or by
- 13 way of reimbursement, and on such terms and conditions and
- 14 in such installments, as the Secretary may determine.
- 15 "REGULATIONS
- 16 "Sec. 223. The Secretary shall, after consultation with
- 17 the National Advisory Mental Health Council (appointed
- 18 pursuant to the Public Health Service Act), prescribe gen-
- 19 eral regulations concerning eligibility of centers under this
- 20 part, determination of eligible costs with respect to which
- 21 grants may be made, and the terms and conditions (includ-
- 22 ing those specified in section 221) for approving applica-
- 23 tions under this part.

1 "AUTHORIZATION OF APPROPRIATIONS

- 2 "Sec. 224. There are authorized to be appropriated for
- 3 each fiscal year beginning after June 30, 1965, such sums
- 4 as may be necessary to carry out the purposes of this part."
