Mr. FOGARTY, from the Committee on Appropriations, reported the following bill; which was committed to the Committee of the Whole House on the State of the Union and ordered to be printed

## A BILL

Making appropriations for the Departments of Labor, and Health, Education, and Welfare, and related agencies, for the fiscal year ending June 30, 1966, and for other purposes.

- 1      *Be it enacted by the Senate and House of Representa-*
- 2      *tives of the United States of America in Congress assembled,*
- 3      That the following sums are appropriated, out of any money
- 4      in the Treasury not otherwise appropriated, for the Depart-
- 5      ments of Labor, and Health, Education, and Welfare, and
- 6      related agencies, for the fiscal year ending June 30, 1966,
- 7      and for other purposes, namely:

I

1           **TITLE I—DEPARTMENT OF LABOR**

2           **MANPOWER ADMINISTRATION**

3   **OFFICE OF MANPOWER ADMINISTRATOR, SALARIES AND**

4           **EXPENSES**

5       For necessary expenses for the Office of the Manpower  
6   Administrator, including administering the Manpower Develop-  
7   ment and Training Act of 1962, as amended, and research  
8   under such Act, and for performing the functions of the Sec-  
9   retary in the fields of automation and manpower, \$7,794,000.

10      **MANPOWER DEVELOPMENT AND TRAINING ACTIVITIES**

11      For expenses, not otherwise provided for, necessary to  
12   carry into effect the Manpower Development and Training  
13   Act of 1962, as amended (42 U.S.C. 2571-2620),  
14   \$273,500,000.

15      **BUREAU OF APPRENTICESHIP AND TRAINING, SALARIES**  
16           **AND EXPENSES**

17      For necessary expenses for encouraging apprentice  
18   training programs, as authorized by the Acts of March 4,  
19   1913 and August 16, 1937 (5 U.S.C. 611, 29 U.S.C. 50)  
20   and for performing functions under the Manpower Develop-  
21   ment and Training Act of 1962, as amended, \$6,665,000.

22      **BUREAU OF EMPLOYMENT SECURITY, SALARIES AND**  
23           **EXPENSES**

24      For expenses necessary for the general administration  
25   of the employment service and unemployment compensation

1 programs; performing functions under the Manpower Develop-  
2 opment and Training Act of 1962, as amended; and  
3 administration of the Farm Labor Contractor Registration  
4 Act of 1963; \$2,160,000, together with not to exceed  
5 \$15,434,000 which may be expended from the employment  
6 security administration account in the Unemployment trust  
7 fund, of which \$1,708,000 shall be for carrying into effect  
8 the provisions of title IV (except section 602) of the Serv-  
9 icemen's Readjustment Act of 1944.

10 **LIMITATION ON GRANTS TO STATES FOR UNEMPLOYMENT**  
11       **COMPENSATION AND EMPLOYMENT SERVICE ADMIN-**  
12       **ISTRATION**

13       For grants in accordance with the provisions of the  
14 Act of June 6, 1933, as amended (29 U.S.C. 49-49n), for  
15 carrying into effect section 602 of the Servicemen's Re-  
16 adjustment Act of 1944, for grants to the States as authorized  
17 in title III of the Social Security Act, as amended (42  
18 U.S.C. 501-503), including, upon the request of any State,  
19 the purchase of equipment, and the payment of rental for  
20 space made available to such State in lieu of grants for such  
21 purpose, and for expenses not otherwise provided for, neces-  
22 sary for carrying out title XV of the Social Security Act,  
23 as amended (68 Stat. 1130), \$492,100,000 may be ex-  
24 pended from the employment security administration account  
25 in the Unemployment trust fund, and of which \$10,000,000

1 shall be available only to the extent necessary to meet in-  
2 creased costs of administration resulting from changes in a  
3 State law or increases in the number of claims filed and  
4 claims paid or increased salary costs resulting from changes  
5 in State salary compensation plans embracing employees of  
6 the State generally over those upon which the State's basic  
7 grant (or the allocation for the District of Columbia) was  
8 based, which increased costs of administration cannot be  
9 provided for by normal budgetary adjustments: *Provided*,  
10 That any portion of the funds granted to a State in the cur-  
11 rent fiscal year and not obligated by the State in that year  
12 shall be returned to the Treasury and credited to the account  
13 from which derived: *Provided further*, That such amounts as  
14 may be agreed upon by the Department of Labor and the  
15 Post Office Department shall be used for the payment, in  
16 such manner as said parties may jointly determine, of post-  
17 age for the transmission of official mail matter in connection  
18 with the administration of unemployment compensation sys-  
19 tems and employment services by States receiving grants  
20 herefrom.

21 Grants to States, next succeeding fiscal year: For mak-  
22 ing, after May 31 of the current fiscal year, payments to  
23 States under title III of the Social Security Act, as amended,  
24 and under the Act of June 6, 1933, as amended, for the first  
25 quarter of the next succeeding fiscal year, such sums as may

1 be necessary, the obligations incurred and the expenditures  
2 made thereunder for payments under such title and under  
3 such Act of June 6, 1933, to be charged to the appropria-  
4 tion therefor for that fiscal year: *Provided*, That the pay-  
5 ments made pursuant to this paragraph shall not exceed the  
6 amount obligated by the United States for such purposes for  
7 the fourth quarter of the current fiscal year.

8           **UNEMPLOYMENT COMPENSATION FOR FEDERAL**  
9           **EMPLOYEES AND EX-SERVICEMEN**

10          For payments to unemployed Federal employees and  
11 ex-servicemen, as authorized by title XV of the Social Secu-  
12 rity Act, as amended, \$131,000,000, together with such  
13 amount as may be necessary to be charged to the subsequent  
14 year appropriation for the payment of benefits for any period  
15 subsequent to March 31 of the current year.

16          Unemployment compensation for Federal employees  
17 and ex-servicemen, next succeeding fiscal year: For making,  
18 after May 31 of the current fiscal year, payments to States,  
19 as authorized by title XV of the Social Security Act, as  
20 amended, such amounts as may be required for payment  
21 to unemployed Federal employees and ex-servicemen for the  
22 first quarter of the next succeeding fiscal year, and the obli-  
23 gations and expenditures thereunder shall be charged to the  
24 appropriation therefor for that fiscal year: *Provided*, That  
25 the payments made pursuant to this paragraph shall not ex-

1 exceed the amount paid to the States for the first quarter of  
2 the current fiscal year.

3 **LABOR-MANAGEMENT RELATIONS**

4 **LABOR-MANAGEMENT SERVICES ADMINISTRATION,**

5 **SALARIES AND EXPENSES**

6 For necessary expenses to carry out the provisions of the  
7 Welfare and Pension Plans Disclosure Act and the Labor-  
8 Management Reporting and Disclosure Act; expenses of  
9 commissions and boards to resolve labor-management dis-  
10 putes and other expenses for improving the climate of labor-  
11 management relations; and to render assistance in connection  
12 with reemployment under the several provisions of law  
13 respecting reemployment after active military service, \$8,-  
14 580,000.

15 **WAGE AND LABOR STANDARDS**

16 **BUREAU OF LABOR STANDARDS, SALARIES AND EXPENSES**

17 For expenses necessary for the promotion of industrial  
18 safety, employment stabilization, and amicable industrial  
19 relations for labor and industry; performance of safety func-  
20 tions of the Secretary under the Federal Employees' Com-  
21 pensation Act, as amended (5 U.S.C. 784(c)) and the  
22 Longshoremen's and Harbor Workers' Compensation Act,  
23 as amended (72 Stat. 835); and not less than \$364,500  
24 for the work of the President's Committee on Employment  
25 of the Handicapped, as authorized by the Act of July 11,

1) 1949 (63 Stat. 409); \$3,220,000: *Provided*, That no part  
2 of the appropriation for the President's Committee shall be  
3 subject to reduction or transfer to any other department  
4 or agency under the provisions of any existing law; includ-  
5 ing purchase of reports and of material for informational  
6 exhibits.

## 7 WOMEN'S BUREAU, SALARIES AND EXPENSES

8 For expenses necessary for the work of the Women's  
9 Bureau, as authorized by the Act of June 15, 1920 (29  
10 U.S.C. 11-16), including purchase of reports and material  
11 for informational exhibits, \$860,000.

## 12 WAGE AND HOUR DIVISION, SALARIES AND EXPENSES

13. For expenses necessary for performing the duties im-  
14. posed by the Fair Labor Standards Act of 1938, as amended,  
15. and the Act to provide conditions for the purchase of sup-  
16. plies and the making of contracts by the United States,  
17. approved June 30, 1936, as amended (41 U.S.C. 35-45),  
18. including reimbursements to State, Federal, and local agen-  
19. cies and their employees for inspection services rendered,  
20. \$20,905,000.

**21 BUREAU OF EMPLOYEES' COMPENSATION, SALARIES AND  
22 EXPENSES**

23 For necessary administrative expenses, \$4,495,000,  
24 together with not to exceed \$63,000 to be derived from the  
25 fund created by section 44 of the Longshoremen's and

1 Harbor Workers' Compensation Act, as amended (33  
2 U.S.C. 944).

3 EMPLOYEES' COMPENSATION CLAIMS AND EXPENSES

4 For the payment of compensation and other benefits and  
5 expenses (except administrative expenses) authorized by  
6 law and accruing during the current or any prior fiscal year,  
7 including payments to other Federal agencies for medical and  
8 hospital services pursuant to agreement approved by the  
9 Bureau of Employees' Compensation; continuation of pay-  
10 ment of benefits as provided for under the head "Civilian  
11 War Benefits" in the Federal Security Agency Appropria-  
12 tion Act, 1947; the advancement of costs for enforcement of  
13 recoveries in third-party cases; the furnishing of medical  
14 and hospital services and supplies, treatment, and funeral  
15 and burial expenses, including transportation and other ex-  
16 penses incidental to such services, treatment, and burial, for  
17 such enrollees of the Civilian Conservation Corps as were  
18 certified by the Director of such Corps as receiving hospital  
19 services and treatment at Government expense on June 30,  
20 1943, and who are not otherwise entitled thereto as civilian  
21 employees of the United States, and the limitations and  
22 authority of the Act of September 7, 1916, as amended (5  
23 U.S.C. 796), shall apply in providing such services, treat-  
24 ment, and expenses in such cases and for payments pursuant

1 to sections 4 (c) and 5 (f) of the War Claims Act of 1948  
2 (50 U.S.C. App. 2012); \$48,530,000, together with such  
3 amount as may be necessary to be charged to the subse-  
4 quent year appropriation for the payment of compen-  
5 sation and other benefits for any period subsequent  
6 to March 31 of the year: *Provided*, That, in the adjudication  
7 of claims under section 42 of the said Act of 1916, for bene-  
8 fits payable from this appropriation, authority under section  
9 32 of the Act to make rules and regulations shall be con-  
10 strued to include the nature and extent of the proofs and  
11 evidence required to establish the right to such benefits with-  
12 out regard to the date of the injury or death for which claim  
13 is made.

14                   **BUREAU OF LABOR STATISTICS**

15                   **SALARIES AND EXPENSES**

16       For expenses, not otherwise provided for, necessary for  
17 the work of the Bureau of Labor Statistics, including ad-  
18 vances or reimbursement to State, Federal, and local agencies  
19 and their employees for services rendered, \$19,601,000.

20                   **BUREAU OF INTERNATIONAL LABOR AFFAIRS**

21                   **SALARIES AND EXPENSES**

22       For expenses necessary for the conduct of international  
23 labor affairs, \$1,204,000.

1                   **OFFICE OF THE SOLICITOR**2                   **SALARIES AND EXPENSES**

3       For expenses necessary for the Office of the Solicitor,  
4       \$5,401,000, together with not to exceed \$136,000 to be  
5       derived from the Employment Security Administration ac-  
6       count, Unemployment Trust Fund.

7                   **OFFICE OF THE SECRETARY**8                   **SALARIES AND EXPENSES**

9       For expenses necessary for the Office of the Secretary of  
10      Labor, \$3,545,000, together with not to exceed \$140,000  
11      to be derived from the Employment Security Administration  
12      account, Unemployment Trust Fund.

13      This title may be cited as the "Department of Labor  
14      Appropriation Act, 1966".

15      **TITLE II—DEPARTMENT OF HEALTH, EDUCA-  
16                   TION, AND WELFARE**

17                   **FOOD AND DRUG ADMINISTRATION**18                   **SALARIES AND EXPENSES**

19       For necessary expenses not otherwise provided for, of  
20      the Food and Drug Administration, including reporting  
21      and illustrating the results of investigations; purchase of  
22      chemicals, apparatus, and scientific equipment; payment  
23      in advance for special tests and analyses and adverse reac-  
24      tion reporting by contract; payment of fees, travel, and per  
25      diem in connection with studies of new developments perti-

1 nent to food and drug enforcement operations; compensation  
2 of informers; payment for publication of technical and infor-  
3 mational materials in professional and trade journals; and  
4 rental of special purpose space in the District of Columbia  
5 or elsewhere; \$50,352,000.

6                   **BUILDINGS AND FACILITIES**

7       For construction, alteration, and equipment of facilities,  
8 including acquisition of sites, and planning, architectural, and  
9 engineering services, \$5,720,000, to remain available until  
10 expended.

11                   **OFFICE OF EDUCATION**

12                   **EXPANSION AND IMPROVEMENT OF VOCATIONAL**  
13                   **EDUCATION**

14       For carrying out the provisions of titles I, II, and III  
15 of the Vocational Education Act of 1946, as amended (20  
16 U.S.C. 15i-15m, 15o-15q, 15aa-15jj, 15aaa-15ggg), sec-  
17 tion 1 of the Act of March 3, 1931 (20 U.S.C. 30), the  
18 Act of March 18, 1950 (20 U.S.C. 31-33), section 9 of  
19 the Act of August 1, 1956 (20 U.S.C. 34), section 2 of  
20 the Act of September 25, 1962 (48 U.S.C. 1667), and the  
21 Vocational Education Act of 1963 (20 U.S.C. 35-35n);  
22 \$262,491,000, of which \$5,000,000 shall be for practical  
23 nurse training under title II of the Vocational Education  
24 Act of 1946, \$375,000 shall be for vocational education in  
25 the fishery trades and industry including distributive occupa-

tions therein under title I of the Vocational Education Act  
of 1946, \$15,000,000 shall be for area vocational education  
programs under title III of the Vocational Education Act  
of 1946, \$25,000,000 shall be for work-study programs  
under section 13 of the Vocational Education Act of 1963,  
\$10,000,000 for two residential vocational education schools  
under section 14 of the Vocational Education Act of 1963,  
and \$177,500,000 shall be for vocational education programs  
under section 4 of the Vocational Education Act of 1963.

HIGHER EDUCATION FACILITIES CONSTRUCTION

For grants, loans, and payments under the Higher  
Education Facilities Act of 1963, \$641,750,000, of which  
not to exceed \$460,000,000 shall be for grants for construc-  
tion of academic facilities under title I; \$60,000,000 shall  
be for grants for construction of graduate academic facilities  
under title II; and \$119,050,000 shall be for loans for con-  
struction of academic facilities under title III.

FURTHER ENDOWMENT OF COLLEGES OF AGRICULTURE AND

THE MECHANIC ARTS

For carrying out the provisions of section 22 of the Act  
of June 29, 1935, as amended (7 U.S.C. 329), \$11,950,000.

GRANTS FOR PUBLIC LIBRARIES

For grants to the States, pursuant to the Act of June 19,  
1956, as amended (20 U.S.C. 351-358; Public Law 88-

1 269), \$55,000,000, of which \$25,000,000 shall be for grants  
2 for public library services under title I of such Act, and  
3 \$30,000,000 shall be for grants for public library construc-  
4 tion under title II of such Act.

5 **PAYMENTS TO SCHOOL DISTRICTS**

6 For payments to local educational agencies for the  
7 maintenance and operation of schools as authorized by the  
8 Act of September 30, 1950, as amended (20 U.S.C., ch.  
9 13), \$347,000,000: *Provided*, That this appropriation shall  
10 also be available for carrying out the provisions of section 6  
11 of such Act.

12 **ASSISTANCE FOR SCHOOL CONSTRUCTION**

13 For an additional amount for providing school facilities  
14 and for grants to local educational agencies in federally af-  
15 fected areas, as authorized by the Act of September 23,  
16 1950, as amended (20 U.S.C., ch. 19), including not to  
17 exceed \$708,000 for necessary expenses during the current  
18 fiscal year of technical services rendered by other agencies,  
19 \$50,078,000, to remain available until expended: *Provided*,  
20 That no part of this appropriation shall be available for sal-  
21 aries or other direct expenses of the Department of Health,  
22 Education, and Welfare: *Provided further*, That applications  
23 filed on or before June 30, 1965, shall receive priority over  
24 applications filed after such date.

## 1 DEFENSE EDUCATIONAL ACTIVITIES

2 For grants, loans, and payments under the National  
3 Defense Education Act of 1958, as amended (20 U.S.C.  
4 ch. 17; Public Law 88-665), \$412,608,000, of which \$180,-  
5 900,000 shall be for capital contributions to student loan  
6 funds and loans for non-Federal capital contributions to  
7 student loan funds under title II, of which not to exceed  
8 \$1,600,000 shall be for such loans for non-Federal contri-  
9 butions, \$88,200,000 shall be for grants to States and loans  
10 to nonprofit private schools for equipment and minor remod-  
11 eling under title III and for grants to States for supervisory  
12 and other services under title III: *Provided*, That allotments  
13 under sections 302(a) and 305 for equipment and minor  
14 remodeling shall be made on the basis of \$79,200,000 for  
15 grants to States and on the basis of \$10,800,000 for loans to  
16 private nonprofit schools, and allotments under section 302  
17 (b) for supervisory and other services shall be made on the  
18 basis of \$9,000,000; and \$24,500,000 of the amount appro-  
19 priated herein shall be for grants to States for testing, guid-  
20 ance, and counseling under title V: *Provided*, That no part of  
21 this appropriation shall be available for the purchase of science,  
22 mathematics, and modern language teaching equipment, or  
23 equipment suitable for use for teaching in such fields of edu-  
24 cation, which can be identified as originating in or having  
25 been exported from a Communist country, unless such equip-

1 ment is unavailable from any other source: *Provided further,*  
2 That no part of this appropriation shall be available for  
3 graduate fellowships awarded initially under the provisions  
4 of the Act after the date of enactment of the Department  
5 of Health, Education, and Welfare Appropriation Act, 1962,  
6 which are not found by the Commissioner of Education to  
7 be consistent with the purpose of the Act as stated in section  
8 101 thereof.

9       Loans and payments under the National Defense Edu-  
10 cation Act, next succeeding fiscal year: For making, after  
11 March 31 of the current fiscal year, loans and payments  
12 under title II of the National Defense Education Act, for the  
13 first quarter of the next succeeding fiscal year such sums as  
14 may be necessary, the obligations incurred and the expendi-  
15 tures made thereunder to be charged to the appropriation for  
16 the same purpose for that fiscal year: *Provided*, That the  
17 payments made pursuant to this paragraph shall not exceed  
18 the amount paid for the same purposes for the first quarter  
19 of the current fiscal year.

20     EDUCATIONAL IMPROVEMENT FOR THE HANDICAPPED

21     For grants for training and research and demonstrations  
22 with respect to handicapped children pursuant to the Act  
23 of September 6, 1958, as amended (20 U.S.C. 611-617),  
24 and section 302 of the Mental Retardation Facilities and

1 Community Mental Health Centers Construction Act of  
2 1963 (Public Law 88-164), \$21,500,000.

3                   **COOPERATIVE RESEARCH**

4       For cooperative research, surveys, and demonstrations  
5   in education as authorized by the Act of July 26, 1954 (20  
6   U.S.C. 331-332), \$25,000,000.

7                   **EDUCATIONAL RESEARCH (SPECIAL FOREIGN CURRENCY  
8                   PROGRAM)**

9       For payments in foreign currencies which the Treasury  
10 Department determines to be excess to the normal require-  
11 ments of the United States, for necessary expenses of the  
12 Office of Education, as authorized by law, \$1,000,000, to  
13 remain available until expended: *Provided*, That this appro-  
14 priation shall be available, in addition to other appropriations  
15 to such agency, for payments in the foregoing currencies.

16                   **FOREIGN LANGUAGE TRAINING AND AREA STUDIES**

17       For payments to carry out the provisions of section  
18 102 (b) (6) of the Mutual Educational and Cultural Ex-  
19 change Act of 1961 (75 Stat. 529), \$2,000,000.

20                   **SALARIES AND EXPENSES**

21       For expenses necessary for the Office of Education, in-  
22 cluding surveys, studies, investigations, and reports regarding  
23 libraries; coordination of library service on the national level  
24 with other forms of adult education; development of library  
25 service throughout the country; purchase, distribution, and

- 1 exchange of education documents, motion-picture films, and  
2 lantern slides; \$22,562,000.

3           **VOCATIONAL REHABILITATION ADMINISTRATION**

4           **GRANTS TO STATES**

5       For grants to States in accordance with the Vocational  
6 Rehabilitation Act, as amended, \$124,000,000, of which  
7 \$121,000,000 is for vocational rehabilitation services under  
8 section 2 of said Act; and \$3,000,000 is for extension and  
9 improvement projects under section 3 of said Act: *Provided*,  
10 That allotments under section 2 of said Act to the States for  
11 the current fiscal year shall be made on the basis of  
12 \$200,000,000, and this amount shall be considered the sum  
13 available for allotments under such section for such fiscal year:  
14 *Provided further*, That additional allotments, not exceeding  
15 \$1,400,000 in the aggregate, for grants under section 2 of  
16 said Act may be made, in accordance with regulations  
17 of the Secretary, to States in which the Federal share of the  
18 costs of rehabilitation services under such section exceeds  
19 their respective allotments from such \$200,000,000: *Pro-*  
20 *vided further*, That the Secretary shall, within the limits of  
21 such allotments or additional allotments for grants under sec-  
22 tion 2 of said Act, allocate (or from time to time reallocate)  
23 among the States, in accordance with regulations, amounts  
24 not exceeding in the aggregate \$5,000,000, which may be

1 used only for paying the Federal share of expenditures for the  
2 establishment of workshops or rehabilitation facilities where  
3 the State funds used for such expenditures are derived from  
4 private contributions conditioned on use for a specified work-  
5 shop or facility, and no part of the allotment or additional  
6 allotment to any State for grants under section 2 of said Act  
7 other than the allocation or reallocation to such State under  
8 this proviso may be so used: *Provided further*, That the al-  
9 lotment to any State under section 3 (a) (1) of said Act shall  
10 be not less than \$15,000.

11 Grants to States, next succeeding fiscal year: For mak-  
12 ing, after May 31, of the current fiscal year, grants to States  
13 under sections 2 and 3 of the Vocational Rehabilitation Act,  
14 as amended, for the first quarter of the next succeeding fiscal  
15 year such sums as may be necessary, the obligations  
16 incurred and the expenditures made thereunder to be charged  
17 to the appropriation therefor for that fiscal year: *Provided*,  
18 That the payments made pursuant to this paragraph shall  
19 not exceed the amount paid to the States for the first quarter  
20 of the current fiscal year.

21 RESEARCH AND TRAINING

22 For grants and other expenses (except administrative  
23 expenses) for research, training, traineeships, and other

1 special projects, pursuant to section 4 of the Vocational  
2 Rehabilitation Act, as amended, for carrying out the training  
3 functions provided for in section 7 of said Act, for studies,  
4 investigations, demonstrations, and reports, and of dissemi-  
5 nation of information with respect thereto pursuant to sec-  
6 tion 7 of said Act, and not to exceed \$100,000 for carrying  
7 out the functions of the Vocational Rehabilitation Adminis-  
8 tration under the International Health Research Act of 1960  
9 (74 Stat. 364), \$46,045,000.

10 RESEARCH AND TRAINING (SPECIAL FOREIGN CURRENCY  
11 PROGRAM)

12 For payments in foreign currencies which the Treasury  
13 Department determines to be excess to the normal require-  
14 ments of the United States, for necessary expenses of the  
15 Vocational Rehabilitation Administration, as authorized by  
16 law, \$2,000,000, to remain available until expended:  
17 *Provided*, That this appropriation shall be available, in addi-  
18 tion to other appropriations to such agency, for the pay-  
19 ments in the foregoing currencies.

20 SALARIES AND EXPENSES

21 For expenses, not otherwise provided for, necessary for  
22 the Vocational Rehabilitation Administration, \$3,415,000.

## 1                   PUBLIC HEALTH SERVICE

## 2                   PREAMBLE

3         For necessary expenses in carrying out the Public Health  
4     Service Act, as amended (42 U.S.C., ch. 6A) (hereinafter

8 in title V, parts 1, 2, 3, and 4 of the Social Security Act, as  
9 amended (42 U.S.C., ch. 7, subch. V; 74 Stat. 995-997,  
10 and 77 Stat. 273), \$162,000,000 of which \$40,000,000  
11 shall be available for maternal and child-health services under  
12 part 1, \$40,000,000 for services for crippled children under

20           **OFFICE OF AUDIT, SALARIES AND EXPENSES**

21       For expenses necessary for the Office of Audit, \$3,313,-  
22 000, together with not to exceed \$510,000 to be transferred  
23 from the Federal old-age and survivors insurance trust fund.

**1        OFFICE OF FIELD ADMINISTRATION, SALARIES AND****2                    EXPENSES**

3        For expenses necessary for the Office of Field Admin-  
4 istration, \$1,772,000 together with not to exceed \$1,293,000  
5  to be transferred from the Federal old-age and survivors  
6 insurance trust fund and not to exceed \$33,000 to be trans-  
7 ferred from the Operating fund, Bureau of Federal Credit  
8 Unions.

**9                    SURPLUS PROPERTY UTILIZATION**

10      For expenses necessary for carrying out the provisions of

19 For expenses necessary for the National Labor Relations

22 141–167), and other laws, \$28,165,000: *Provided*, That  
23 no part of this appropriation shall be available to

5      To enable the Secretary of the Treasury to pay in ad-  
6      vance to the Interstate Commission on the Potomac River  
7      Basin the Federal contribution toward the expenses of the  
8      Commission during the current fiscal year in the administra-  
9      tion of its business in the conservancy district established  
10     pursuant to the Act of July 11, 1940 (54 Stat. 748),  
11     \$5,000.

12     **TITLE VIII—UNITED STATES SOLDIERS' HOME**  
13     **LIMITATION ON OPERATION AND MAINTENANCE AND**

15     For maintenance and operation of the United States  
16     Soldiers' Home, to be paid from the Soldiers' Home perma-

12 SEC. 1002. Appropriations contained in this Act avail-

16 SEC. 1003. Appropriations contained in this Act avail-  
17 able for salaries and expenses shall be available for expenses

20 which will contribute to improved conduct, supervision, or  
21 management of those functions or activities.

22 SEC. 1004. The Secretary of Labor and the Secretary of

2 official reception and representation expenses.

3 SEC. 1005. None of the funds contained in this Act  
4 shall be used for implementing any provision of the Economic  
5 Opportunity Act of 1964.

6 This Act may be cited as the "Departments of Labor,  
7 and Health, Education, and Welfare Appropriation Act,  
8 1966".
