- 1. To find out who Joseph A. McHenry, the Negotiator, of the the Contract with the War Department was.

MANNER OF PROCEDURE AND KNOWLEDGE OBTAINED:

- 1. I visit the Mayor of Boston, Maurice Tobin.
- I told him I wanted to find out who was Joseph A.McHenry as he was the Negotiator of our Contract.

 He asked me --- "For whom does he work"

 I told him:

War Department Corps of Engineers Office of Division Engineer New England Division.

Mayor Tobin:

"Oh! then, he works for my very good friend, Colonel Gillette."

He called Col Gillette on the phone and said:

"Father McLaughlin, my very good friend, is here and he has serious matter on his mind.

I want you to receive him and do as much for him as you would for me."

Col.Gillette:

"I will be very glad to do so When can he be over to see me.

Mayor Tobin:

"In about one hour"

- 3. I then went to the First Service Command to visit my very good friend Col.Robert L.Collins to seek his advise on the matter.
 - I explained to him how I had come to find out about Joseph A.McHenry and the Contract.
 - Col. Collins manhimmi said you should see Col.Gillette.

He then called Col Gillette on the phone.

Col Collins:

" I want to introduced to you my very dear Friend
Father McLaughlin who is here with me.
He has some serious matter on his mind in regard to the
Army Contract.
I want you to do everything you can for him.

Col. Gillette:

Mr. French:

"I am sorry if I made that impression.

I am only to help the institution in the proper drawing up

of the contract.

Referring to MaHenry.

Mr.McHenry:

"That is right, Father, all he does is save time, so that the preliminaries will be out of the way before we come to the actual negotiating of the contract.

Fr.McLaughain;

"Well, then, it is like my old straw hat. Much to do about nothing.

This summer I sat in a restauraunt, I on one seat and my hat on the other across the table.

Suddenly a man appeared, sat on hat; the waiter thought it was ruined. But it was much to do about nothing.

Mr.McHenry:
