REPORT ON THIRD TRIP TO WASHINGTON Jan. 25-30, 1943

Pre-Notes:

On Jan. 23,1943 I visited Edward Higgins at the Narragansett Hotel in regard to the Army-Navy College program.

The substance of the talk was this:

- Il) Mr.J. Farrell Coyle was to be appointed State Director for Rhode Island of the War Manpower Commission.
- (2) When that happened which should have been Jan.13, Mr. Higgins, Mr. Cotte, and myself were to get together at the Narragansett Hotel and settle the quota of college students for Providence College.
- (3) I agreed that was fine; but, in view of the fact the Army intended to selected 70,000 men for Pre-Flight training, I told Mr. Higgins he should consult Mr. Watson B. Miller in Washington on his return Jan. 26, Tuesday.

 He agreed to this, and, further told me that he

He agreed to this, and, further told me that he would call me on the telephone Jan. 26 or 27, and, for me to be prepared to go to Washington, D.C. if he should need my help.

Rather Dillon agreed at my suggestion on Sunday, Jan. 24, that I should go to Washington on Jan. 25 incorder to be on the stene should I be needed.

I ARRIVED IN WASHINGTON --- TUESDAY --- Jan. 25, at 1:30 P.M.

I went immediately to Senate Green's Office and met Mr. Higgins at 2:00.

Situation on Tuesday Afternoon in Higgin's Office:

Higgins rushed out to me in the outer office.

Papers in hand and appeared much upset and very busy.

He was all concerned with Coyle's appointment; told me he would be appointed in a few days.

Did not want to visit Watson B. Miller; wanted to wait until Goyle was appointed.

He saw I was anxious ,and, added -- "But I will see Penman tomorrow at the War Manpower Commission, and, bring up about the 70,000 "

I said "fine" and left.

SITUATION ON WEDNESDAY

I was to visit Ed. Higgins at 5:00 Oclock in the afternoon. So in the Morning I visited General Jimmie Ulio, at the Pentagon Building.

He received me graciously.

He told that Brig.Gen.Dalton was the proper man in charge of the school program and for me to see him. He said that the releases on policy were released in his name, but, that Dalton did the work and Rivected the policy.

At 5:00 oclock I arribed at Higgin's Office.

In about half an hour in came out to me in much the same mood as the previous day, and, said diffidently "I have no news for you".

Then, he related that the OTL SITUATION had become accute in R.I. and his whole day was spent in getting oil for war plants in R.I.

I doubted him, BUT EVENTS PROVED HE WAS TELLING THE TRUTH
I imagine he saw I was much disappointed ,and,added
"I will go to Penman to-morrow,however; come back
then,and, I will have news."

I was to visit him again on Thursday at 5:00

SITUATION ON THURSDAY

Arrived at Higgin's Office at 5:00.

He cam out into the outer office and said--- " I have bee been very busy all day and had a callé in for Mr. Penman to call me, but he did not call;

Penman must have been out of his office.

Told me come back on Friday.

I WAS MUCH DISCOURAGED BY THIS TIME.

SITUATION ON FRIDAY:

Higgins had a full and helpful REPORT, it is as follows:

The BANKHEAD COMMITTEE had been created during the week of Jan.17th. Its purpose is for the limitation of drafting men into the armed services.

The ADMINISTRATION has concluded that the Army and Navy, particularly the ARMY, have gone too far with drafting of men. The situation calls for ADMINISTRATION control FURTHERMORE, the ADMINISTRATION believes that the differences in the PLANS of the Army and the Navy for selected Colleges and students etc. should be brought into ONE PLAN to be known as THE MASTER PROGRAM.

This MASTER PROGRAM will be under the supervision of:

The War Manpower Commission, and,

The Bankhead Committee.

Of the 5 men on this committee, Senator Green, R.I., is one of the members.

THE SITUATION AS ITS STAND NOW:

ALL PROGRAMS ARE SUSPENDED. (Hence the 70,000 men for Army) When the MASTER PROGRAM IS ANNOUNCED the selection of men for colleges will begin.

COYLE will be confirmed by the Senate on Feb.lst., then, the program will work through him.
