Loyalty Fund Reaches Half Million Mark

ANNUAL CAMPAIGN ENTERS FINAL PHASE; CLASS PHONATHONS IN APRIL

Francis L. Gragnani '40, Providence College's 1979-80 Loyalty Fund General Chairman, announced today that the College has received Iannuccilli, M.D. '61, Frank M. D'Alessandro, M.D. '55, Richard A. DeBlasio '56, Robert J. Paci '64 and Daniel J. Ryan '69, the school received more than 2,000 pledges totaling over \$200,000.00.

The fund is now in the Regional

Hafey, the golden anniversary class of 1930 has received over \$5,000 in pledges while the silver anniversary class of 1955, led by class agents Francis "Butch" Carey and Charles Sullivan has obtained almost \$30,000 in pledges - the largest silver

more than one-half million dollars in pledges from Alumni, Friends, Parents, Faculty and Corporations around the United States. "Our returns to date are truly encouraging and I'm very impressed with the increased generosity being shown by many of our Alumni", said Gragnani.

Last year the Loyalty Fund broke all previous records with 7,019 pledges for over \$470,000.00. As of the last week in February, the Fund had already received over 5,700 pledges totaling \$500,997.00. This figure is roughly \$100,000 ahead of last year's record breaking pace.

William T. Nero, Associate Vice President for Development, along with Chairman Gragnani attributed the increased participation and fund returns to many factors, among them a growing awareness of the college's need for financial support. Nero also noted what he called "the most valuable factor" for the fund's success - interested and effective volunteers and volunteer leadership.

The first phase of the fund, Special Gift Phonathons, was conducted in September. Under the leadership of Special Gift Chairmen such as Robert E. Finneran '53, James G. Hagan '58, William D. Slattery, Jr. '53, Edward A. phonathon phase which consists of phonathons conducted by alumni volunteers in 25 different cities across the country. As of March 1st, 16 regional phonathons had been completed raising a total of \$55,059 in pledges from 1,229 alumni.

Chairman Gragnani also noted that with the end of the regional phase starts the third phase of the fund - the Class Phonathons. "Our goal of \$525,000 is the largest in the history of Providence College. In order to attain such an ambitious objective, we must rely on our Class Phonathons to round out our fund and put us over goal. We also hope to better last year's Alumni participation rate of 40% because this statistic influences the acquisition of gifts from other sources."

The Class Phonathons are held on Providence College's Lower Campus from April 8 through April 16th. They are coordinated by the Development Office with the assistance of three Class Solicitation Chairmen, Henry T. Kaveny '27, Wallace R. Tasca '40 and John E. Martinelli '65.

Separate Anniversary Class phonathons for the classes of 1930 and 1955 were held earlier in the year. Under the leadership of Anthony J. DeNicola and Leo R.

Gragnani asked that anyone who has not yet pledged to the 79-80 Loyalty Fund do so as soon as possible to minimize the financial expenses and volunteer time needed to wrap-up the 1979-80 fund solicitation.

MATTHEW SMITH NAMED SPEAKER OF RI HOUSE OF REPRESENTATIVES

On January 25, 1980, Matthew Smith, Professor of History, and Archivist at Providence College, became the Speaker of the Rhode Island House of Representatives. Serving his eighth year in the Rhode Island General Assembly, Smith is representative for the 70th district of Providence.

Smith began as the Providence College Archivist in 1967. At that time, he began compiling many of the college's private manuscripts which were primarily concerned with the national, local, civil, economic, and social life of Rhode Island during the post-civil war period. Later, he collected and compiled manuscripts which recreate the history of Providence College since it was chartered in 1917.

Smith, a professor of History, teaches courses in American, urban, Civil War, and Golden Age History.

A native Rhode Islander and Providence college alumnus, Smith resides in Providence with his wife and four children.

In 1978, Miss Manchester received her MA degree, Cum Laude, in Public Communication/Journalism from Purdue University, West Lafayette, Indiana. While a graduate student at Purdue, she also served as a Graduate Teaching Assistant in the Department of Communication.

Before coming to Providence, Miss Manchester was a part-time reporter and promotion/production assistant at WPRI-TV12, East Providence. Her work at WPRI included field reporting, promotional copywriting, camera and electronic graphics operation, and occasional hosting of an interview talk show.

Since September 1978, she has also been a Visiting Lecturer in the Department of Business Administration at Providence College's School of Continuing Education.

David M. Tschaen '80 (Chemistry) and Karen J. Ferrante '80 (Clinical Chemistry/Biology) orally presented their research paper on the inflammatory arthritic condition, at the symposium. Forty undergraduate students from across the nation were selected to participate in the program.

SPORTS WRAP-UP

LADY FRIARS AMONG BEST IN NATION!

There are those who say it's a man's world. It may be, just don't tell Providence College's Lady Friars.

It was the best of winters for the Lady Friars, who came up with championship teams in basketball and ice hockey and, while the men Friars did well, too, at the end when it was all said and done, it was the Lady Friars who were in the spotlight.

First in hockey, then in basketball. For the record, both sports had their best season ever at PC. The women skaters finished 20-3, the women hoopsters 22-7. Both all-time records for wins in a season.

The hoopsters went all the way to the second round, or the round of 16, in the national tournament before running into a buzz-saw, nationally sixth-ranked Rutgers University and bowing in Alumni Hall, 70-54.

But, along the way, the Lady Friars of coaches Tim and Lisa Gilbride beat then 10th-ranked Cheyney State to win their own first PC Women's Invitational Tournament, and then at the end, upset Syracuse, then Queens and Boston University to become only the second New England team ever to win the Northeast Regional championship.

It was truly a remarkable season led by a couple of seniors — cocaptains Lynn Sheedy (Warwick, R.I.) and Mary Ann McCoy (Westwood, Mass.), who, combined, averaged 25 points per game. Sheedy will leave as the Lady Friars' all-time scorer with 1,261 career points and with 571 career assists. McCoy will leave as No. 1 all-time in rebounding with 1,056; No. 2 in scoring with 1,224 points and No. 2 in assists with 324.

For both, the trip to the nationals was a most fitting climax to a great four-years. They played in four straight post-season tournaments and on three straight 20-win plus teams. In many respects, the women skaters were even more successful. Their three losses were all to New Hampshire, which hasn't lost a game in the three years they've had varsity women's hockey. In fact only one tie (the PC, of course) a year ago mars an otherwise perfect record for UNH.

Anyway, the Lady Friars of coach Tom Palamara hosted the first ever Eastern AIAW tournament, tantamount to the national championships because virtually every college which has women's ice hockey is in the East, and finished second, bowing to UNH in a well-played finale, 5-2.

But PC had little trouble with everyone else throughout the year. Like the women hoopsters, the skaters had many stars in a wellbalanced galaxy.

Sophomore Mary Ellen Riordan (Quincy, Mass.) led the PC scorers with 35 goals and 24 assists for 59 points. Juniors Kathy Lenahan (Orange, Conn.) (23-35-58) and Connie Richer (Marlboro, Mass.) (15-33-48) were right behind.

In goal, senior Jill Spencer (Foster, R.I.) and freshman Jane Ford (Watertown, Mass.) split the job and both were outstanding. Spencer was 10-0 with five shutouts, 139 saves and an 0.60 goals against average. Ford was 103 with two shutouts and a 2.61 goals against average.

So, it's easy to see it was a great year. Don't ever tell the Lady Friars it's a man's world. Their records speak for themselves.

SEXTET AT ECAC: JUST A GOAL AWAY IN HOMESTRETCH

Just a goal away.

So near, and yet to far away. The NCAA hockey championships are in downtown Providence, in the Civic Center, this year and those first two paragraphs best tell it all about the Providence College hockey team.

Back in October, before the wild and crazy ECAC hockey season began, those allegedly in the know didn't even have Providence ranked among the top eight in the East. But that was understandable because the Friars did lose six players — four of whom signed professional contracts.

But those in the know also didn't know much about Lou Lamoriello and his young 1979-80 hockey club; didn't know it was an unselfish group, a club with talent guided by four seniors, some excellent underclassmen and perhaps the best freshman class of hockey players ever recruited by PC.

So, what happens? The Friars end up winning 21 games, the most in their history; reach a national ranking of fourth during the season, not only make the ECAC playoffs, but are seeded second and gain home ice for the first time in 16 years.

First came an 8-3 blowout at home against Colgate and a subsequent trip to the Boston Garden for the ECAC finals. Next, disaster. A 6-5 loss to Cornell, the eventual champion, as the Big Red scored four unanswered goals in the final period. There was a happy ending, though, a 6-5 victory in OT against Clarkson in the consolation game. Some thought there might have been, and should have been, a playoff to determine the second ECAC team to the NCAA finals. But the NCAA committee voted against such an idea and, in addition to Cornell, Dartmouth, the runnerup ECAC team, was sent to the Civic Center.

So, the Friars ended up a goal away from realizing a dream — a rare trip to the Final Four.

But, when you think about it, the whole season was like a dream. Here was a team of 29, which included 10 freshmen and 9 sophomores, going all the way to the ECAC finals when it wasn't even picked, in pre-season, to finish in the top eight. Here was a team which won more games than any other Friar hockey team. Here was a team that, after losing its first four games, went 21-7 the rest of the way and never lost two games in a row. Think about that stat: the Friars never lost two games in a row after it lost the first four to start the season.

In many ways, it was the best season ever at Providence. Perhaps even as good as the '64 team which won the ECAC title and played in the NCAA tournament. It was a team, this 1979-80 Friar team, which was enjoyable to watch, enjoyable to be with and a team without a real star. A very unselfish team that somehow always got the job done.

Everyone, in their own way, contributed. The four seniors defensemen Dan Haskins and Frank Johnson, plus centers Jeff Whisler and Denis Martin — will graduate knowing that they'll be in the first class at PC which has played in four straight ECAC tournaments and the class with the best four-year hockey record at PC.

For those seniors, especially Whisler, the captain and a guy who played in a record 123 straight games (he never missed a start in the four years he was at PC), the ending may have been a bit disappointing. Just a goal away and so near, yet so far away.

But Whisler can leave knowing he scored the team's last goal in PC's winningest year ever — a slap shot 8:45 into OT to beat Clarkson in the ECAC consolation game.

It was most apropos!

FRIARS HANG TOUGH AGAINST NATIONAL HOOP POWERS

In terms of the won-loss record (11-16), basketball was not a success at Providence College this winter. But if one watched the team play, thought about who it played against and just who was on the team, one couldn't be disappointed.

It was an exciting winter despite those 16 defeats because, except for a blowout at Purdue and a 20-point loss at home to Syracuse, PC was in every game.

Before going into great detail, consider the following:

• Of the 24 opponents on the PC schedule this winter, 11 went into post-season play: Purdue, Georgetown, Duke, Holy Cross, Villanova, Syracuse, Louisville and St. John's to the NCAA; Connecticut, Boston College and St. Joseph's to the NIT.

• Four of those NCAA teams reached the round of eight and two — Purdue and Louisville — went to the Final Four.

• Ten of the 16 defeats were by six points or less. To go a step further, PC lost to Brown by a point, to Holy Cross at the buzzer, to Boston College on a pair of free throws with time expired and to St. Joe's with six seconds left.

• A step further. PC lost to Georgetown by five and Georgetown came within a point of reaching the Final Four. The Friars lost to Duke by four when Duke was ranked No. 1 in the country. PC lost to Louisville by six and Louisville is in the Final Four. Then there were six and four point losses at the end to St. John's, when the Redmen were ranked No. 7 in the nation. It should also be noted the Friars played Syracuse and Louisville on back-to-back Saturdays when both teams were No. 2; Purdue when the Boilermakers were No. 7 and Georgetown when the Hoyas were No. 13.

So, once again the Friars were right in there with the iron. It's a credit to Walters and his club that it did so well when you consider it was a club that had NO DEPTH and was pretty much a six-man team. Of the six, five return; John Nolan, a guard who was the sixth man and then a starter at the end, will graduate this spring.

Game-after-game the Friars were ready, mentally and emotionally. And game-after-game it was difficult because the Friars had to be patient offensively, play tenacious defense and find it damn near impossible at the end to win because there just weren't enough offensive answers.

"They gave us everything they had, every day in practice and in every game. I wish they could have won a few more - even half of those 10 games we lost by six points or less," said Walters. "Every game was a challenge, a struggle offensively. But every game, except Purdue and Syracuse, we were right in there until the end. Every time we asked for a little more, we got it. But it was never enough because there was always someone better. We are not happy, not happy at all. with the final record. But we are happy, over-all, with the effort. We really couldn't ask for anything more."

For the statistically-minded fans, PC had three players finish the season averaging double figures juniors Jerry Scott, 14.9 Rudy Williams, 14.7, and sophomore Bill Fields, 11.4. As a team, the Friars averaged only 63.1 per game and gave up 62.7

The most pleasant surprise was the play of freshman Ricky Tucker, a point guard from Philadelphia who quickly became the darling of PC fans with game-long hustle and great exhuberance. He averaged 8.4, but led the club with 143 assists.

The Friars finished last in the BIG EAST Conference. What next year will be like is difficult to say, even though five starters return. Walters and the Friars need help, a lot of help.

The day after the season ended Walters was in Florida on a recruiting trip, and stopped in Washington, Philadelphia, New Jersey and New York on the way home.

That should tell us all something!


