"Language: The Social Mirror" (Rowley, Mass.: Newbury

House). Dr. Chaika has also recently finished collecting data at Butler Hospital for a study of the ways schizophrenics encode events into narratives and later recall them.

At the Third Symposium of the North American Apiotherapy Society in Washington, D.C., Dr. James Belliveau of the Chemistry Department and Dr. Gerard P. O'Leary of the Biology Department collaborated on two presentations: "A Survey of the Plasma Corticosteroids in Various Animal and Human Arthritic Conditions", and "The Reliability of Using the Adjuvant Induced Arthritic Rat Model in Arthritis Research." Drs. Belliveau and O'Leary were also elected to the Science Advisory Board of the Warren Memorial Arthritis Foundation at this Symposium.



LOYALTY FUND ENTERS REGIONAL PHASE — The 1980-81 Loyalty Fund is continuing its torrid pace as it moves from the special gifts concentration stage into the regional phonathon phase.

As this issue of Update went to press, 3907 gifts and pledges totalling \$431,951 had already been amassed compared to 3,373 gifts and pledges amounting to \$346,916 as of the same time last year.

Included in this year's totals to-date are \$331,266 from alumni, \$23,178 from parents, \$26,697 from friends, \$45,925 from corporations and \$4,885 from non-alumni faculty-staff.

Having completed a round of successful phonathons at the Chapin Incorporators, Chapin Associates, President's, Chancellor's, Dean's and Century Club levels, the Fund will now concentrate on reaching alumni for gifts at all levels through a series of phonathons in selected cities throughout the country over the next four months.

The regional phonathons commence with Minneapolis, Minnesota on December 28 and conclude with San Francisco, California on April 6 and are in addition to the regular fund appeals mailed from the college throughout the year.

All alumni are urged to mail in their Loyalty Fund pledges as soon as possible to minimize the number of calls to be made, and anyone wishing to volunteer to work on the regional phonathons listed in our previous Update can do so by calling the Development Office collect at 401-865-2415.



Fr. McPhail, a 1961 alumnus of Providence College, was ordained to the priesthood in 1964. He also attended the Dominican House of Studies in Washington, DC, Boston University, and the Catholic University of America. He holds the Bachelor's Licentiate and Lector's degrees in Sacred Theology.

Presently a special lecturer in the Religious Studies Department, Father McPhail is the Director of Special Events for the College as well as Assistant Director of Slavin Center, the student union.

#### LADY FRIARS FALL WRAP-UP

Many local readers who are sports nuts, or who just like to know what is happening on the local college athletic scene, have been aware that there is a fine women's athletic program at Providence College. The headlines over the past few years all sound alike, usually saying, 'The Lady Friars Win' or 'The Lady Friars Over . . . .' Well, with the program moving into Division I this past fall, many thought the headlines would read 'In a Transition Year' or 'not much chance of post season play'.

How did the Lady Friars fare this fall? Just fine, as usual, thank you.

The women's volleyball team, under coach Dick Gagge, earned its third consecutive trip to Eastern Regionals, this time in Division I while compiling a 46-17 record for the season. It was a long and tough road for PC spikers through the months of September, October and November of being on the road for tournaments every weekend.

Through all these tournaments, the Lady Friars knew "they would have to prove themselves as a quality team to the Division I competitors to reach the regionals" said Bagge.

It was a fall full of highlights such as winning the Southern Connecticut Tournament, the Providence Invitational and placing second at the University of Massachusetts and Central Connecticut tournaments. The team was 43-14 when selected to compete in the Eastern Regionals, seeded eighth at Penn State. PC held its own against such teams as topseeded Pittsburgh and beat No. 5 seed Maryland before losing to Georgetown in single elimination play of the quarter-finals. The leaders on the court were senior co-captains Joan Finneran and Sandy Radcliffe, the first seniors for Bagge in his four year old program. There are many talented underclassmen on the 1980 squad who will be back and ready for the 1981 season.

Another team which also reached the Division I regionals was coach Kathy Cerra's cross country team. The 1980 squad had a fine season led by freshmen Diane Swick and Julie McCrorie with upperclassmen Sue Ratcliffe, Oona Mulligan and Sheila Barry. These five runners consistently placed on top for the Lady Friars in every race. The team won the Fitchburg Invitational with junior Sue Ratcliffe setting a course record with a time of 18:24.4 over the 3.1-mile course. The team then competed in a race at Franklin Park in Boston hosted by Boston College. PC placed second, losing to host and unbeaten BC, but beat Georgetown, St. John's and Syracuse.

Providence was running in top form as it headed to the state tournament. The Lady Friars finished second behind Rhode Island, but overcame Brown, Rhode Island College and Bryant. The next

week they swept the top four places to capture the Holy Cross Invitational, beating eight teams. Then, another trip to Franklin Park for the New Englands, where the women finished eighth in a field of 40.

For their first trip to Division I Regional meet, the Lady Friars finished a respectable 13th with 237 points. Top finishers for the Lady Friars were freshmen McCrorie (38th), Swick (48th), followed by upperclassmen Ratcliffe (52nd) and Mulligan (67th). Cerra said, "I was pleased with the hard work that every runner on the team gave, and we expect another successful year."

Yet another winning team for the Lady Friars this fall was coach Kate Denning's field hockey team. The second year coach led her team to a 11-5 finish in its first season of Division I play. The team, as are the others, is still upgrading its schedules, but did see Division I action against national power New Hampshire and Rhode Island.

A highlight of the season was a trip to Connecticut and New York for three days to play Bridgeport, Manhattanville and Adelphi and the Lady Friars won all three games by scores of 5-1, 3-2 and 4-1 respectively. Leading the team in scoring was senior co-captain Linda Wage, who had 19 goals and 7 assists. She finished her collegiate career with 94 goals. The second leading scorer was freshman forward Jackie Gladu,
