PC's FATHER RICHARD VAHEY FEATURED ON 'PM MAGAZINE'

'PM Magazine' cohost Sheila Martinez called him "... one jewel of a man, who over the last 77 years has combined some globetrotting foreign missionary work for the Dominican Fathers, with a physical fitness program that has kept him one of the best examples of the saying, 'sound mind, sound body.'"

Father Richard Vahey, O.P., an avid sports fan whose "secret love" is the PC girls' hockey team, was the subject of a recent segment of the Group W, Westinghouse Production, which aired Feb. 2nd on WJAR-TV 10, Providence. During the eight-minute feature, Father Vahey was shown doing what he does most everyday at Providence College — saying morning mass at Guzman Hall, jogging around the PC campus, and finally, teaching students how to skate in Schneider Arena. An informal recruiter for the women's hockey team, Father is proud to say that he has taught skating to over 350 students in the last five years.

Besides devoting countless hours to instructing PC students, Father has organized a program to teach the handicapped children of Meeting Street School, with the assistance of some 20 PC students.

Prior to coming to Providence College in 1970, Father Vahey headed the Dominican Foreign Mission Program in New York.

"I can't tell you how much I've enjoyed being here", Father said during the televised interview.

"PC students are really fabulous people who have tremendous concern and compassion for others."

"My philosophy is that I should help others not only spiritually, but mentally and physically," Father concluded.

NEW CAMPUS SERVICES CREATED FOR STUDENTS

Returning to campus following the Christmas vacation, PC students were greeted by two new campus services. First, a new shuttle bus service, designed for transporting students to their off-campus apartments during the evening hours, has been established for the safety and convenience of these students. A 15 passenger bus has been leased by the College and operates five nights of the week from 7PM until 12:30AM. The bus discharges students along its assigned route, and also picks up students who may be returning to campus. Students must show their PC ID card in order to use this service.

Secondly, a new food and variety store (named Store 104), is now located on the ground level of Slavin Center, the student union. The store carries a variety of food products including meat, canned goods and dairy items. The hours of operation for Store 104 are Monday-Friday 11:30AM-8PM; Sunday, 2PM-8PM; the store is closed on Saturdays.

Rev. Thomas R. Peterson, O.P., president of the college, officiated at the short ribbon cutting ceremony on January 19th.

The establishment of these services brings to fruition work begun by the Student Congress three years ago, and also by the Off-Campus Resident Organization.

UPDATE

LOYALTY FUND NEARS \$600,000 MARK IN PLEDGES

With about five months still remaining before its June 30 closing date, the 80-81 Loyalty Fund, by February 3, had already amassed 5,522 pledges totalling \$574,498 and is running more than \$100,000 ahead of last year's record-setting fund on the same date, according to General Chairman Eugene T. Voll '55.

Included in this year's pledge totals are \$441,303 from alumni, \$35,123 from parents, \$33,127 from friends, \$58,325 from corporations and \$6,620 from non-alumni faculty/staff. Last year's fund on February 3 had obtained 4,956 pledges amounting to \$462,332 including \$370,355 from alumni, \$16,758 from parents, \$22,410 from friends, \$44,740 from corporations and \$8,069 from non-alumni faculty/staff. Cash payments this year amount to \$396,864 compared to \$330,137 on the same date last year.

Reviewing the Fund's latest report, Chairman Voll expressed much elation over the results obtained to date. "I'm deeply impressed by the effort of our fund leadership and volunteers and the wonderful response of so many alumni, parents, friends, faculty/staff and corporations so far. Especially gratifying is the response being obtained at all levels of giving, particularly at the special gift levels. This signifies that the needs and merit of Providence College are being recognized more substantially by more people this year and enhances our chances of reaching our \$650,000 goal by June 30."

Adding to Mr. Voll's remarks of praise for fund volunteers and donors, his classmate, Associate Vice President for Development William T. Nero, noted that participation at the special gifts level is substantially higher this year than in past years. Following are the Special Gift results to date and the respective chairmen:

W.F. Brennan, D.M.D. '56, 13 pledges for \$78,228; Chancellor's Club, Hon. A.B. Sciarretta '52 and R.A. DeBlasio '56, 131 pledges for \$72,826; Dean's Club, R.J. Paci '64 and D.J. Ryan '69, 353 pledges for \$88,250; Century Club, C.M. Borkoski '71 and P.M. Lenahan '72 1,273 pledges for \$135,052.

Also doing very well are the Golden Anniversary Class of 1931, led by George A. Kenny and the Silver Anniversary Class of 1956 led by Arthur O. Aloisio and Paul J. Fournier. The Class of 1931 has to date obtained 37 pledges totalling \$6,205 and the Class of 1956 has 109 pledges totalling \$19,422.87

Having completed its special gift phonathons, the 1980-81 Fund is now midway through the regional phonathon phase and meeting with a high degree of success. 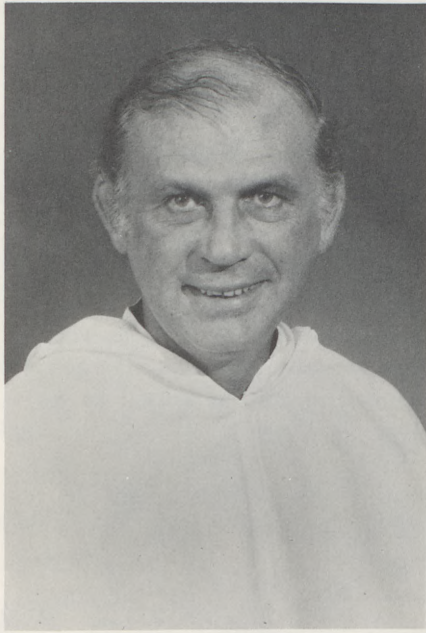

FACULTY NOTES



The resignation of **Rev. Francis C. Duffy, O.P.** vice president for student services, has been accepted by V. Rev. Thomas R. Peterson, college president. Fr. Duffy, resigning for health reasons, served in that position since 1970 and was responsible for overseeing the athletic department, the resident offices and the student services office. Until a successor is chosen, Father Peterson will assume the responsibilities of the vice presidency and Rev. John G. McGreevy, assistant to the president, will act as liaison between the president and the student service organizations.

Michael D. Spiegler, associate professor of psychology, participated as a major speaker at the Third National Institute on the Teaching of Psychology to Undergraduates, held in Clearwater, Florida last month. As a member of the core faculty which consisted of nationally-recognized experts in the field, Dr. Spiegler was selected to make two presentations and to deliver the closing address, entitled "Can You Teach Anybody Anything?"

Alice Hauck of the art department has accepted an invitation to write two essays for the forthcoming *MacMillian Encyclopedia of Archi-*

texts, a comprehensive, multi-volume collection of biographies of architects, written by eminent international scholars. She will contribute essays on two Englishmen — Edward Pugin, architect and Edward Lacy Garbett, architectural theorist.

Assistant Political Science Professor **William E. Hudson** has authored an article, "The New Federalism Paradox," which will appear in a book edited by John G. Grumm and Steven Wasby, entitled, "*The Analysis of Policy Impact*," due for publication by D.C. Heath and Company.

The Council on Social Work Education, a national accrediting body for professional education in social work, has selected **Peter Salvatore**, associate professor in the social work division, as a site visitor for the council's commission on accreditation. He will participate in a training program to be held in Louisville, Kentucky next month.

Dr. James Carlson and **Dr. Mark Hyde** of the political science department collaborated on an article entitled "Personality and Political Recruitment: Actualization or Compensation?" which was published recently in the *Journal of Psychology*. Dr. Carlson also presented a paper on "The Effects of Winning and Losing on Candidate Image," at the annual meeting of the Southern Political Science Association held recently in Atlanta.

After acting as chaplain to english speaking pilgrims at Lourdes and in Israel, **Fr. Giles Dimock** spent the fall semester studying and teaching at the University of St. Thomas in Rome (The Angelicum). Father also wrote an article "Liturgical Meanderings" on the state of liturgy in Europe, which is being published in *Sacred Signs*, a revived quarterly of liturgical art.

Dr. Mary Anne Sedney of the psychology department will present a paper — "Conceptual and Methodological Sources of Controversies About Measuring Androgyny," at the American Educational Research Association's conference to be held in Los Angeles in April.

Dr. Charlotte O'Kelly, director of the sociology division, has been requested to prepare a review essay on cross-cultural studies of women's statuses, for *Contemporary Sociology*, a journal of book reviews for the American Sociological Association. Next month, Drs. Sedney and O'Kelly will attend the annual meeting of the Association for Women in Psychology to be held in Boston, and present their collaborative paper on "Social Structure and Sex Roles: Structural Considerations."

W.A. HINNEBUSCH, O.P. 1909 - 1981

William A. Hinnebusch, O.P., former professor of history at Providence College, died January 12th in Madeira, Ohio. He was 72.

A 1930 alumnus of Providence College, Fr. Hinnebusch was ordained a Dominican priest in 1935. He held the degree S.T. Lr. (Lector of Sacred Theology) from the Dominican House of Studies and a Doctorate in Philosophy from Oxford where he studied medieval history.

The Pittsburgh native was a professor of history at Providence College from 1939 to 1950 and at the Dominican House of Studies from 1956-1978.

The Dominican historian contributed to numerous academic publications and authored a two-volume history of the Dominican Order.

He was a member of the Catholic Historical Association, the Medieval Academy of America, the Rhode Island Historical Society and the Thomistic Institute. In 1969 he was awarded an honorary Doctor of Humane Letters degree at Providence College's 50th Anniversary Convocation.

Fr. Hinnebusch is survived by two brothers who are Dominican priests and three sisters who are Dominican nuns.

A Mass of Christian Burial was held on January 15th at St. Gertrudes's Church, Madeira, Ohio.

JERRY SCOTT . . . Satisfied, Successful, But Still Striving

It's said participation in athletics does not build character . . . it shows it. However, athletics can sometimes overshadow the importance of an education. This is not the case of Providence's senior swingman, Jerry Scott.

Scott came to the Friars from Cambridge (Mass.) Rindge Tech where he established himself as one of that school's most outstanding basketball players. While there, he captained the team his junior and senior years, was a three-time Boston All-Scholastic choice, All-American honorable mention in his junior and senior years and held the school's all time scoring record — until Pat Ewing came along to break it — basically an "all-world" candidate.

These are all statistics the truly enthusiastic Providence College basketball fan probably already knows. What one probably doesn't know is that Jerry Scott was an honor student in high school and was recruited by several Ivy League schools.

"I was in a college preparatory honors program in high school, but it wasn't that good in so much that it didn't fully prepare me for college academics," Scott related. "People are probably wondering why I didn't go to Harvard. Well, at that time of my life all I really thought about was playing professional basketball. I knew Harvard didn't have a real good team and therefore it wasn't a stepping-stone to the pros. Coming out of high school, I thought for sure I was going to be a pro. I knew that if I wanted to play in the NBA I first had to play in a "big-time" college program — that's why I shrugged off the Ivy League," said Scott.

"That's the trouble with young high school ball players today. Most think they're going to play in the

NBA. But what we're dealing with is 23 teams and, say, 11 spots on a club — the averages are against them. I'd like to recommend to these youngsters to be more academically aware at the outset of their career."

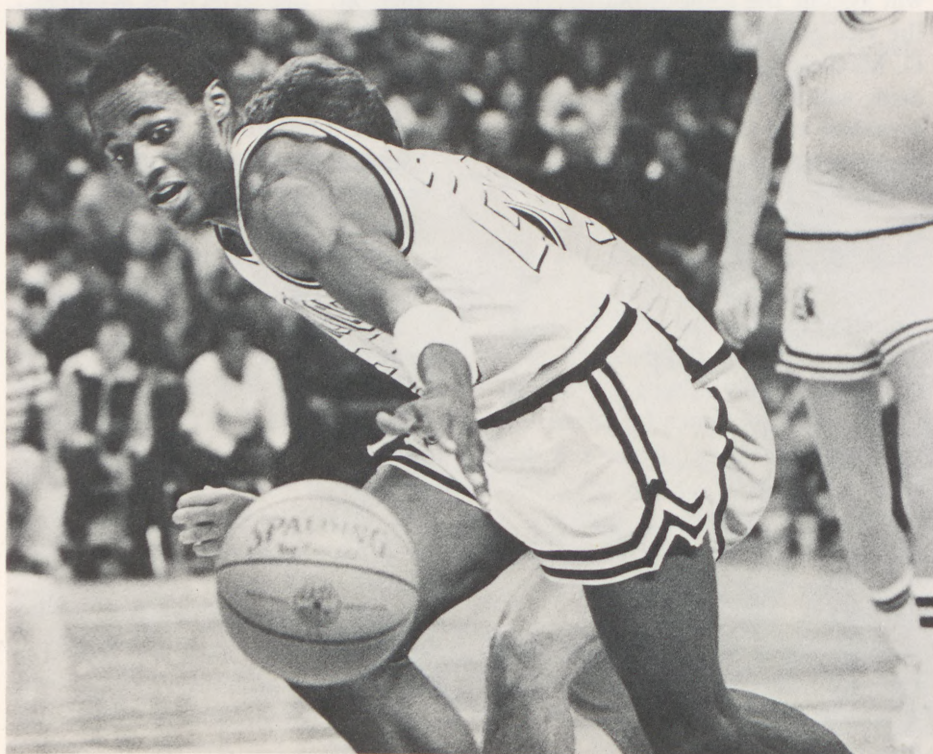
Upon arriving at PC, Jerry was somewhat disillusioned. He encountered adjustment difficulties and had trouble developing a base. "I was originally declared a Sociology major, but soon discovered the avenues to a job were not available. I changed majors at the end of my sophomore year and enrolled in the business program as a management major. I was behind so far as business courses go, and was very unsure of myself. Then I met Mr. (Anthony) Rocchio (Providence College Athletic Academic Advisor) in my junior year. He has played an important role in my academic life, as well as getting my feet on the ground."

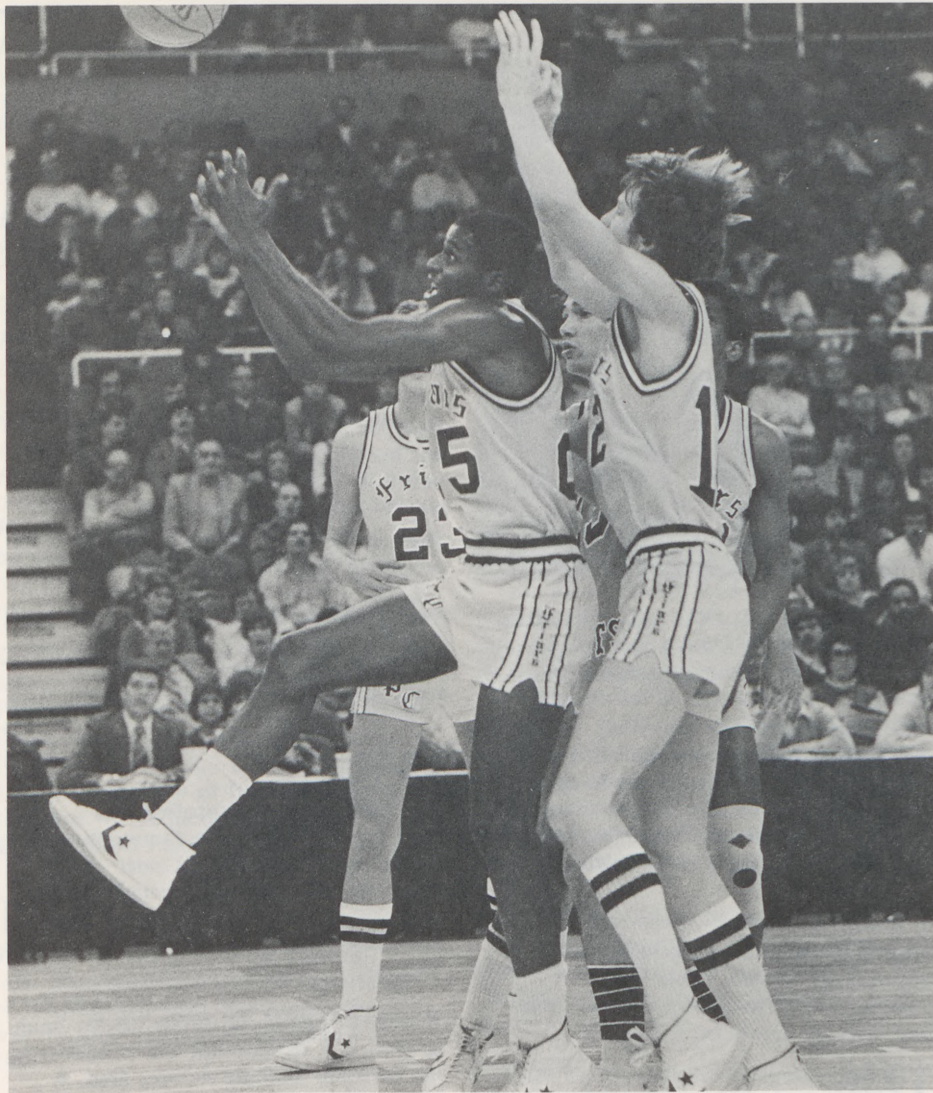
Rocchio perceives Scott this way:

"Jerry now realizes his development and self worth come from more than just playing a game. While in one sense Jerry may have missed great opportunities in "The Ivies", the down-home informality and intimacy of PC has worked in his favor."

Scott readily agrees, "I am very satisfied and contented here at Providence. I've had the chance to play "big-time" basketball, which I always dreamed of, had the opportunity to travel, gain national exposure as a basketball player and meet people who might be able to help me later in life in my career. Let's face it, I've had the opportunities a lot of other guys will never see."

Scott, a 6-3, 195-pounder who led the Friars in scoring last year, is a very "down to earth" young man. Rocchio says: "Jerry is filled with questions about life. For someone like Jerry, with his quizzical mind, the possibilities for the future are





limitless. Jerry is most himself in the center of a philosophical discussion."

Steve Regan, PC's senior team manager who has known Scott since they met in their freshman year, says: "He (Scott) is one of the most personable guys I've ever met. Dip (a nickname Scott acquired from his teammates for the way he dips and glides through defenders) is a really nice guy. We've become close friends."

Scott has made various contributions to the Providence College basketball program. In the Inbank Classic, he's made the all-tournament team his sophomore, junior and senior years and was the tournament's Co-MVP last year. This past December he set a tourney record with 41 points against Michigan State. He's had several game-winning baskets. This is all coming to an end, however, and

Jerry anxiously awaits life after basketball.

"I was fortunate and blessed to play this game," he says. "I was blessed with some natural ability and physical talent.

"But I had to work on my game. Now I have my heart set on going to graduate school to earn a MBA — something I never dreamed of two years ago. If I'm not accepted upon graduation, I'll work and take night classes so I'll be in there the following year."

Friar coach Gary Walters says: "Jerry is an integral part of our team. He carried the load offensively for us in the first half of the season. I strongly hope Jerry continues to further himself as a person."

Jerry Scott will leave a lasting impression on the Providence College scene . . . and not just as a former basketball player.

ANNE M. MULLANEY

Anne M. Mullaney, wife of Joseph A. Mullaney, head basketball coach at Brown University and PC Basketball coach from 1955-1969, died suddenly on January 30th.

A native of Flushing, N.Y., she was a daughter of the late John and Helen (Kelleher) Zipp, and lived in Providence for 12 years before moving to East Greenwich five years ago.

A member of Our Lady of Mercy's parish council in East Greenwich, she was a territorial representative of the council and a member of both the CYO group and the liturgical committee of the church.

Besides her husband, she is survived by a daughter, Mary Ellen; and four sons, Joseph A. Mullaney, Jr., the women's basketball coach at PC, John A. Mullaney, a student in Catholic University Law School, Arlington, Va., Paul A. Mullaney, a senior at PC, and Thomas A. Mullaney, a PC sophomore.

A concelebrated Mass of Christian Burial was held at Our Lady of Mercy Church in East Greenwich on February 2.

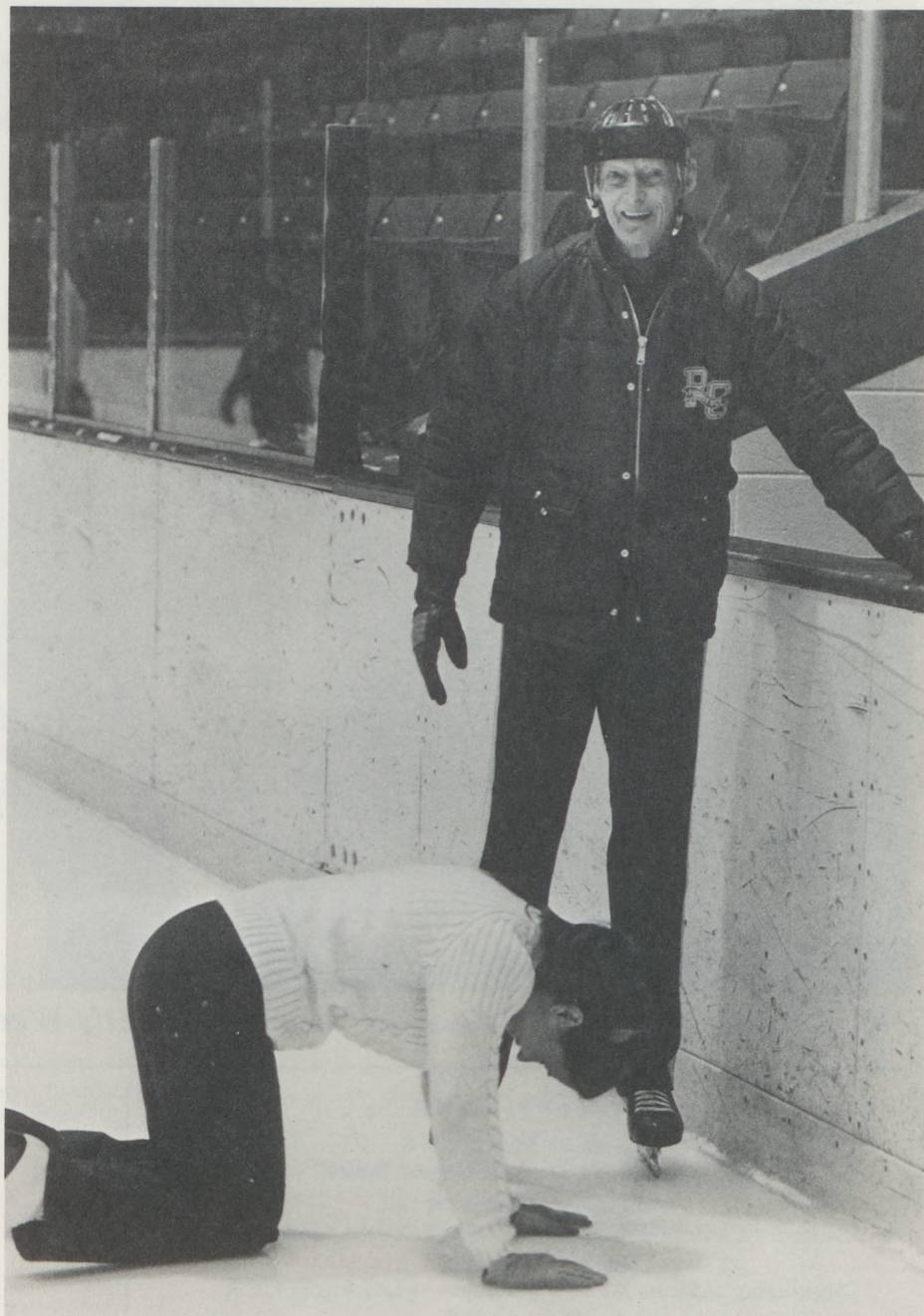
PC HOSTS (AND WINS!) FIRST ANNUAL ALUMNI VOLLEYBALL TOURNAMENT

The First Annual Alumni Volleyball Challenge Cup Tournament was held at PC's Alumni Gymnasium on December 5th. The event was the result of much planning by a committee comprised of representatives of the six participating institutions: Brown, Cornell, Harvard, Holy Cross, Notre Dame and Providence. The combined alumni fund raiser event brought in scholarship money donated by supportive alumni families for each participating institution. The distinctive Challenge Cup was sponsored by the Cornell Club of Rhode Island and South-eastern Mass.

The round-robin tournament lasted four hours, with PC emerging the winner, scoring victories over Brown and Notre Dame in the first eliminations, and again beating Brown 3-1 in the best-of-five finals. TUITION, ROOM & BOARD INCREASED: UNCERTAIN FORECAST FOR FED'L AID

Very Rev. Thomas R. Peterson, O.P., college president, has announced that tuition for all full-time undergraduates will be increased by \$650, effective next September.

The increase will bring the yearly tuition rate to \$4,592, or an increase of 16.48 percent. Also the cost of room and board will be raised by \$350 for the 1981-82 academic year, bringing that total to \$2,900.

In a letter to students, Fr. Peterson attributed the increase to "the impact of severe inflation and the spiraling costs of heat, light and power." He also pointed out that two years ago, students agreed to a \$250 tuition increment in order to construct the new recreation center. That \$250 is included in the \$650 tuition increase.

Father Peterson said there is no way to forecast what changes will be made in federally assisted programs, but that he will make every possible effort to increase the college's budget for student financial aid.
