Fund "Storms" Country on Road Campaign

In early December, Providence College embarked on its regional effort, the second leg of its 1981-82 Loyalty Fund campaign. After having amassed 790 pledges for \$157,706 in the campaign's gift phase, Providence College officials took to the road.


Over the past eight weeks, kickoff events have initiated local campaign activity in such areas as Metro-New York City, Boston, No. New Jersey, St. Louis, Minneapolis and Chicago.
Response to the call of regional co-chairmen to area alumni has

been overwhelming.

On one stormy Saturday afternoon in January, 65 phonathon volunteers from the Greater Boston area huddled in Philomanthia Hall on the Boston College campus and solicited 182 pledges for \$7,785.00.

As the campaign roamed far north from its cozy New England setting, volunteers trudged through 30 inches of snow, braved subzero temperatures and gathered in Co-Chairman Richard Cesario's office in Minneapolis to solicit 33 pledges totalling \$950.

Rev. Adrian Dabash, O.P. Appointed Chaplain



Rev. Adrian G. Dabash, O.P., has been appointed Head Chaplain succeeding the Very Rev. Thomas Ertle, O.P., who was elected prior of PC's Dominican community last November.

A 1961 graduate of PC, Fr. Dabash received his MA in

Philosophy from St. Stephen's College, Dover, MA, and studied for the priesthood at the Dominican House of Studies in Washington, D.C. He was ordained at St. Pius Church, Providence, in 1971.

Assigned to PC in 1966 as an instructor of art, Fr. Dabash holds MA degrees in Theology/Liturgy (St. John's University, Collegeville, MN) and Art/Painting (University of Dallas), as well as the MFA degree in Painting (University of Dallas).

He has served as moderator of both the Art and Yoga Clubs of PC, and since 1974, as assistant director of campus ministry.

Fr. Dabash has also been active in prison reform and rehabilitation, serving as art program director at the Adult Correctional Institution and as an art instructor volunteeer for the Ocean Tides Program in Narragansett.

Associate Vice President for Development William T. Nero praised the regional co-chairmen and volunteers noting, "the key to our regional success has been the enthusiastic participation and endearing spirit of our alumni in supporting its alma mater during the most critical phase of its campaign."

General Chairman, Anthony Sion, Jr., '56, also expressed his highest regard for the regional co-chairmen and volunteers saying, "their attitude reflects the general sensitivity and family unity that continues to pervade the Providence College student body even today — that sense of self-sacrifice to benefit the majority, which is in this case, the entire PC community."

Regional phonathons have proven to be a boost in the arm to the Loyalty Fund campaign, enabling brother and sister alumni throughout the country to give of their time as well as their money. In addition, numerous area receptions have helped to stimulate school spirit and rekindle fond memories of campus life among classmates.

Mr. Nero interjects, "there is a certain sense of camaraderie when fellow alumni exchange greetings at a phonathon. As long as we continue to reacquaint our alumni with that spirit, I'm confident that the Providence College endeavor will prevail."

Of the \$626,954 in pledges recorded to-date, 1,071 pledges totalling \$53,631 have been obtained through regional phonathons. With 11 regional phonathons remaining, it is anticipated that an additional \$50,000 in pledges will be raised through the efforts of regional volunteers.



PC Press Publishes Fr. McGlynn's Biography

Providence College Press has published a limited edition volume on the works of the late Rev. Thomas McGlynn, O.P., an internationally acclaimed Dominican sculptor and former professor of art at PC. Entitled "Thomas McGlynn, Priest and Sculptor," the volume features 120 of Fr. McGlynn's works, spanning 58 years of his life. Fr. McGlynn died in September, 1977, at the age of 71.

Ordained in 1932, he studied art at the New York School of Design and received his diploma in sculpture from the Royal Academy of Fine Arts, Rome. As a student at the Royal Academy, Fr. McGlynn became associated with Carl Milles, the Swedish sculptor noted for his fountain and garden statuary, and later studied with him at Cranbrook, Michigan.



From 1937-1956, Fr. McGlynn continued to develop his skills as a sculptor while teaching art at Providence College (and other colleges and schools) and doing apostolic work for the Dominican Order throughout the United States. His experiences during four years as Director of the Blessed Martin Interracial Center in Chicago prompted him to write the play, "Caukey," which was produced off Broadway in 1944 by the Blackfriars Guild.

PC Community Honors Fr. Masterson with New Business Center

On December 3, PC faculty, alumni, students and friends gathered in Koffler Hall to honor "priest, educator and humanitarian," Father Edwin I. Masterson, O.P. The occasion marked the dedication of Room 103 as the Masterson Business Center.

Father Masterson graduated from PC in 1928, earned his Masters degree from Catholic University, and after being ordained a Dominican priest in 1935, returned to PC to teach. He served as chairman of the business department for almost 30 years. An honorary member of the college Corporation, Father received honorary degrees in 1958 (Master of Arts) and 1963 (Doctorate of Business Administration) and in 1970 was named Professor Emeritus of the business department.

The new center, located in Koffler 103, will house the business department's computer terminals and be used for special seminars.

College President Thomas R. Peterson, O.P., presided over the ceremonies, with addresses offered by Joseph C. Prisco, chairperson of the dedication committee, and Rev. John B. Davis, O.P., assistant to the President.

To conclude the event, a charmed audience then listened to Father Masterson offer a few words of thanks, wisdom, and of course, humor.



The 1981-82 Loyalty Fund, with five months remaining before the June 30 closing date, has already received \$495,432 in general alumni pledges; \$41,634 from parents; \$40,935 from friends; \$32,768 from corporations and \$16,185 credited to non-alumni faculty/staff. Augmented totals in three categories reflect 5,909 pledges for \$626,954.

At this same time last year, the augmented totals reflected 5,522 pledges totalling \$574,498. This included \$421,600 from alumni, \$29,805 from parents, \$33,127 from friends, \$58,325 from corporations, and \$6,620 from non-alumni faculty/staff. The total amount received is \$449,249 versus \$396,864 paid at the same time last year. This reflects approximately 65% of the total goal of \$700,000.

The Loyalty Fund will move into the class solicitation phase with phonathons for every class scheduled at Providence College between April 5th and April 16. Chairman Sion urges all prospects to forward their pledges as early as possible to minimize the large number of phone calls that the phonathon volunteers will be making.



Otis Thorpe: He's Come Shining Through

He was labeled by former PC head coach Gary Walters as a "diamond in the rough." He was untested and unproven. But the potential existed. All he needed was time. Otis Thorpe has lived up to the color, cut and clarity of a true gem

Otis Thorpe is a late bloomer. He never started playing organized, competitive basketball until his junior year of high school. "I was urged by my cousins and the junior varsity coach to try out for the varsity," Thorpe said.

He played his first 17 games with the junior varsity to gain experience, but was elevated to the varsity for the last 10 games—and what a welcome addition he was. He averaged 10 points and 10 rebounds in that stint for Lake Worth (Fla.) High School. For his efforts, he was rewarded with the coaches award for the most productive player.

During that summer he grew in size—from 6-6 to 6-9— and added 15 pounds to his already muscular

200 pound frame. Otis attributes it to ordinary growth and by "eating a lot."

"In my senior year, the varsity coach started by teaching me more about the game. He taught me about blocking out and being in the right place at the right time. He also put us on a conditioning program that included weight lifting and a lot of running," Otis said.

In his first three games as a senior, the big guy from Boynton Beach, Fla., was averaging 12 points and pulling down 14 caroms off the glass. He was soon up to 19 points and rebounds per game. Before the end of the season he had scored 40 points in a game twice, and at season's end he averaged 21 points and 19 rebounds per game.

"A lot of small schools were watching my progress and my coach gave me the advice to go to junior college to refine my basketball skills," the big center recalls.

"I received some letters from PAC-10 schools—Washington State, Oregon, and other like University Nevada-Las Vegas and Louisville. But I never answered them. I never really thought about college. I didn't have the confidence in myself," Thorpe related.


Then the transformation. The opportunity for a scholarship and a possible career on the horizon. "During my junior summer, I went to a basketball camp in New Jersey and Princeton head coach Pete Carril (who coached Gary Walters while he was in school at Princeton) was there and he contacted Coach Walters. Coach (Steve) Hocker came down to see me play," Thorpe said.

Thorpe wanted to go to a college with a small campus that had a rich basketball tradition. Providence fit the bill nicely.

"PC gives me the opportunity for a good education and a chance to earn a degree," Otis said.

His freshman year in college was both a learning experience and a productive year on the hardwood.

"I wasn't used to studying. It was






different because I was all on my own-independent. The only thing to fall back on was a phone call or write a letter to a friend. That made me feel better about things, but it wasn't the real thing," Thorpe revealed.

Like being home. "At certain times, I'd feel down and I knew I couldn't go home. At Christmas I was glad to go home and see family," he added.

He found round ball practice difficult at first, but soon adjusted. "I wasn't used to all the yelling. But things just worked out for me. I adjusted to practice and tried to improve my ability on the court. I'll always remember my first points in college ball because it was a dunk against UMass," "O" said with a smile. forward to continued improvement



"Towards the end of the season, I developed more confidence in my ability and things fell into place," he said. And that they did-Otis Thorpe finished the season averaging just over nine points per game and five rebounds, good enough for All-Rookie team honors in the BIG EAST Conference.

How does Otis view his role on the club? "First, I want to work hard at what I'm doing-hit the boards, play good defense and get some points. Everyone thought at the outset of the season everything would circulate around me, but they didn't notice that we had outside shooters, also," the soft spoken young man said.

Coach Joe Mullaney looks

from Thorpe. "Otis has to provide the bulk of the rebounding. He exhibited more intensity in the past couple games, especially against Georgetown. We hope he can sustain that intensity night in and night out," Mullaney said,.

You might say that Otis Thorpe has come a long way. He has matured. He's aspiring. "I think about school a lot because I want to get my degree, so I can fall back on something if basketball isn't there. I try not to let basketball get in the way of school," the likeable Thorpe said.

His heart is as big as his mitts. He wants to make something of himself. And, after all, doesn't aspiration flow from the heart?



Pope John Paul II has named Bishop Thomas C. Kelly, O.P., General Secretary of the National Conference of Catholic Bishops and United States Catholic Conference, new Archbishop of Louisville, KY.

A 1953 graduate of PC, Archbishop Kelly succeeds Archbishop Thomas J. McDonough, who resigned as Archbishop of Louisville last September.

Ordained in 1958, Archbishop Kelly holds a licentiate in theology from the Dominican House of Studies in Washington and a doctorate in canon law from the University of St. Thomas in Rome. He has also done graduate work a the University of Vienna and Cambridge University. From 1962 to 1965 he was secretary in the office of the provincial of the Dominicans' New York province. At that time he also worked with the tribunal of the New York Archdiocese. He joined the staff of the Apostolic Delegation in Washington, D.C., in 1965 and served there as secretary and archivist until he became NCCB Associate General Secretary in June, 1971.

He remained in that position until his election as General Secretary of NCCB and USCC by the conferences' administrative committee and administrative board in February, 1977. The following July, Pope Paul VI named him Titular Bishop of Tusuro and Auxiliary to the Archbishop of Washington. He was ordained a bishop August 15, 1977, at the National Shrine of the Immaculate Conception.

As General Secretary, Archbishop Kelly has served as chief administrative officer of the U.S. bishops' canonical organization, NCCB, which collaborates on matters of shared pastoral concern, and of the Catholic Church's principal national level action agency, USCC, which conducts programs in education, social development and world peace, communication, and other fields.

He was awarded the Benemerenti Medal for service to the Church in 1971 and is the recipient of honorary degrees from several institutions of higher education.
