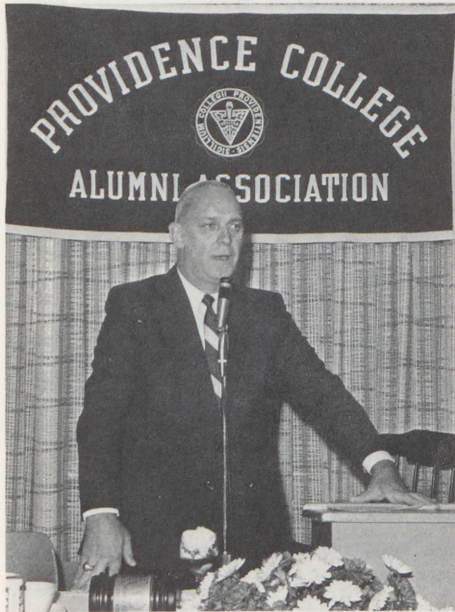

## **New Home for Performing Arts a Welcomed Addition!**

Since its opening in 1919, Harkins Hall auditorium has served a variety of purposes. It was once the gymnasium . . . the cafeteria . . . the main lecture hall . . . and the bookstore. Recently, it has been the site for theatre arts productions; however, the theatre department's use of the auditorium has been somewhat constrained by poor acoustics, frustrating lighting conditions and an inadequate performing area.

All that was changed during the summer, when the College invested over \$200,000 to transform the auditorium into a suitable facility for the performing arts. On October 15th the theatre department staged its first performance in its new home — "The Blackfriars Theatre," opening its 14th season with a modern version of William Shakespeare's "A Midsummer Night's Dream," directed by Mary G. Farrell.

Designed by Dana Newbrook of Robinson, Green and Beretta Corporation of Providence, the new theatre has 256 cushioned chairs

## **Leadership Dinner Launches LF Campaign**

Over 350 invited guests visited the campus on October 16th for the annual Leadership Dinner, which officially launched the 1982-83 Loyalty Fund drive and Alumni Association program. A series of afternoon seminars on topics ranging from the College's admissions and financial aid policies to future curriculum development, preceded the dinner in Raymond Hall. Alumni President John Martinelli '65 served as toastmaster for the evening Leadership Dinner and outlined key objectives for the Alumni year.

William Nero '55, the College's acting vice president for development, reported that the 1981-82 Loyalty Fund - under the inspired leadership of General Chairman Anthony Sion '56 - raised a total of \$784,902 and set a new record for dollars raised and percentage of participation: 42 percent. Bill cited several chairpersons for exceptional performance, and individual plaques

were on display for the following leaders of the 1981-82 fund:

**Special Gift Clubs** - Maurice C. Paradis '58 led the Associate Chairman's Club to the largest increase in donors and dollars raising \$78,784 from 31 donors.

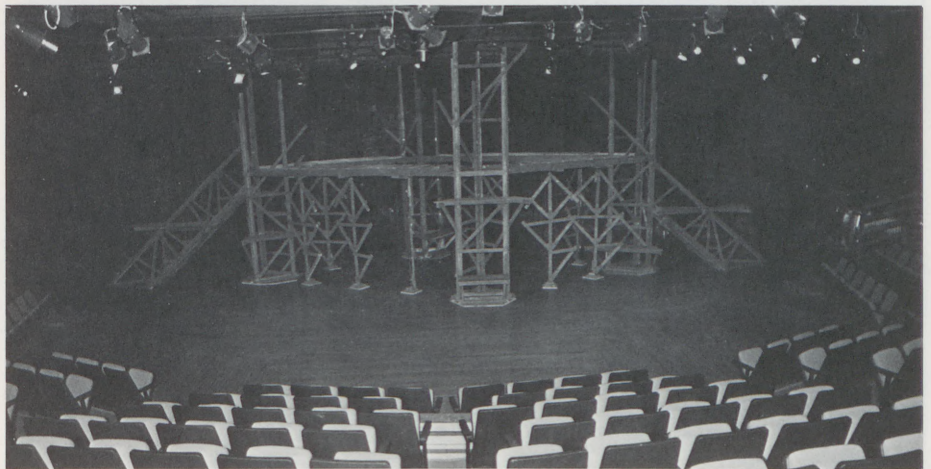
**Leading Class Percentage** - Very Rev. Vincent C. Dore, O.P. for the 3rd straight year led the pioneer class of 1923 to 100 percent participation.

**Leading Class-Donor Percentage Increase** - The Class of 1945 led by Dr. John Parrillo raised participation from 47 percent to 60 percent.

**Leading Class-Dollars Contributed** - Chairmen Francis Carey '55 and Dr. Francis D'Allesandro led the class of 1955 to another pace-setting class total of \$30,780.

and William Frain '63 had a 66 percent participation level.

**Leading Region-Highest Increase in Donors** - The Rocky Mountain States region went from 36 percent to 47 percent participation led by Donald McDonald '52 and Wilfred Paquin '55.

**Leading Region-Increase in Dollars** - Northern California led by Al Foley '62 and Bill Godbout '64 increased their results by 92 percent jumping from \$4,875. to \$9,356.

In his closing remarks Bill praised the outstanding leadership provided by Sion, who was presented a P.C. chair and an engraved gavel as a token of the College's gratitude. Sion eloquently thanked all volunteers and the College's staff who made it possible to set a new Loyalty Fund record. He then symbolically passed the Chairman's gavel to Maurice C. Paradis '58, who will direct the 1982-83 Loyalty Fund effort as General Chairman.

Mr. Paradis joined in lauding Mr. Sion and the 1981-82 volunteer leadership and graciously accepted the task of directing the drive for the largest Loyalty Fund goal ever, \$850,000. "Tony Sion's remarkable achievement this past year will certainly be a difficult act to follow. However, my Associate chairman, Dr. Gus Ramos '50, and I view the coming year and our ambitious \$850,000 goal as an exciting challenge," said Paradis. "I'm confident that the combination of dedicated volunteers, talented professional leadership from the College and hard work will help us not only reach our goal but surpass it."

College President, Very Rev. Thomas R. Peterson, O.P. closed the program by officially extending the congratulations and appreciation of the P.C. community to Mr. Sion, Mr. Paradis and Alumni President Martinelli. Father Peterson also expressed the College's gratitude to all alumni across the country who devote their time to the advancement of the College.

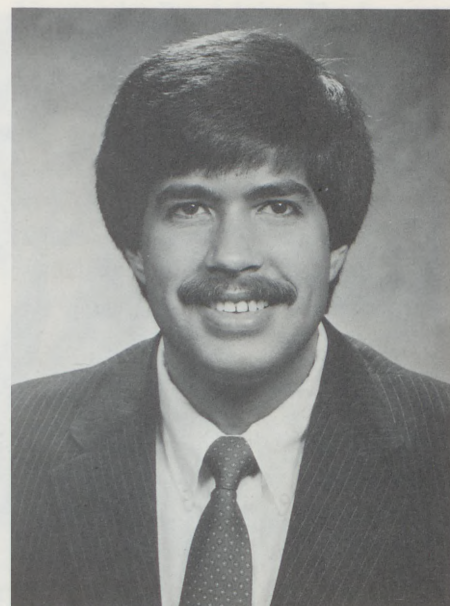

Prior to joining the PC staff, the Barrington, Rhode Island native was an account representative for CommEd Duplicating Systems in Boston.

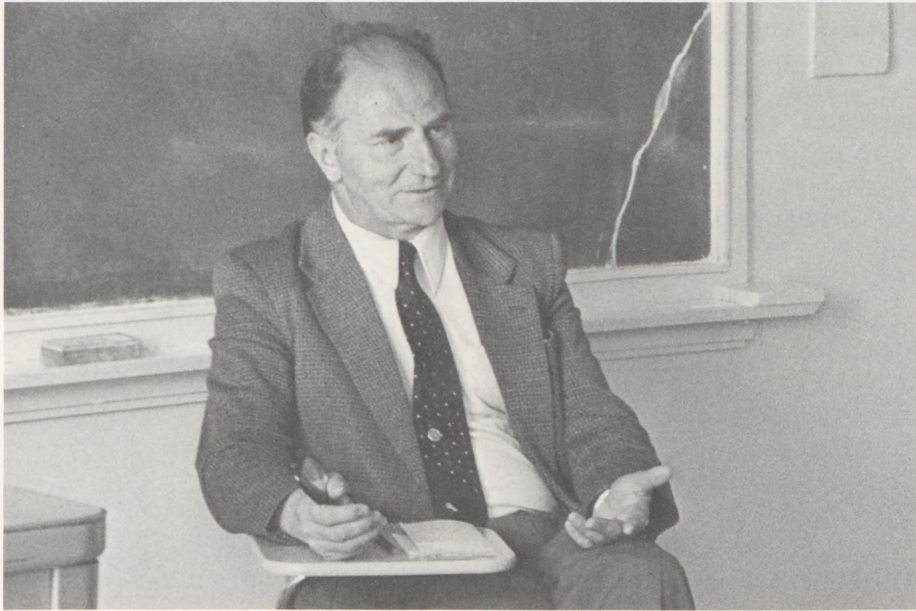

## Students Swap Views with Soviet Editor

Albertas Laurinchukas, editor of the Lithuanian newspaper, *Tiesa*, visited Providence College on September 9th as the guest of Ted Holmberg, a special lecturer in journalism. The visit was part of a New England tour that included a conference of American and Soviet editors held at Colby-Sawyer Col-

lege in New Hampshire and sponsored by the New England Society of Newspaper Editors and the *Boston Globe*.

During an informal meeting with Holmberg's class, Laurinchukas stated that the purpose of the conference was to discuss the different views of the American and Soviet

governments and how this, in turn, affected each country's newspapers. He explained that since all Soviet newspapers are government owned, decisions concerning their content must be made in accordance with government regulations. However, in relaying his own feelings about journalism, he stated, "In journalism, if you can't get in the door then you must come through the window. A journalist has to be pushy and persistent in order to get the story and get it right."

According to Laurinchukas, there are also other differences between the two country's newspapers. Soviet newspapers are generally much smaller (4-8 pages), have little or no advertising and receive most of their revenue through sales with only one organization responsible for their distribution.

In addition to his journalistic ability, Laurinchukas is a published author and playwright. His play, "Last Will," ran on the Moscow stage during September and was followed by the opening of "An Average American Woman" in October.

affixed to sectioned risers which can be moved to change the acting area from a thrust arrangement with the audience sitting on three sides, to an arena set-up with the audience surrounding the stage. A balcony along one side of the hall will now be used to accommodate the hand-capped as well as visiting dignitaries. In addition, absorption material in the ceiling, heavy brown blackout drapes on the windows and carpeting on the risers have helped to minimize the annoying echo problem of yesteryear.

The name "Blackfriars" was chosen because of its tradition linking the Dominican Friars with theatre arts. In the Middle Ages it was a popular name given to the Dominican Friars, who over their white wool tunic wore a black cloak and cowl - for traveling and for cold weather. When the Dominican preachers came to England, they

built a friary or convent near London, which was called Blackfriars. Suppressed at the time of the Reformation, Dominicans and other religious orders used the Blackfriars house - with its large enclosed refectory - for theatrical productions. In 1608 the King's Men, Shakespeare's Company, leased Blackfriars for winter productions.

In our own time, Blackfriars was the name given to the Catholic theatrical group formed by the Dominicans in Washington, DC, in the early thirties. Fathers Urban Nagle and Thomas Carey, both Dominicans, started the Blackfriars Guild, a theatrical group dedicated to writing and producing plays that were both artistically appealing and spiritually challenging. That initial experience in Washington provided the impetus for other Blackfriar chapters in various cities - New York, Boston, Philadelphia, Providence, Pittsburgh, Louisville, Rochester, etc. Another Blackfriars' venture, a summer Institute of the

Dramatic Arts at Catholic University was the seed-bed and the inspiration for the now-famous School of Speech and Drama founded at Catholic University in the late thirties, under the direction of Gilbert V. Hartke, O.P.

When Fathers Nagle and Carey were transferred to New York City, they became the driving force behind the Blackfriars Theatre, one of the first Off-Broadway Theatres. Operating in a small and intimate theatre on West 57th St., the Blackfriars Guild staged its first play in 1941 and remained in continual operation until the early seventies. During this time, the Guild produced over forty original plays, availing itself of the energies and talents of hundreds of New York actors, many of whom went on to outstanding theatrical careers.

## "Seems Like Old Times" - Clark Returns!

Chris Clark is returning as "Voice of the Friars!" Clark will broadcast all 30 Providence College basketball games this season over Radio Station WEAN, it was jointly announced last month by David Garrison, WEAN general manager, and Lou Lamoriello, PC athletic director.

"We couldn't be happier," said Garrison. "Chris is a proven talent, certainly the most recognizable

sports broadcaster in Rhode Island history and, despite being away from the 'mike' and doing PC games for three years, really has always been and always will be the 'Voice of the Friars.' We're happy he's on our team."

Lamoriello echoed Garrison's words. "Everyone at PC is certainly glad Chris is back because we've always felt he's been a part of the Providence College basketball tradi-

tion. When you think about PC basketball, you also think of Chris Clark."

Clark, who will do the Joe Mullaney pre-game and post-game shows in addition to the play-by-play, is returning after a three-year absence. He was the 'Voice of the Friars' for 21 years, from the 1958-59 season through the 1978-79 season. During that time, PC had 17 20-win seasons and competed in the NIT nine times and the NCAA tournament eight times.

Clark is currently in his 12th year as sports director of WJAR-TV, Channel 10 and has been selected the Rhode Island Sportscaster of the Year an unprecedented 17 times.

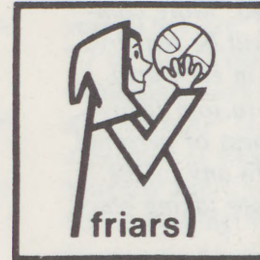

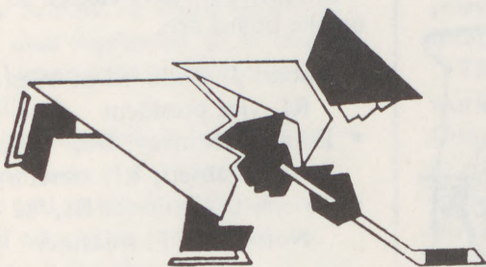

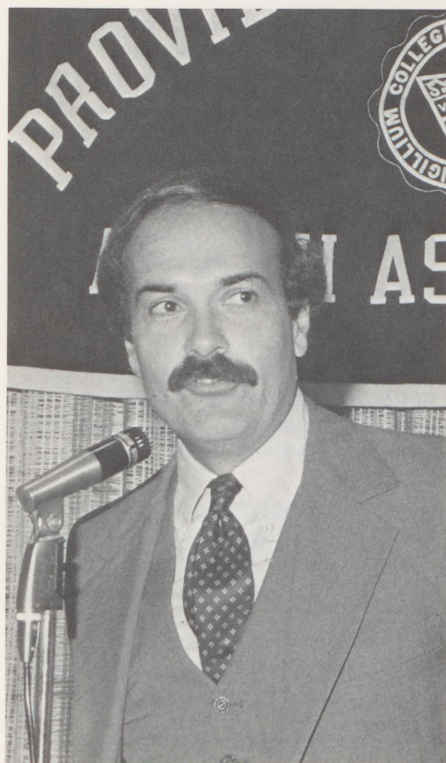

### **Rev. John M. Donahue, O.P. 1928 - 1982**

The Reverend John Matthew Donahue, O.P., professor of theology at the Dominican House of Studies and one of the founders of the Cluster of Independent Theological Schools in Washington, D.C., died September 12 at Georgetown University Hospital after a long illness.

Father Donahue held many important posts in the Dominican Order and in the Washington theological education community. In addition to his faculty post, he was recently Prior of the Dominican House and President of the Pontifical Faculty there. Until his death, he held a position as theological consultant to the Committee on Doctrine of the National Confer-

ence of Catholic Bishops. Previously he had been Secretary to the Dominican provincial superior and Director of Vocations.

Father Donahue was born in Altoona, Pennsylvania in 1928 but grew up in Columbus, Ohio, where he attended Aquinas College High School conducted by the Dominican Fathers. He received his B.A. degree from Providence College in 1950 and was ordained a Dominican priest in 1955. He also held a doctorate from Fordham University.

Throughout his twenty years working in Washington, Father Donahue was active and influential in ecumenical circles. He frequently collaborated with faculty of the Virginia Theological Seminary and the Gettysburg Lutheran Seminary in offering courses in ecumenical theology, and he was among the first to offer a joint seminar with Protestant colleagues when the Washington Theological Consortium was founded ten years ago.
