PC Community Mourns Passing of Beloved Dean, Thomas H. McBrien, O.P.

Reverend Thomas H. McBrien, O.P., 68, a member of the Providence College faculty since 1949 and dean of undergraduate studies for the college from 1974 through August of 1987, died September 9, 1988 at the St. Thomas Aquinas Priory-Graggani Dominican Center on the Providence College campus.

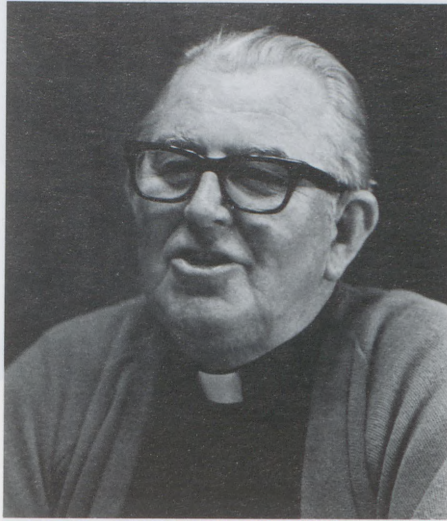
He was a son of the late Hugh and Beazie (McTague) McBrien of Attleboro, Massachusetts.

An Attleboro native, Father McBrien graduated from Attleboro High School in 1937 and received a bachelor of arts degree in classics from Providence College in 1941. Ordained to the Dominican priesthood in Washington, D.C. in 1948, he received his licentiate and lectorate in sacred theology in 1949 and doctorate in theology in 1963 from the Dominican House of Studies-Pontifical Faculty in Washington, D.C.

Assigned to Providence College in 1949 as an instructor in religious studies, Father McBrien was named College Chaplain in 1955. During that same year, he also taught theology at the Newton College of the Sacred Heart in Newton, Massachusetts. In 1963, he was named national director of the St. Thomas Aquinas Foundation in New York City. In this position, he was instrumental in raising over \$1 million to accelerate the work of the Leonine Commission, which was charged with the completion of the critical edition of the writings of St. Thomas Aquinas.

Father McBrien was elected prior of St. Mary's Priory in New Haven, Connecticut, in 1966 and served there until 1969. Named director of administration for the Center for Applied Research in the Apostolate (CARA) in Washington, D.C. in 1970, he served in that position until 1972, when he returned to PC as assistant to the vice president for development. In 1974, Father McBrien was named dean of the college, a position which he held until August of 1987. He resumed teaching religious studies in September, 1987.

Father McBrien served on a number of college committees throughout his



tenure as dean, including the Committee on Academic Rank and Tenure, the Committee and Executive Committee on Studies, and the Committee on Planning. Also a well-known speaker throughout New England, Father McBrien was a member of the American Theological Society, the Society of Catholic College Teachers of Sacred Doctrine, and the Mariological Society of the United States.

Father McBrien was most recently honored by Providence College at the Fall Faculty Frolic in November of 1987, when Rev. John F. Cunningham, O.P., president of the college, said of him: "For all but five years in his life as a Dominican, Father McBrien has served at Providence College. He has given of himself in service to the college's ideals. His commitment has never been less than total whether in the classroom, as a spiritual counselor, or as an academic advisor. And in my own twenty-five years here, I have never known any member of the college community whose concern for students was greater. We honor Father McBrien for what he gave: unswerving devotion to Providence College and her mission."

In 1983, Father McBrien was the recipient of The Very Reverend Vincent C. Dore Award from the college Alumni Association's Mal Brown Club, given to those members of the college community "whose contributions throughout

the years have been many, yet who remain unpretentious in their service."

In June of 1973 Father McBrien returned to his native parish of St. John the Evangelist Church in Attleboro as principal celebrant of a mass commemorating his 25th anniversary of ordination to the priesthood, followed by a reception in his honor.

Father McBrien's body was received in Our Lady of the Rosary Chapel of Providence College's St. Thomas Aquinas Priory-Graggani Dominican Center on September 12, 1988, and the Office of the Dead was chanted by the Dominican Friars. A Mass of the Resurrection was concelebrated the following day at St. Pius Church on Eaton Street in Providence, and Rev. Thomas L. Fallon, O.P., gave the eulogy.

"He was in deed and in word a dedicated pastor of the young persons to whom he ministered," said Father Fallon of Father McBrien.

"As I saw him, he was very tender-hearted, a very sentimental man. He readily experienced empathy and compassion. He shed a tear with many a troubled student," Father Fallon said of his colleague.

"Two days ago, I heard that Father McBrien, as dean of the college, was approached by a student who had lost a serious amount of money, apparently stolen by an unknown fellow student. While being angry and incensed at the immorality of the thief, and chagrined at the stupidity and carelessness of the victim, he still empathized with the victim," said Father Fallon.

"He also gave to her in her necessity his practical love and care: he gave her his own...vacation money to help her in her need. This incident shows to us all his great love for the students and his open trust in their honesty," Father Fallon said.

Father McBrien is survived by his sisters, Miss Gertrude McBrien and Mrs. John McIntyre of Attleboro, Massachusetts, and Mrs. Robert Mullin of Arlington, Virginia; and his brothers, Vincent McBrien of Auburn, Massachusetts and Hugh McBrien of Port Charlotte, Florida.

Newly-renovated Moore Hall is Center for Civ Program

The dedication of Cornelius C. Moore Hall, formerly known as Antoninus Hall, took place on Oct. 22 with more than 250 persons in attendance at a special ceremony held in the newly-renovated facility. The building was named for Cornelius C. Moore, a prominent attorney and civic leader from Newport, Rhode Island, who died in 1970.

Through the generosity of Mr. Moore, and the proceeds secured by the sale of a silver collection he willed to Providence College, the college was able to extensively renovate the hall, which is now the hub of activity for the college's Development of Western Civilization Program.

The new facility contains three lecture halls with seating capacity for between 140 and 180 students, three classrooms, a conference room, a supply room, storage area and administrative offices. An impressive new foyer, with alternating glass and brick work, was also added to the building.

Mr. Moore's silver collection, which included the largest group of Rhode Island silver in a private collection, was auctioned by Sotheby's of New York in January 1986, bringing more than \$610,000 to the college's general fund.

The building took more than one year to renovate, and was opened again to students last spring.

Mario DiNunzio, Ph.D., director of the DWC program at Providence College, delivered the welcoming remarks at the dedication exercises, and PC president, the Reverend John F. Cunningham, O.P., greeted attendees and blessed the building.

The dedication address was delivered by Dr. David Herlihy, a Barnaby Conrad and Mary Critchfield Keeney Professor of History at Brown University.

Dr. Herlihy's address was important in that he talked of the shifting attitudes of historians about western history, and of the role of Western Civilization in American higher education, said Dr. DiNunzio.

Dr. Herlihy has also been Professor of History at the University of Wisconsin and Harvard University. He is the winner of the Guggenheim, Fulbright and other fellowship and academic prizes, and is the author of many books and articles.

The Honorable Francis J. Boyle, Chief Judge, U.S. District Court, a legal associate and close friend of Mr. Moore's, also spoke at the dedication exercises.

Mr. Moore began his private collection of 18th century American silver in the 1940's. It was presented in public display at the Rhode Island Historical Society in 1961 and at the Rhode Island School of Design Museum in 1966.

He had hoped to further share his collection with the public by having a catalogue published; however, preliminary work on such a publication was halted due to his untimely death.

But under the editorial supervision of Alice H.R. Hauck-Beckwith, associate professor of art history, five Providence College students revived the catalogue project in a senior seminar on art historical research methods. In 1981, Providence College, aided by a grant from the Rhode Island Bicentennial Foundation, published the catalogue Mr. Moore had envisioned.

The limited edition catalogue entitled "American Silver 1670-1830: The Cornelius C. Moore Collection at Providence College," is a richly illustrated collection of essays as well as a catalogue of the more than 200 examples of colonial era silver from the New England region.

Since the college did not have an appropriate gallery or museum in which to exhibit the collection during the 15 years it owned it, the corporation voted in 1985 to sell the collection so that more art enthusiasts would have an

opportunity to appreciate and view the works of art.

Mr. Moore's interest in education paralleled his interest in silver. In addition to his special fondness for Providence College, Mr. Moore was also involved in the establishment and maintenance of Portsmouth Priory and School in Middletown, R.I. and Salve Regina College and Vernon Court Junior College in Newport.

Patrick Kennedy Elected RI State Rep

Patrick J. Kennedy, a 21-year-old Providence College junior majoring in philosophy, and son of Senator Edward M. Kennedy D-Mass., won his first bid to become a state representative when he beat a five-term incumbent in the Rhode Island state Democratic primary in September.

Because there was no Republican challenger on the November ballot, winning the primary was tantamount to winning the general election.

Patrick, president of the Young Democrats at PC, is the youngest of the Kennedy clan to be elected to public office, and the first Kennedy to be elected to public office in Rhode Island.

Patrick won 57% of the vote in the 9th State Representative District, which includes the Providence neighborhoods of Mount Pleasant, Elmhurst and Olneyville.

His opponent, veteran legislator John Skeffington, captured 43% of the vote.



Neal Simpson, Ph.D., Assumes Post of Dean of Minority Student Services

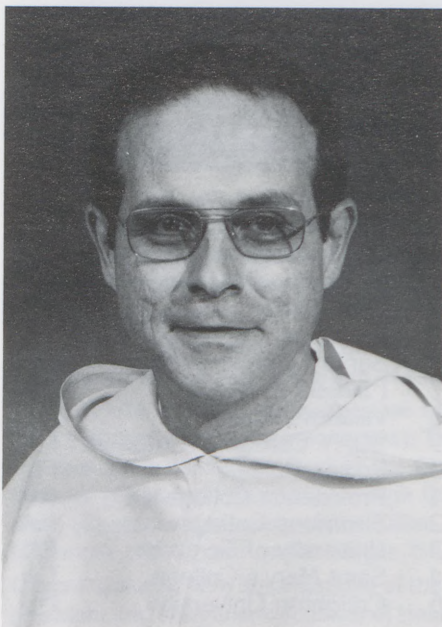
W. Neal Simpson, Ph.D., of West Carrollton, Ohio, has been named dean of minority student services at Providence College, it was announced recently by Rev. John F. Cunningham, O.P., PC president.

Dr. Simpson will be responsible for coordinating, implementing and evaluating programs to promote the academic and personal development of PC's minority students as well as enhancing the awareness and sensitivity of the college community to the particular needs of minority students. He will monitor the academic progress of minority students through the directors of the Martin Luther King and Southeast Asian Student Programs; serve as a consultant to the director of admissions on minority recruitment, and serve as the college's Affirmative Action Officer.

Prior to joining the PC staff, Dr. Simpson served since 1976 in various capacities at Northern Kentucky University in Highland Heights, Kentucky. He was coordinator of the Academic Probation Program for students undecided about a major area of study; and academic advisor/counselor for the University's Advising, Counseling and Testing Center. A native of Hattiesburg, Mississippi, Dr. Simpson also served as athletic director at Wilberforce University in Wilberforce, Ohio and chairman of the Health and Physical Education Department at Wilberforce from 1972-1973.

Dr. Simpson earned his doctor of education degree in 1976 from the University of Cincinnati, and his master of arts degree from Tennessee State University. He also pursued post-doctoral studies at Southern Illinois University.

Rev. John Reid Joins Staff of Student Services



Reverend John J. Reid, O.P., an assistant professor of religious studies at Providence College, has been appointed assistant vice president for student services at PC, it was announced recently by Rev. John F. Cunningham, O.P., college president.

In this position, Father Reid will be responsible for overseeing student clubs, organizations and their activities and will serve as director of Slavin Center, the student union building.

Father Reid succeeds Rev. John McMahon, O.P., who will continue teaching in PC's Education Department.

A native of Brooklyn, New York, Father Reid earned his bachelor's degree in electrical engineering from Polytechnic Institute of Brooklyn, NY, and studied for the Dominican Order at St. Stephen's College in Dover, MA and at the Dominican House of Studies in Washington, D.C. He was ordained to the Dominican priesthood in 1973.

A member of the PC faculty since 1974, Father Reid has also served as chaplain of the college.

Sister Mary O'Keeffe Named to New Advising Post

Sister Mary Daniel O'Keeffe, most recently of St. Anselm's College in Manchester, New Hampshire, has been named coordinator of advising services and pre-law advisor at Providence College, it was announced recently by Rev. John F. Cunningham, O.P., PC president.

She will be responsible for working with faculty and departments to improve their advising, developing materials and programs for improving advising and assisting students seeking information about law school admission.



Sister O'Keeffe had served as director of academic advisement and lecturer in the humanities at St. Anselm's College since 1984. Prior to that she was a graduate assistant for the Department of Education at Boston College's Graduate School of Arts and Sciences. She also served as director of continuing education at Caldwell College, Caldwell, New Jersey.

Sister O'Keeffe received her doctorate in higher education/educational administration and a master's in Latin from Boston College.

PC Ranked 11th Nationwide in *U.S. News & World Report* Education Survey

For the second straight year, Providence College has been ranked among the nation's top colleges and universities in *U.S. News & World Report's* most recent survey of American higher education.

The special report, entitled "America's Best Colleges," was published in the October 10 issue of the magazine.

This year, Providence College has been ranked 11th nationwide in the category of "Comprehensive Colleges and Universities." Each of the 399 institutions across the country in this category enroll more than 2,500 students and award more than half of their bachelors degrees in two or more occupational or professional disciplines.

In 1987, Providence College tied for sixth place in the category of "Best Eastern Comprehensive Colleges in the United States," from a total of 124 such educational institutions.

This year, *U.S. News* combined last year's three regional comprehensive categories into the new overall national category of "Comprehensive Colleges and Universities," thereby creating a much larger competitive arena for PC.

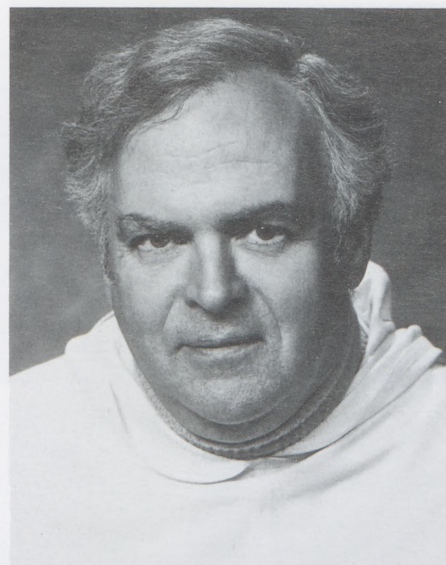
The magazine surveyed 1,337 colleges and universities, dividing the institutions into five categories based upon the most recent classifications of colleges and universities determined by the Carnegie Foundation for the Advancement of Teaching.

Survey results were based on objective data such as the nature of a college's student body as determined by the school's selectivity; the strength of the school's faculty and the per-student size of its institutional budget; the resources available for its educational programs; and a college's ability to see its entering freshman through to graduation.

Faculty Senate Pay Tribute to Rev. Joseph B. Boyd, O.P.

Reverend Joseph B. Boyd, O.P., an assistant professor of philosophy at Providence College for the past eight years, was recently honored by the PC Faculty Senate, and recognized as a model of excellence for fellow faculty members and future educators.

In a Resolution of Appreciation passed by the senate, Father Boyd's love of learning and teaching was described by his colleagues as singular, obvious and contagious; his presentation of philosophy was described as erudite, thorough and engaging; his treatment of philosophers as positive, balanced and objective; his classical knowledge as wide, deep and illuminating; and his attention to routine as precise, detailed and conscientious.

Faculty senate members also honored Father Boyd for putting the needs, aspirations and worries of students uppermost in his mind, and for helping his brother Dominicans in their indispositions. "His eloquent eulogies at their passings has been a hallmark of his presence in his religious community," faculty members stated in the resolution.

Father Boyd completed his undergraduate studies at Providence College as a dean's list student in 1952 and went on to study at the Dominican House of Studies.

He taught philosophy and theology at Ohio Dominican College in Columbus, OH, and at Aquinas College in Grand Rapids, MI, among other institutions, before returning to Providence College in 1981.

1988-89 Annual Fund Drive off to a Strong Start

The 1988-89 Providence College Annual Fund Drive fundraising effort gained strong momentum in November from six record-breaking special gift phonathons during which 240 alumni volunteers obtained more than 2,600 pledges totaling more than \$250,000.

Current estimates have the 1988-89 Annual Fund Drive ahead of last year's pace at this point in time by approximately 600 donors and almost \$150,000.

Led by 1988-89 Annual Fund Drive chairman Kevin Phelan '66, the annual fund is a part of the \$25 million Campaign for Providence College which has been underway since the 1984-85 year.

The long range capital campaign, under the tireless direction of chairman Francis L. Gagnani '40, is entering its fifth year. More than \$22.5 million in pledges for the capital campaign have been secured to date, of which \$15.7 million has been paid.

The regional phase of the 1988-89 Annual Fund Drive begins after the holidays and runs through March. Thirty-three phonathons will be held using local volunteers in cities ranging from New York to San Francisco.

In April, ten classes and three parent phonathons will wrap up the telephone contact portion of the drive. By the June 30th close of the 1988-89 fundraising effort, approximately 850 volunteers will have made more than 16,000 calls on behalf of Providence College.

If the 1988-89 results approach last year's final total of \$3.7 million received in gifts and pledge payments, the capital campaign may reach its \$25 million goal in pledges by June 30th...two years ahead of schedule.

A special five-year campaign report will be mailed to alumni and friends in February.

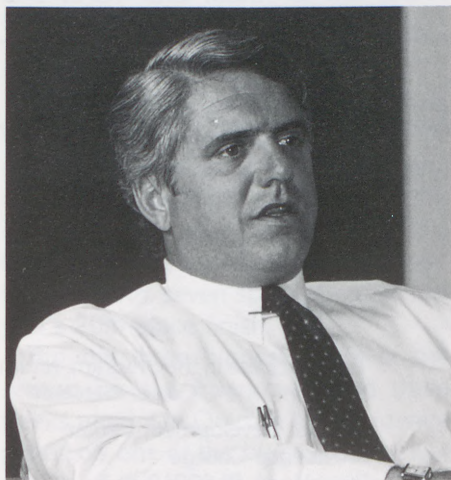

All-American Moloney Highlights Fall Sports Season at PC



Cross country runner Tina Moloney made headlines for herself all fall season, but the Waterford, Ireland native's biggest accomplishment came recently when she finished eighth at the NCAA Championships in Ames, Iowa to become the first female runner at Providence to earn All-American honors.

For Moloney it was the finishing touch on one of the best seasons ever for a Providence cross country runner - a season in which she won the BIG EAST and New England Championships.

As a team, the Lady Friars were also successful as they won the Rhode Island Invitational, the National Catholic Championships and the New England Championships for the second straight year. They also finished second at the BIG EAST and fourth at the ECAC Championships.

MEN'S CROSS COUNTRY

Coach Ray Treacy's men's cross country team was ranked in the Top 10 nationally for most of the season and was ranked as high as sixth. For the second straight year, the team earned a berth in the NCAA Championships, and finished 13th, seven spots ahead of last year's 20th-place finish.

But the three biggest thrills of the season for the Friars occurred three weeks apart. On October 8, Providence pulled off one of the biggest dual meet upsets of the season by beating Dartmouth on its own home course, some-

thing that hadn't been done since 1982. Not only did PC hand the Big Green its first dual meet loss in five seasons, but also extended its own dual meet string to 148, dating back to 1973. Frank Conway (Glenbeigh, Ireland) won the 4.6 mile race in 22:09, just seven seconds off the course record.

Two weeks later Providence captured its seventh BIG EAST crown in 10 years by defeating two-time defending champion Georgetown. The Friars dominated the race, placing five runners in the top 12, led by third and fourth place finishes by Conway and David Burke (Tullamore, Ireland).

A week later the Friars won the New England Championships for the first time since 1983. Conway won the 5.2 mile race in 25:08.

FIELD HOCKEY

After an 18-1-3 record last season, and an appearance in the NCAA Tournament, Coach Jackie Gladu wasn't sure what to expect from her Lady Friar field hockey team in 1988. But Gladu was pleasantly surprised by her squad's performance as it posted a 17-4-3 record and won its first ECAC championship, which was held at Providence.

Although her team did not receive an NCAA bid, the ECAC title ended the season on a positive note. On its way to the crown, Providence posted 1-0 wins over Ivy League foes Princeton and Dartmouth. Debbie Barnhill (Lexington, MA) put the game winner in against Princeton in the overtime period, while Karen Krawchuk (Carle Place, NY), the team's leading goal scorer with 15, put in the game's only tally 14 seconds into the championship game.

The Lady Friars received their share of individual honors as well. Goalie Sandra O'Gorman (Dublin, Ireland) and Krawchuk were named to the Northeast Region First Team, while Cami White (Athol, MA), Providence's leading scorer this season with 10 goals and 11 assists, was a second team honoree.

O'Gorman, regarded as one of the nation's top goalkeepers, had another outstanding season, posting seven shutouts and allowing only 18 goals in 23 games.

MEN'S TENNIS

The men's tennis team was undefeated during the fall season, posting a 7-0 record, and tied for runner-up honors with St. John's at the BIG EAST Championships, behind eight-time champion Boston College.

The Friars put three of their doubles teams in the finals with their No. 1 tandem of Fernando Romero (Key Biscayne, FL) and Andy Garcia (Madison, NJ), winners of last year's New England No. 1 doubles title. They took the honor with a three-set victory over the Pittsburgh team of Larry Garrard and Jeff Mills 6-2, 2-6, 6-3.

The No. 2 team of freshmen Richard Lowther (London, England) and Paul Mandeville (Manville, RI) won their bracket with an easy 6-2, 6-3 victory over Greg Belzberg and Christian Valulis of Georgetown.

Matt DeNucci (East Longmeadow, NJ) and Tim Scanlon (Burr Ridge, IL) lost in the finals of No. 3 doubles in a three-set match to Mike Rafferty and Hiro Takato of Boston College.

WOMEN'S TENNIS

The women's tennis team posted a 5-10 record and finished fifth at the BIG EAST Championships.

Constance Calma (Fairfield, CT) recorded the best overall singles record for the Lady Friars as she finished with an 11-5 record. The rookie tandem of Dana Dourney (Baskinridge, NJ) and Amy Mangano (Gwynedd, PA) finished with a 10-7 record.

MEN'S SOCCER

Coach Bill Doyle's booters were 8-8-1 during a season which was highlighted by a 2-0 win at home against Syracuse, nationally ranked at the time and one of the BIG EAST's strongest teams this season. The Friars started the campaign off strong, but lost seven of its last 10 games.

Senior co-captain Pat Kocourek (Edina, MN) had an outstanding season for Providence as he led the team in scoring with 12 goals and six assists (30 points) and finished second among BIG EAST players in that department. All-

American back Seamus Purcell (Dublin, Ireland) turned in some stellar defensive performances and had one goal and two assists during the season. He was honored by *Soccer America* in early November as its player of the week.

WOMEN'S SOCCER

The women's soccer team finished the season with a disappointing 3-12-3 record. Freshman Leslie Danehy (Coventry, CT) finished as the team's leading scorer with five goals. Senior captain Beth Szostkiewiczy (Holyoke, MA) ended her four-year career tied for the school's career assist mark (18) and finished as the school's third all-time leading scorer with 12 goals and 18 assists.

VOLLEYBALL

Coach Dick Bagge's spikers were 18-23 and finished third at the BIG EAST Championships. In the tournament, Providence won two of three matches with wins over Connecticut and Georgetown.

Sophomore Debbie Matejka (Wan-tag, NY) was named to the All-Tournament Team for the second straight year. She also earned similar honors at the Hofstra and URI Invationals.

GOLF

Coach Joe Prisco's linksters were fourth at the BIG EAST Championships, third at the ECAC Qualifier and eighth at the New England Championships.

The Friars just missed qualifying for the ECAC Championships, but David Croke (Scituate, MA) tied five players for individual honors at the ECAC qualifier to earn an individual berth at the ECACs and finished tied for 53rd. Shane Drury (North Providence, RI) also earned a spot in the ECACs and placed 61st.

Momentum from Midnight Madness carried the new coach and his Friars past a good Cibona team which would leave its BIG EAST tour with wins over pre-season conference favorites Syracuse and Georgetown. But the pre-season game wasn't what Barnes wanted most. What he wanted was the first-ever defense of the Fleet Classic.

He got it, thanks in large part to MVP Mat Palazzi and all-tournament players Marty Conlon and Eric Murdock. Palazzi hit more three-pointers during the two-day tournament than some football field goal kickers earn in a season. Conlon showed bulk and heart as a tough inside scorer and Murdock was ... well ... Murdock. He was terrific offensively, led the team on defense and generally picked up where he left off a year ago as a BIG EAST All-Freshman Team choice.

The winning ways continued with defeats of Brown, Lafayette, Yale and a nationally televised contest with Boston College in the league's first conference tilt of the year. Surely, Barnes and Co. are off and running.

PC '88 Grads Credit Job Search/Career Placement Service for their Success in Achieving Career Goals

During the 1987-88 academic year the PC Student Development Center's Job Search/Career Placement Service arranged 2,892 first, second, or third senior interviews by approximately 114 on-campus recruiters who offered students career opportunities in human services, government, entrepreneurial ventures, small companies, and Fortune 1000 companies. Additionally, 104 senior interview appointments were held by more than a dozen employers off-campus. According to John McGrath, coordinator of the Job Search/Career Placement Service, about 90% of the seniors interviewed are currently employed in career positions.

"We also offer job search services, such as helping students seek out leading companies in their chosen career fields, teaching them how to create resumes and build interview techniques, and affording them the opportunity to take part in our extensive on-campus recruitment program," he continued. "We also work closely with those who wish to pursue advanced degrees as opposed to immediate employment."

The majority of on-campus recruiters, said McGrath, hold executive positions with the employers they are recruiting for, and are often Providence College alumni.

"At the Job Search/Placement Service, alumni are our greatest single asset," explained McGrath. "Recent alumni have been listing job openings with us, answering seniors' questions about interviews and company backgrounds, and encouraging their employers to recruit on-campus. More established alumni have always been the prime factor in why most companies choose to recruit at PC," he said. "We would like to encourage other alumni employers to get involved in our recruitment efforts and/or to make their expertise available in helping seniors make appropriate career decisions. I would be happy to answer any questions from alumni at (401) 865-2305."

The following "job search" stories were written by representative Class of '88 graduates and illustrate the wide

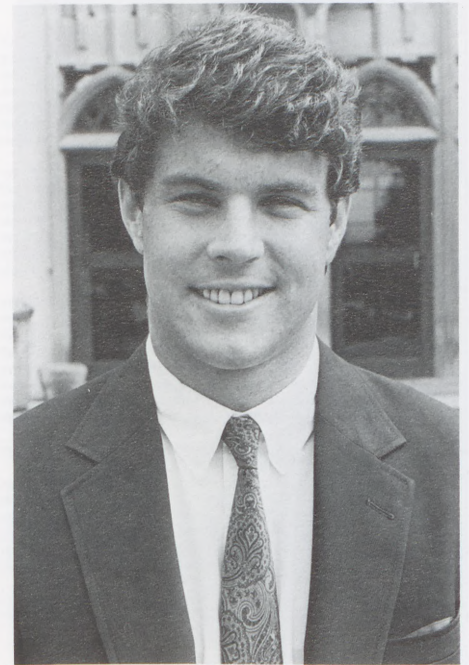
variety of career fields, graduate studies, and search techniques chosen by students who achieved their goals. Their stories also illustrate how having a PC education helped them win positions in their chosen fields, and include "words to the wise" for students who are beginning to plan for life after PC, or who should at least be thinking about it!

Cheryl Adams, an accounting major from Yorktown Heights, NY, began working in September 1988 as a staff accountant (assistant) in the Stamford, CT office of a Big 8 public accounting firm, Peat Marwick Main & Co. Her first interview with the company was obtained through the Job Search/Career Placement Center, where she had submitted her resume to be forwarded to a number of companies. "My contact with students from different backgrounds and different countries, coupled with my association with the Dominicans and knowledgeable professors, has given me the ability to get along with many different types of people and will be very helpful in my career," noted Miss Adams.

Karen M. Belton of New Haven, CT is now an accountant with Clairol, in Greenwich, CT, a subsidiary of Bristol-Meyer, where she is responsible for fixed asset ledgers and capital products. She was a business major at PC.

"I submitted a resume to Selected Executive Inc., a search firm located in Boston," said Miss Belton. "SEI did the initial groundwork. They set up two interviews for me, one with an insurance company in Hartford and the other with Clairol in Stamford, CT. The Placement Center at PC was extremely helpful from the initial draft of my first resume to researching companies and preparing for the interviews."

A Martin Luther King Scholarship recipient, Karen served as treasurer of the Afro-American Society and was a member of her class Ring Design Committee. Her advice to current students: "Employers like to see people get involved and have other interests outside the classroom. Work hard to get good grades, and get involved in activities," she stressed. "Don't be afraid of failure, because it is the only way to appreciate your successes."

Psychology major **Michael Burke** of Westport, CT has contracted with Junction Human Services Corporation of Providence to do health promotion and drug prevention services aimed at student-athletes at the college, university and high school levels.

As a separate venture, Burke has incorporated a publishing company, ATHWELL Corporation, which focuses on athlete wellness. "I am working with a mental health professional and an athletic trainer in putting together a student-athlete drug prevention workbook that ATHWELL will market to school athletic departments," he explained.

"Initially, I developed a health promotion/drug prevention program, and then put together an operating plan for expansion of Junction's prevention services in the student-athlete area," recounted Burke. "I showed the plan to John McGrath in the Job Search/Career Placement Office, who critiqued it and advised me on presentation strategy. Junction's management liked my proposal and hired me."

"I became interested in student-athlete health promotions and drug prevention when I interned at Junction, and during an independent study for a psychology class which involved carrying out and evaluating a self-esteem

improvement program as a drug treatment. My background in varsity athletics as captain of PC's men's varsity swim team during my senior year, and my efforts to overcome my own substance abuse problems which I experienced during part of my college career, also contributed to my interest in creating these programs," said Burke.

Patricia M. Brennan of Garden City, New Jersey, was one of the approximately 30 people hired nationally by Aetna Life and Casualty for its Personal Financial Security Division. "I have been accepted into the "Connecting with PFSD Program," she said, "which is an accelerated development track aimed at creating a pool of talented, well-rounded individuals capable of assuming a variety of challenging technical opportunities." During the 18-month program, Miss Brennan will receive training in claims, underwriting and marketing.

Miss Brennan, who began planning her job search two years ago through the Job Search/Career Placement Service, said her position with Aetna came about as the result of McGrath's advice that she attend a special Career Track '88 at New York City's Penta Hotel. "I took his advice and visited the Career Track on both days," she said. "As a result, I received 13 replies from companies that I was interested in! Take advantage of all the services the Job Search/Career Placement Service offers," counseled Miss Brennan. "I started in my junior year, but I wish I had started earlier. Students should visit the career fairs in upper Slavin as early as freshman year to help narrow down their interests," she said. "Seniors should take advantage of the interviewing process on campus, because each interview helps you to be better prepared for the next one."

As a staff consultant for Early, Cloud and Co., a telemarketing software development company in Newport, RI, **Donna A. Durante** of North Kingstown, RI will work in research and development, program in Cobol and Assembly language and act as a consultant/trainer for company clients. "I utilized the Placement Service by keeping updated on which companies were recruiting on campus and then participating in the on-campus interviews," she began. "I also utilized the SIGI (System

of Interactive Guidance and Information) computer to determine my strengths and weaknesses, and talked frequently with Mr. Kennedy, a job placement counselor, and Mr. McGrath. Information about the job I accepted actually came to me from one of my teachers, though, and I received more information from Mr. McGrath about the company before I had my first interview.

"It definitely helps to have contact with those faculty members who have some familiarity with the job market which you are entering," added Miss Durante. "It seems that those faculty members who have previously worked in business or in industry are more helpful, as they can share their own work experiences with you in addition to providing the academic angle. It also helps to talk to students who have recently graduated from PC in your major.

"Most of all," said the PC mathematics/computer science major, "DON'T PANIC! Beginning to explore your options early is a good idea, but don't worry if you don't know what you want to do. Work hard and keep your grades up, participate in an internship during your sophomore or junior year if possible, and try to eliminate the things you know you are not interested in," she advised. "Know your strengths and weaknesses because this helps you to put together a resume, and also gives

you some confidence when you are interviewing. If you are the type that worries a lot or stresses out, do as much as you can as early as you can. That way, your senior year will be less hectic and you can sit back and enjoy it."

Frank L. Finamore, Jr., a political science major from Woodbridge, VA, is working as a research associate with the management consulting firm of Booz-Allen and Hamilton, Inc. in Washington, D.C., and will provide support services to the Environmental Protection Agency.

"The Career Placement Service was instrumental in helping me identify where my interests and skills would be put to their best use," said Finamore. "After identifying several top management consulting firms, I sent each a resume and cover letter outlining my qualifications and skills that would enhance those firms," he said.

"Time and effective planning are the most important aspects in a career search," continued Finamore. "Identifying your interests and strengths early in your college career better allows one to direct his or her efforts to a specific goal. The limit to what one can achieve is only set by oneself," he declared. "Through study, hard work and determination, any goal is attainable."

Currently an assistant credit analyst in commercial lending in Fleet National Bank's Management Training Program

in Providence is **Mark Harriman**, a history-education major from Rockland, MA. Two years ago, he began his career search by studying the banking industry during part-time employment as a collections adjuster.

"I spoke with several key people in such areas as mortgage, commercial lending and bank operations," he explained. "After targeting a definite interest, I went to the Career Placement Service at the beginning of my senior year and reviewed my resume and interview skills with Paul Kennedy and John McGrath, who were extremely helpful with their advice and constant encouragement. I also interviewed with several different companies in various other industries, as well as banking, because I wanted to explore other available opportunities," he explained. "Fleet, however, offered me the opportunity I had been searching for."

"My activities in the Friar Council Knights of Columbus and my association with several Dominican priests on campus were two very important factors in establishing my career plans," Harriman explained. "In my freshman year, I assumed a position in the K of C in which I developed leadership and communication skills. I was also fortunate enough to establish lasting friendships with several Dominicans. They are very special people who have taught me, by word and example, how to live my life in the Catholic faith. I will always use them as role models, as I hope every student and graduate does."

Harriman's advice for underclassmen consists of one word: "patience." "I was lucky enough to be offered a job before I graduated, but it didn't come right away, nor did it come easily," he said. "Organize a solid search effort and be patient. Things will fall into place."

To freshmen and sophomores, he said, that experience helps. "Most students do not know what they want to do with their lives after they graduate," he said. "While you have a chance, try to secure summer or part-time work in your area of interest. There are several summers ahead before you graduate, and any business experience you get will benefit you in your job search," he continued. "Look at me. I once drove an ice cream truck."

Mark Christopher Hart of Lawrence, MA, an economics/finance major, has fulfilled his life-long dream of joining the Peace Corps.

"I have accepted a two-year assignment with the United States Peace Corps in Honduras as a small business advisor," he said. "My specific assignment will be determined after three months of training in Spanish and basic accounting methods."

"I always wanted to be in the Peace Corps, and was able to get an application at the Placement Center," added Hart. "Mr. McGrath gave me excellent advice and support for my final decision."

Hart said he is prepared for the demands of a Peace Corps assignment because "the education I got at PC allowed me to challenge myself with some very demanding courses. I participated in the Liberal Arts Honors Program, and the instructors in that program were fantastic, as were my fellow classmates," he explained. "Opting for a double major was possible due to the excellent guidance I got from department heads Sr. Mary Ellen Butcher, O.P. of the Finance Department and Dr. William Simeone of the Economics Department, and from Dr. Sickinger in the Dean's Office."

James C. Laing of East Providence, RI, a marketing major, has been hired by the U.S. Gypsum Company as an inside sales representative for the Maine, New Hampshire, and Northeastern Massachusetts territories. The company produces industrial and residential construction materials.

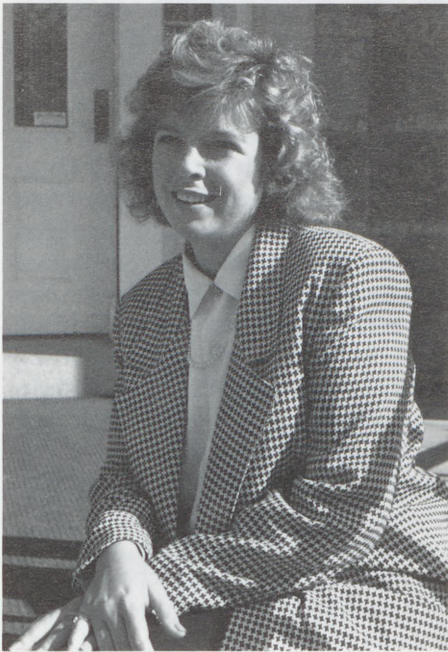
"Having determined that I was going to enter the world of business management," said Laing, "I researched the channels I would have to travel through and decided to begin my career in a Fortune 500 company. I focused my job search efforts in the area of industrial sales," he explained, "because this type of sales allowed for more extensive technical and "hands on" training experience."

"My first meeting with U.S. Gypsum," he continued, "was an on-campus interview not only with the regional manager of the Eastern Division of the company, but also with George Murphy, chief operating officer and vice president of USG Corporation, who is a Providence College alumnus."

"Providence College and its great family atmosphere has given me a leading edge in the real world not only educationally, but spiritually, socially, and emotionally as well," said Laing. "One of the biggest influences that will live in my heart forever were the lessons and many strange but extremely meaningful teachings of Fr. Walter Heath, O.P. Through Fr. Heath, I and many other classmates learned and gained much respect for Christian values." On this note, Laing also advised students to "be true to yourself and remember who you are, and keep a good set of values in both your personal and professional lives."

"PC's family atmosphere also provided me with a chance to get involved in many extracurricular activities, including serving as Last Resort manager on the Board of Programmers, as a member of the Friar's Club, and as chairman of the Meeting Street School Fund Raising Committee," he added. "This aspect of my college career provided me with excellent practice in management responsibilities. My interviewers even noted that my involvement in these extracurricular activities played a major role in their job selection process."

Jennifer Lennon, a business management major from Rockville, CT, was one of approximately 30 people hired throughout the country as a bond representative with Aetna Surety & Casualty. After getting a handle on her goals with the help of the Job Search/Career Placement Center, she found her position through the contacts she discov-

ered that she already had in various areas who helped her to "get her foot in the door" and show employers what she had to offer. As a bond representative, she will combine the personal and analytical skills which she developed through her liberal arts coursework and her involvement with extracurricular activities.

"I will have a two-sided job," said Miss Lennon. "As an underwriter, I will evaluate hazards Aetna might be asked to cover with a bond and negotiate terms and conditions. I will also be a marketing representative, promoting and expanding Aetna's bond business to help meet the company's objectives. I will counsel agents and their clients on financial and technical matters relating to bond qualifications, and will also deal with contractors, engineers, lawyers, bankers, brokers, political leaders, risk managers, public officials and top management in virtually every type of business."

During her PC career, Miss Lennon served as a student representative on the college's Budget, Athletics, Admissions, Health, and Financial Aid Committees, and was a four-year member of the Student Congress. "My extracurricular activities," she explained, "provided me with an opportunity to work with the college's president and vice presidents and to understand the goings-on in an institution of this size. This experience became a stepping-stone," she said, "into a career I feel will be very promising."

"To me, the academics, sports (I was a varsity soccer player), and leadership activities all meshed together in a very hectic schedule to make me a very well-rounded individual," she continued. "While at PC students should take advantage of such opportunities, and learn to converse on many levels with many types of individuals. In order to further your career, whether it be in education or in a job, you must be able to sell yourself to someone. It is imperative to be able to communicate both orally and in writing," stressed Miss Lennon.

Now an associate underwriter with Seaboard Surety of Bedminster, NJ, finance major **Mark D. Leskanic** of Bloomfield, NJ is in the midst of a one-year training program in all aspects of selling and underwriting surety bonds, a form of financial guarantees. Upon completing his training, he will transfer to a branch office in a major city.

"I interviewed with several potential employers through the Career Placement Service," said Leskanic. "Mr. McGrath helped me form an excellent resume, and with some practice, my interviewing technique enabled me to get several second interviews and eventual job offers. I weighed my choices and decided that Seaboard Surety was the one for me.

"The PC experience has made me a more well-rounded person," he continued. "The Dominicans showed me an

extra special guidance both in class and in outside activities, and set a positive tone for a successful future. Through social events and the many friendships I have formed over the years, I have achieved an understanding of how other people live, and have developed a confidence in myself that will help me in any career I pursue.

"The top advice that I would give to PC students is twofold," said Leskanic. "First, find worthwhile employment in 'career-related' jobs as early as possible. If one can get a meaningful job in the summer between the freshman and sophomore years, it will be easier to get an even better job the following summer. Secondly," he continued, "students should utilize all career opportunities which come along at PC. These include career counseling at the Student Development Center, internships provided by local businesses, and of course the opportunities afforded by alumni who are employers."

Susan Mebus of Huntington, NY, a math-computer science major, is now a management consultant with Coopers and Lybrand in New York, where she implements management information systems for a variety of clients after researching their needs. The Placement Service was very helpful, according to Miss Mebus, in preparing her for interviews, researching companies and writing thank-you notes. "Providence College has also prepared me for the working world by providing me with a well-rounded academic environment and diverse extracurricular activities," she said. "My involvement in intramural and varsity sports was a large part of my PC life and by being involved, I learned to work in teams, which is now an important aspect of my job."

Joan Marie McFadden, formerly of River Edge, NJ and now living in Providence, began employment as a business analyst with Dun & Bradstreet in East Providence in June. She majored in economics.

"I compiled my resume in October '87 with the help of Mr. McGrath and Mr. Kennedy," said Miss McFadden. "I then participated in the on-campus recruiting program and was selected for approximately eleven interviews, one of them being Dun & Bradstreet. I was called back to Dun & Bradstreet for two more interviews. Prior to these additional interviews," she said, "I utilized the Job Search/Career Placement Ser-

vice even further by consulting with Mr. McGrath in more detail about second and third interviews. He also referred me to Ed Smith '83, who is district manager of Dun & Bradstreet in New Hampshire. I called Ed, and he gave me some very useful advice about the position.

"I would suggest that before anyone makes an important career choice decision, they should take a good look at themselves and find out who they really are inside," added Miss McFadden. "Whatever their ambition is, they should be confident enough to pursue it. Use the Career Placement Service—it was an incredible asset for me in finding my job because Mr. McGrath was so enthusiastic and knowledgeable about various career paths," she counseled. "It was also a nice feeling to know that a fellow PC alumnus was so willing to help me."

Currently the advertising account manager for EMC Corporation's IBM Mainframe product line, **Ruth Ann Reale**, a marketing major from Norton, MA, creates ads and direct mail campaigns, and handles sales collateral and all aspects of public relations.

"I received this job offer after working part-time in EMC's Advertising Department," explained Miss Reale. "The long hours I put in as an intern were demanding but very educational, and helped me get my foot in the door. For students interested in the advertising field, I suggest finding an internship, especially one in a firm with an in-house ad agency. Practical work experience, combined with good grades and extra-curricular activities," she explained, "will help pave the way for finding a full-time job in the field."

"Don't let opportunities which will enhance or display your talents pass you by," stressed Miss Reale. "To get a job in the competitive world of advertising you must show potential employers that you are a 'go-getter.' Any clubs, activities, or part-time work that will emphasize your uniqueness and ability to work hard will be beneficial to you in finding a career in advertising," she said. "Studying in London during my junior year, and working as a waitress, helped prepare me for the real world," continued Miss Reale. "Also, being president of the Ski Club helped me develop organizational and leadership skills."

Robert A. Salvatelli, Jr. of Leominster, MA, a business management major, recently began working for Abitibi-Price, a Canadian firm which exports construction products to the United States. He will manage the company's Hartford, CT territory.

"The PC Job Search/Career Placement Service was my main source for locating a job," said Salvatelli. "I had approximately 15 interviews during the second semester. Mr. Kennedy, who was my main advisor, helped me polish up my resume and advised me throughout the interview process. Mrs. Ricci, the office's secretary, was also very helpful."

"PC has provided me with the maturity necessary to aggressively approach major corporations with the confidence needed to excel in an interview situation," he declared. "Strong friendships, excellent relationships with both the Dominicans and the lay faculty and the responsibility that was bestowed upon me has aided me greatly and is something I will cherish for many years."

His advice to current students: "Find a major as quickly as possible and focus your course of studies around it," he suggested. "Make the most out of your four years at PC in more than just academics. Get involved in either Student Congress, any of the clubs, athletics, and the social scene," said Salvatelli. "It shows recruiters that you are motivated."

Lisa Marie Spooner of Newport, RI is working for TJX Corporation-The Newton Buying Company Division in Worcester, MA, as a merchandise analyst. She interviewed with the company on-campus through the Job Search/Career Placement Service. "I really got so much out of PC!" she exclaimed. "The college really helped to prepare me for my future. I was an English major and took only two business courses, but my liberal arts education really put me ahead of a lot of business students from other colleges when I was interviewing for jobs in retail." Her advice to job seekers: "Give yourself some direction, but don't limit yourself to defined and unbending decisions," she said. "At first, I wanted to go to law school! That's still a possibility, but you have to look at all the options."

Mary Lou Walsh of Hingham, MA, a double major in math/computer science and humanities, is an applications programmer at IBM in Tarrytown, NY. Her on-campus interview with IBM was convenient and comfortable because it was in familiar surroundings, she said. Prior to the interview, she researched the company extensively through materials available in the Career Placement Service. Her advice to other PC students: "Get to know the Job Search/Career Placement Office early because if you do not, senior year will sneak up on you fast and many of you will be 'living' in there all year!"

Lynn Rose Toomey, a humanities major from East Providence, RI, is assistant marketing manager of Swansea Mall in Swansea, MA, for Equity Properties and Development Company of Swansea. Currently in a one-year training program, she is learning about advertising, marketing, design and public relations in relation to the shopping center industry.

"The Job Search/Career Placement Service played a major role in my job search," said Miss Toomey. "It was through that office that I was made aware of the marketing opportunity with Equity. The staff really cares about the students and follows up on positions they feel would be good career opportunities. I recommend to underclassmen that they begin their career search here early," she continued. "Through use of the SIGI machine and other reference materials, one can gather quite a bit of information."

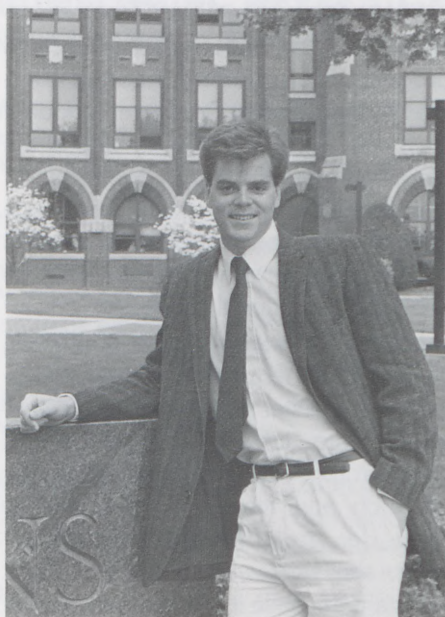
"Also, as a humanities major, I was able to combine 21 business credits with 21 English credits," said Miss Toomey. "These classes gave me a good handle on the marketing industry. To supplement my classwork, I had two communications-related internships which gave me great hands-on experience. I also learned to plan, organize and accomplish tasks through my membership in the Friar's Club and Board of Programmers.

"Lastly," added Miss Toomey, "one of the most important things that I have gotten out of my PC experience is the importance of commitment and dedication. It was through my observance of and contact with a number of Dominicans that I have come to a greater awareness of what it means to be truly dedicated to something."

Thomas K. O'Grady, a humanities major from Petersham, MA, spent "a great summer relaxing and working as a lifeguard" because before graduation, he had secured a position with Chase Manhattan Bank with a starting date in late August. (O'Grady was one of *eight* PC seniors hired by Chase in 1988 for its Individual Bank Management Development Program. Of the 34 undergraduate schools at which the bank recruited, PC and Dartmouth tied for the highest number of students hired.) O'Grady is currently in a year-long training program through Chase's Individual Banking branch in the Metropolitan New York area and will assume a first line management position with the company in either marketing or operations, whichever area he performs best in, upon completion of the program. "I was happy to have been selected by this very prestigious company," said O'Grady, "and was also able to enjoy my summer without pulling my hair out over landing a job!"

"In fact, many people have told me that one of the most stressful experiences they have had is the process of finding a job," said O'Grady. "I can honestly say that my experience was more of an adventure than anything else. I utilized the career services that PC offers to the utmost and had very little trouble.

"I began by putting together my resume on a computer disk at the school's computer lab," he explained. "This allowed me to modify or amend it

without having to have a professional company reprint it every time. I sought advice from Mr. Kennedy in the Placement Center, and submitted resumes for all of the positions in which I was interested. I then participated in several first interviews, a few second interviews, and finally received word that I would be hired by Chase Manhattan. Before my last interview with Chase in New York, I sought advice from Mr. McGrath, who told me exactly what to expect and gave me tremendous confidence for the interview," said O'Grady.

As a humanities major, O'Grady had felt at first that he would not have what employers were looking for. "But I found that what is of greater importance is not what your major is, but how you spend your time at college," he explained. "My time at PC has more than anything made me a well rounded person. I can say that I am truly the product of a 'liberal arts experience'.

"I participated in two internships while at PC and believe these were a great asset," he continued. "Also, my participation in extracurricular activities as a member of the Student Congress, as a lobbyist for the Student Congress at the Rhode Island State House, and my participation in Big Brothers and Sisters and intramural sports were important. I sensed that employers like a person who can balance an academic life with other responsibilities," he added. "Many students don't bother putting together a resume or starting

their job search until the summer after the senior year is over," noted O'Grady. "It's unfortunate because the school brings in some of the nation's top companies for interviews and these students miss out. Also, students should seek out advice on the best ways to formulate a resume, or techniques on how to handle these interviews better. But most importantly," counseled O'Grady to current undergrads, "use your years at PC wisely. Your time at PC doesn't last forever, so think ahead!"

Those who chose grad school . . .

Elizabeth A. Arendt of North Scituate, RI, a chemistry major, is pursuing her Ph.D. in chemistry at Brown University Graduate School, where she received a teaching assistantship and waiver of tuition. She credits her "excellent academic background" and friendships with faculty and students as helping greatly in her career objectives.

Susan Ann Cardoza of Raynham, MA, an English major, is in her first year at Harvard Law School. (She was also accepted by Boston College, Boston University, and Yale University law schools). "The most important factor in my PC experience was the quality education and the faculty support I received for my ambitions," she said. "Also, PC's small size allows a rapport to develop between students and professors, which is very important."

Christopher John Thimes of Foxboro, MA, a double major in biology and chemistry, is attending the University of Maryland at Baltimore Medical School. "Start early and get as much help and advice as possible," advised Thimes, whose goal is to be a pediatrician or family practitioner. "Be open to alternatives other than medicine while remaining committed to medical school. However, if the idea of staying in on an occasional Friday or Saturday night is overly depressing, then a science major, not to mention medical school, should be seriously reconsidered."

Tara Callahan of Newburyport, MA, a psychology major, is pursuing her master's degree in social work at Simmons College. "I sensed that much of the peace of mind and happiness of the PC Dominicans and faculty came from helping students both in and outside the classroom," she explained. "The experience of getting outside of yourself to help another person appeared rewarding, so I chose a profession in which I could act in a similar way." She advises social work majors to keep their options open and take a variety of classes, and to pursue work experience or internships. "Applying what I learned in the classroom as an intern in a professional setting was critical in my decision to continue my education in social work," she said.

Eileen Corr of Fairfield, CT, a humanities major, has begun a two-year MBA program in international business management at Bentley Graduate School of Business. "I spent my junior year at the Universite de Fribourg, Switzerland," she said. "As a result of that experience abroad, I decided to further my interest in international affairs by pursuing an MBA in international business."

Jill A. Jackson of North Smithfield, RI, a humanities major, is working toward her master's degree in art history at the State University of New York at Binghamton, and hopes to ultimately research and teach at the university level. Her most beneficial PC experience, she said, was being a resident assistant because it allowed her to grow and build character, although it was "a thankless job." She also lauded art history associate professor Dr. Alice H. R. H. Beckwith for her assistance in searching for the right school. Miss Jackson's advice: "Juniors should take practice tests for GRES; try them twice if you have to. Do not delay taking the real exams because the scores serve as a cutoff point for many graduate schools."

Melissa Matteo of Middletown, CT, an economics and humanities major, is continuing her job search in the Hartford, CT area while pursuing an MBA at

the University of Connecticut. "Think ahead," she advised students. "Do not put off important things like putting together a resume. Also, apply to graduate schools as early as possible to give yourself a greater chance of being admitted to the school of your choice."

Renee Jean Wocl of Moodus, CT, a health services administration major, is pursuing graduate studies in health care law at the Catholic University of America in Washington, DC. "Start early!" she warned. "Time goes by too fast and if you are unorganized you might miss important deadlines. Utilize the Career Counseling Center. Mrs. Clarkin, Mrs. Gregory and the career assistants have a lot of good ideas and resources that can help make your job search a lot easier," she continued. "Also, juniors interested in law school should talk to Mr. McGrath about preparing for the LSAT's. He knows what he's talking about!"

In addition to offering job search and career placement services, the Student Development Center, under the direction of Jacqueline Kiernan MacKay, also offers career planning and personal counseling services.

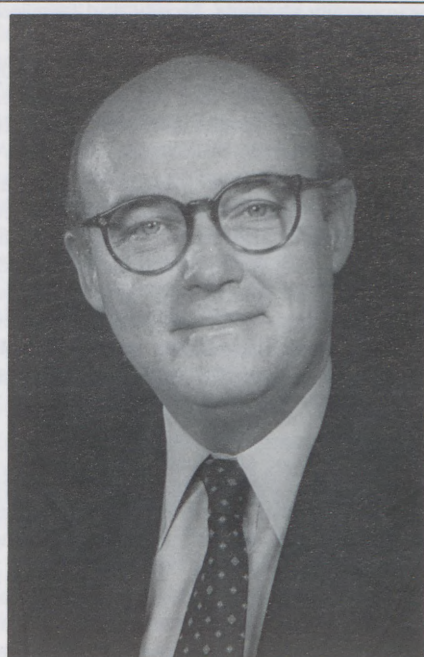

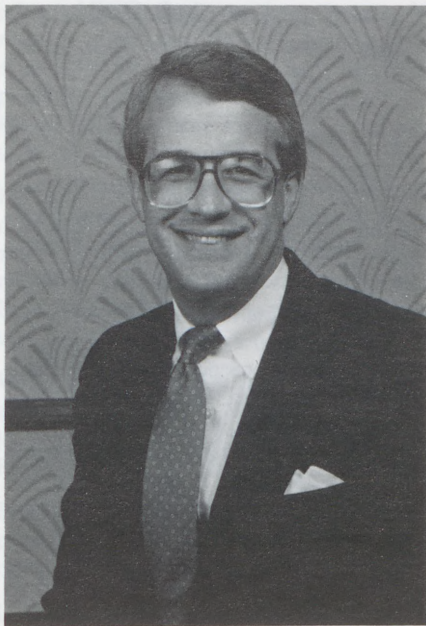

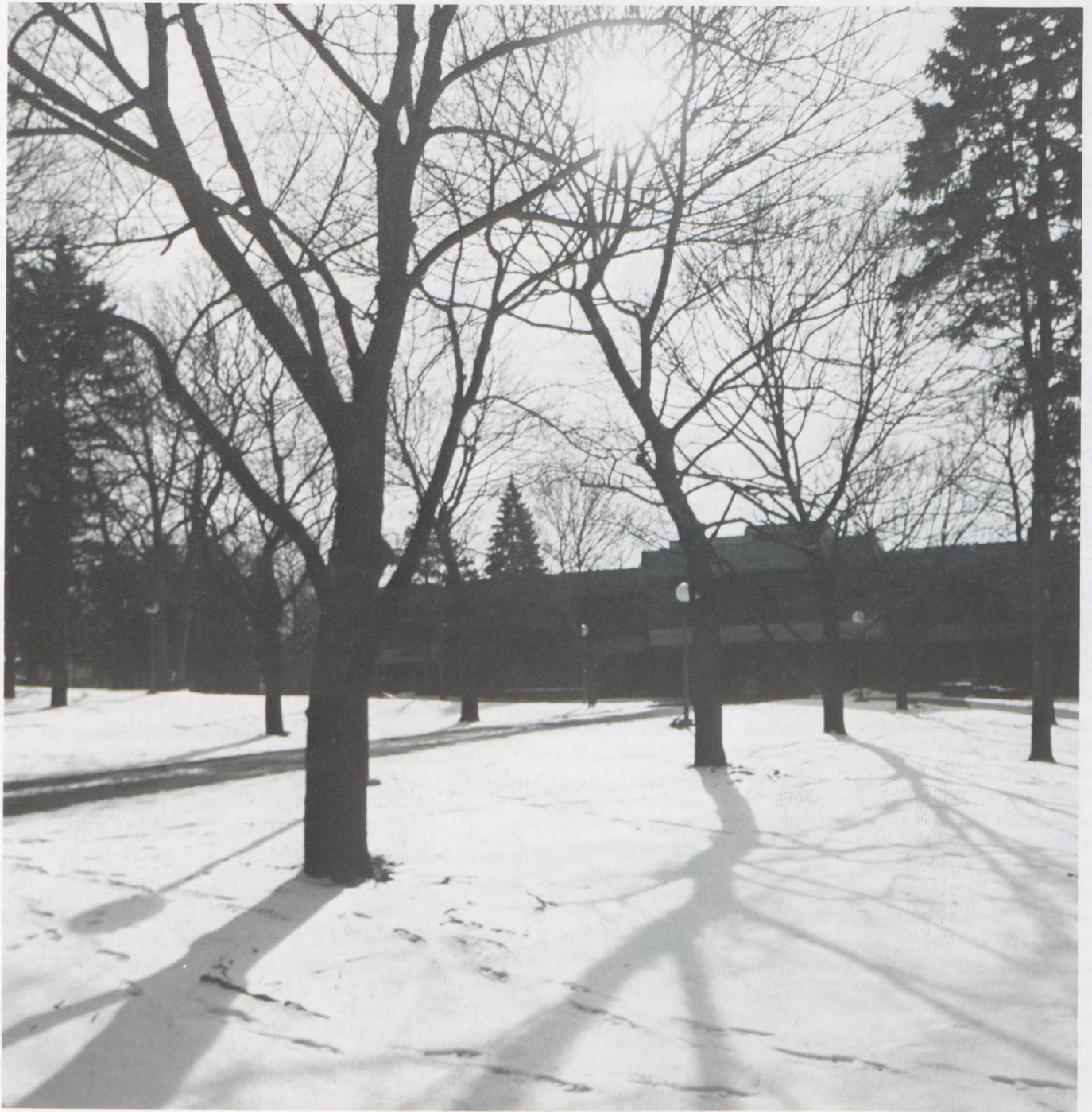
